## Michelle:

Unlike some within the community \* – we (VolusiaExposed.Com) have opted NOT to engage in *ex parte* communication with local judges. However, we find it both appropriate - and necessary - to express our (VolusiaExposed.Com) concerns that Judge Tesha Ballou has an apparent conflict of interest - being the assigned judge in Francis' pending September 7, 2022 hearing.

\* rumor has it - that Sheriff Ivey has been known to have such *ex parte* communications with judges – regarding on-going litigation attached to the Brevard County Sheriff's Office.

Therefore – we shall expect your office (PIO) to address our conflict of interest concerns.

In January 2016 - the Brevard County Sheriff's Office (BCSO) arrested twenty-two year old Skyler Francis for the alleged murder of two BCSO deputies.

According to the arrest report (see below linked copy) – Francis had "murdered" two sheriff deputies – when in reality - Francis and the deputies had engaged in a short physical confrontation - after the deputies had broken into the curtilage of the Francis family home. http://volusiaexposed.com/brevard/bcso/2022/inthedefenseofskylerfrancis8302022/arrestreport.pdf

Obviously – the criminal charges against Francis were quickly reduced to battery on law enforcement officers.

During Francis' trial – Judge Robin Lemonidis engaged in several acts of judicial misconduct that in the OPINION of many – biased the jury against Francis.

In February 2020 - the Florida Supreme Court took disciplinary action against Judge Lemonidis - partially for her judicial misconduct within the Francis trial (see our below linked December 23, 2020 article for particulars)

In June 2019 – Attorney Tesha Ballou was appointed to the judicial bench by Florida Governor Ron DeSantis. During the appointment process – Ballou submitted a judicial application – that now provides evidence that calls into question her judicial ability to provide Francis with an unbiased review of his post conviction motion.

According to her judicial application (question 7 – page 1) Judge Ballou is married to retired law enforcement professional Matthew "Scott" Ballou. Mr. Ballou retired from the Seminole County Sheriff's Office after thirty-two (32) years of law enforcement service.

Further – according to her judicial application (question 21 – pages 5-6) – Judge Ballou served as the "General Counsel" to the Seminole County Sheriff Department from 2001-2006.

Brevard and Seminole counties comprise the Eighteenth Judicial Circuit.

According to available records - Mr. "Scott" Ballou is still active within the law enforcement educational community. He also is noted for his July 27, 2017 Op-Ed within the <u>Orlando Sentinel</u> - in which he opines about police officers making "reasonable suspicion - stop and frisk" searches of citizens. Mr. Ballou questions why some citizens are so eager to make examples of officers who make mistakes?
