On the above date and time, I physically observed the defendant and [REDACTED] (passenger) operating a white in color, Hyundai sedan bearing Florida tag "HWDH06" south bound on Croton Road. I attempted a traffic stop on the vehicle in the area of Croton Road and West Eau Gallie Boulevard based on the fact I had knowledge the defendants driver's license was currently suspended.

The defendant refused to stop the vehicle and continued west bound on Eau Gallie Boulevard at the posted speed limit, while I followed behind him with my blue lights and siren. As the defendant traveled west bound, he proceeded to stick his head out of the driver window, while yelling "Fuck you" at my vehicle, which showed he acknowledged law enforcement was behind him.

The defendant then made a right turn onto Arnold Drive, then right turn onto Eva Lane. The defendant continued east on Eva Lane until he reached Shelby Drive. At the intersection of Eva Lane and Shelby Lane, the defendant began reaching under the front seat, which I relayed to Agent Magill who was following in his agency issued vehicle with his lights and siren going. Prior to departing the intersection, the defendant leaned out the driver's window, giving Agent Magill and I the middle finger, at which time he made a right hand turn towards Croton Road. It should be noted, multiple times as the defendant fled he would stick his middle finger out of the window while yelling obscenities toward my vehicle. The defendant traveled north on Croton Road and proceeded to make a right turn onto Lime Drive until he reached his residence, at which time [REDACTED] exited the vehicle and ran toward the house.

As the defendant parked his vehicle, he exited the car and proceeded to aggressively approach me with his fists clenched while yelling obscenities. The defendant was ordered multiple times to sit back in his vehicle, to which he refused to comply.

The defendant then assumed a fighting stance with his fists still clenched and proceeded to aggressively approach Agent Magill and myself. At this time, a brief physical altercation occurred. During the struggle and while attempting to detain the defendant, he intentionally bit the outside of my hand. In addition, the defendant dug his nails into Agent Magill's forearms causing small lacerations to both of his forearms. After refusing to comply with all verbal commands, the defendant was successfully detained.

During a search of the defendants person, (2) fully loaded Ruger .380 magazines were located within his jeans pocket. In addition, (1) fully loaded (one in the chamber) .380 firearm was located on the floorboard of the driver seat where he was observed reaching. It should be noted, the defendant was confirmed via Teletype as a convicted felon (Career Criminal). Furthermore, I verified via DAVID that the defendant's license was actively suspended as of 07/07/2022.
