On the above time and date I initiated a traffic stop at the intersection of Croton Road and Aurora Road, Melbourne, Brevard County, Florida, on a black Cadillac SUV for an inoperative headlight pulling a small cargo trailer.

Contact was made with the driver Joshua Morris, front seat passenger Richard Ennis, and rear seat passenger Daphne Morris. Joshua Morris was unable to produce his drivers license upon request and provided me his name and DOB. I attempted to identify Richard Ennis and Daphne Morris but they refused to identify themselves at that time. At this time I smelled the strong odor of burnt marijuana inside of the vehicle. As I attempted to identify the passengers inside of the vehicle they started to argue and become verbally aggressive. At this time I asked all of the vehicle occupants to step out of the vehicle for officer safety. All of the vehicle occupants refused multiple verbal commands to step out of the vehicle. I warned Mr. Joshua Morris that he would be placed under arrest if he refused to step out of the vehicle. Joshua Morris again refused to step out of the vehicle and I told him he was under arrest. I opened the drivers door of the vehicle and grabbed Joshua Morris left wrist, told him he was under arrest, and to step out of the vehicle. Joshua Morris pulled away from my grip and braced himself inside of the vehicle. As Agent Magill and myself attempted to pull Joshua Morris out of the vehicle he pulled away, braced himself in the vehicle, and struck myself and Agent Magill with his hand and arms as he attempted to take him into custody. Joshua Morris was tased and escorted out of the vehicle onto the ground. The passenger Richard Ennis then fled from the vehicle on foot westbound on Leewood Blvd. Myself and Agent Magill pursued on foot and was able to apprehend Richard Ennis in the back yard of a residence. As Richard Ennis ran multiple verbal commands were given for him to stop but he refused. I observed Richard Ennis reach into his pocket as he was running and throw a metal tin can that contained FTP 0.2 grams fentanyl, 1 Alprazolam pill, and FTP snorting straws with fentanyl residue. It was later found that Mr. Richard Ennis had an active out of state felony warrant for his arrest.
