The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 18th day of October, 2023, at approximately 12:13 hours at 1467 LAVENDER ST, violated the law and did then and there:



Narrative Title: Narrative

3. On Wednesday, October 18, 2023, at approximately 1213 hours, Deputy Westfall (9306) responded to
4. 1467 Lavender St, Deltona in reference to a suicidal person. As Deputies were responding, they were
5. informed by Terry Neubauer (R1), she was with Theresa Blandford- Webb (W1) after Michael and Theresa
6. had gotten into a verbal argument. Theresa and Terry were together when they had received a phone call
7. from Michael Webb (D1) advising "it's over at 1230 and this is the coward way out". Theresa also informed
8. Deputies who were responding that Michael owned multiple weapons to include pistols, rifles, and shotguns.
9. Terry informed law enforcement that Michael had consumed prescription pain medications and alcoholic
10. beverages.

12. Upon arrival, Deputy Westfall approached the residence with other units and got Donna Hill (W2),
13. to leave her trailer located in the backyard of the residence. Deputies took Donna away from the residence
14. and began to gather information about Michael and his situation. Donna informed Deputies Michael possesses
15. multiple firearms in the residence and was previously in the military.

17. Deputies began to set a perimeter around Michael's residence and made numerous attempts to make
18. contact by a cellphone which resulted with no response. Travis Linthicum (O2) was outside with deputies
19. and contacted Michael on his phone. While speaking with Travis, Michael made several comments about
20. not coming out, and "they" will have to come and get him before disconnecting. Deputies then began
21. attempting to contact Michael by utilizing the PA system of a marked Volusia Sheriff patrol vehicle,
22. when a single shot was heard coming from the garage of the residence. The shot traveled through the
23. thin aluminum garage door, in the direction of the deputies outside. Deputy Westfall and Deputy Santiago
24. were behind an extended portion of the residence at 1461 Lavender St, Deltona which provided them with
25. cover when the shot occurred. Deputies immediately began to check themselves for any injuries. All
26. deputies on the perimeter retreated to gather better cover due to Michael shooting from within the
27. residence's garage.
28.
29. Sergeant Woell requested a reverse 911 be sent to the surrounding area to advise residents to stay
30. inside.
31.
32. Deputies continued to make announcements utilizing the public address (PA) system of a marked Volusia
33. Sheriff's Office patrol vehicle, identifying themselves, requesting Michael to exit the residence for
34. his safety, while attempting to contact Michael by his cell phone, which had negative results. After
35. a period of time, Michael answered his phone and began to make statements advising if law enforcement
36. were to approach the house and get near him, he would "blow his brains out".
37.
38. Shortly after, Michael opened the garage door, and while standing inside began to make threats of
39. killing himself, and threatened law enforcement that if they approached he would kill them. Michael
40. continued making threats and vulgare statements, stating "fuck you" and "lets see what you got". Michael
41. also made several statements of "Come get me! I want suicide by cop!" before closing the garage door.
42. Deputies continued the PA announcements due to not having any visual on Michael at this point.
43.
44. At approximately 1308 hours, another shot from within the garage portion of the residence was heard.
45. Deputies across the street from the residence confirmed there to be two bullet holes in the upper portion
46. of the thin aluminum garage door, confirming the second shot also came in the direction of deputies
47. and neighbors. The shots exited from the front of the garage and traveled over the road towards the
48. direction of an occupied residence and in the direction of law enforcement who were posted across the
49. street. Deputies continued to make attempts to contact Michael by telephone and make PA announcements
50. to have Michael exit the residence.
51.
52. After the second shot, Michael opened the garage door and continued to shout at Deputies that he
53. wanted suicide by law enforcement. Michael continued to stay inside of the garage, refusing to exit
54. and make contact with law enforcement. As Deputies were outside of the residence, Michael closed the
55. garage door and was on the phone with Richard Edge (W3) and Travis Linthicum (W4). Michael informed
56. Richard and Travis that if law enforcement approached the residence, it would be "hell" for anyone
57. who approaches the residence.
58.
59. Deputies continued PA announcements and communications on the cell phone with Michael.
60.
61. Sheriff Chitwood responded to the residence and continued communications with Michael via the telephone.
62. Michael informed Sheriff Chitwood that he would exit the residence and contact him, Richard and Travis.
63. Michael then exited the residence and approached Sheriff Chitwood, Richard, and Travis with nothing
64. in his hands. Michael was escorted to a patrol vehicle and was placed in hand cuffs.
65.
66. Deputies entered the residence to confirm there was no one injured inside and Michael was the only
67. occupant. Deputy Westfall observed two bullet holes in the top of the garage door and multiple firearms
68. throughout the residence. Deputy Westfall observed a shotgun and revolver in the garage next to where
69. Michael was observed sitting. Deputies maintained containment of the residence until a warrant was
70. filed and conducted.
71.
72. The Chain of Command, CID, Crime Scene, and SWAT were notified of the active incident and responded.
73. CID and Crime Scene responded to the residence for further investigation.
74.
75. At the conclusion of the incident observed by Deputy Westfall, Michael was placed under arrest for
76. two counts of aggravated assault on law enforcement and two counts of discharging a firearm in a residence.
77.
78. Deputies canvassed the surround residences and were not able to locate any damage caused by the
79. discharge of the firearms.

81. Deputy Westfall requested a Criminal History for Michael, which returned with no prior felony convictions.

83. Michael was transported to the Volusia County Branch Jail with a notification of suicide watch.
