 The State has yet to file on the cyberstalking charge that the Defendant was arrested on simultaneously. 4. Defense Counsel believes that the State intends to offer evidence of a timeline created for Agent Fischer by the alleged victim (See Exhibit A)

 Any information contained in the alleged victim timeline was made specifically for Agent Fischer and not at the time it actually occurred and as such should be considered hearsay and excluded.

6. To bring in any evidence regarding the timeline of would not only be hearsay but would be improper and highly prejudicial pursuant to Sections 90.801, 90.403 and 90.404 of the Florida Evidence Code.

WHEREFORE, based on the above and foregoing, the Defendant DANA LYNN LOYD, requests this Honorable Court to enter an Order prohibiting the State of Florida from bringing in any and all evidence of a timeline produced to the Brevard County Sheriff's Office by the alleged victim and or otherwise referring to in any way these alleged facts in trial of this cause.
