Investigative Overview

This investigative summary details the events of the in-custody death of Inmate Gregory Lloyd Edwards.

On Sunday, December 9, 2018, at Walmart located at 845 Palm Bay Road, Palm Bay, Brevard County, Florida, a business video recording captured Mrs. Kathleen Edwards (with child) and Mr. Gregory Lloyd Edwards at approximately 1111 hours. The two adults were walking from the parking lot toward the Walmart business entrance. Mrs. Edwards was pushing a shopping cart with their daughter within. As they approached the front entrance, Mrs. Edwards and daughter enter the business. The recording reflects that Mr. Edwards did not enter the business and walked to the right of the door entering the back of a white utility truck at 1111 hours, which was parked by the entrance. At approximately 1112 hours, Mr. ██████████ walked out of Walmart toward the rear of the truck. ██████████ is then observed walking out from behind the truck. Mr. Edwards is observed coming from behind the truck and then attacks ██████████ from behind at approximately 1113 hours. Mr. LaBrandon Koonce is then observed coming from behind the truck to assist ██████████ by pulling Mr. Edwards from ██████████ and then tackling Mr. Edwards to the ground. Mr. Koonce then remains on top of Mr. Edwards, restraining him on the ground until West Melbourne Police Officer Jacob Mathis arrives on scene at approximately 1119 hours.

At approximately 1119 hours, while on routine patrol at Walmart, West Melbourne Police Department (WMPD) Officer Jacob Mathis was advised of a possible fight occurring at the Walmart entrance by a walk up concerned citizen. Officer Mathis responded to the suspicious incident, arriving at approximately 1122 hours. Officer Mathis locates the disturbance and exchanges positions with Mr. Koonce on top of Mr. Edwards who is aggressively resisting. Officer Jacobs, with the assistance of Sergeant Michael Perez (arrival approximately 1127 hours) and Officer Kevin Krukoski (arrival approximately 1127 hours), physically restrain Edwards and then place Mr. Edwards into the rear of a West Melbourne Police Department marked patrol unit at approximately 1131 hours. At the conclusion of the on-scene investigation, Mr. Gregory Lloyd Edwards was arrested for Resisting Arrest with Violence, Battery and Violation of Felony Probation.

No camera recordings captured the interaction between WMPD Officer Mathis and the walk-up concerned citizen.

BCFR Station 83 arrived at Walmart at approximately 1128 hours. BCFR personnel (Iriban, Weiss and Clarisse) examined and cleared victim [REDACTED] who refused transport to a local hospital. WMPD body camera recording captured BCFR Station 83 personnel at the side of the WMPD marked patrol unit with Inmate Edwards secured and seated in the rear, door open.

At approximately 1237 hours, WMPD Officer Kevin Krukoski transported Inmate Edwards to the Brevard County Jail Complex (BCJC) for further processing under a no bond status and an accompanying Baker Act Form.

While enroute, Officer Krukoski requested assistance from Brevard County Jail Complex (BCJC) personnel upon his arrival, advising Inmate Edwards had become "agitated again and began kicking, stomping and screaming in the back seat." Officer Krukoski arrived at the BCJC at approximately 1309 hours, at which time Inmate Edwards was transferred to the custody of Brevard County Sheriff's Office Corrections Deputies who were awaiting his arrival based upon the previous request/notification of Officer Krukoski (Sergeant Perez).

At approximately 1351 hours, Corrections Deputy [REDACTED] attempted to perform the Jail booking process with Inmate Edwards. As Inmate Edwards was being escorted to begin the process, Inmate Edwards became uncooperative. The video recording depicts at approximately 1352 hours, [REDACTED] attempting to direct Inmate Edwards to a processing location. Inmate Edwards and [REDACTED] both began falling to the ground. While falling, Inmate Edwards punched [REDACTED] with his left fist, which appeared to have struck [REDACTED] in the head. Both fall to the ground with [REDACTED] on the bottom. At this time, the back of [REDACTED] head strikes the concrete floor. While on the ground Inmate Edwards positioned himself on top of [REDACTED] where he grabbed [REDACTED] shirt and duty belt with his right hand, pulling him closer. Corrections Sergeant Richard Zimmerman and Corrections Deputy Robert Wagner Jr. then run to [REDACTED] aid and attempt to free [REDACTED] from Inmate Edwards' hold. Inmate Edwards then used his left elbow and forearm area to strike [REDACTED] at least three times to [REDACTED] head. Inmate Edwards then used his left arm to push [REDACTED] head and neck to the ground while grabbing his shirt. Sergeant Zimmerman used both hands to pry Edwards left arm from [REDACTED] neck and head area, ultimately freeing [REDACTED] from the hold. Once Inmate Edwards' left arm grip was removed, [REDACTED] was able to maneuver his head away from Inmate Edwards. As the struggle continued, Corrections Deputies then assisted by attempting to neutralize Edwards' aggressive resistance, utilizing response to resistance techniques and agency issued less lethal force (CEW & OC Spray). Corrections Deputies were eventually able to secure Inmate Edwards in handcuffs and place him into an Emergency Restraint Chair (ERC) at approximately 1357 hours.

While in the ERC, Edwards was observed having what is described as a medical event. BCSC correctional personnel then attend to Inmate Edwards at approximately 1423 hours. Inmate Edwards was transferred to the Jail's Medical Ward at approximately 1435 hours, and an emergency 9-1-1 activation was initiated at 1438 hours. BCJC

BCFR Station 83 arrived at Walmart at approximately 1128 hours. BCFR personnel (Iriban, Weiss and Clarisse) examined and cleared victim Mich who refused transport to a local hospital. WMPD body camera recording captured BCFR Station 83 personnel at the side of the WMPD marked patrol unit with Inmate Edwards secured and seated in the rear, door open.

At approximately 1237 hours, WMPD Officer Kevin Krukoski transported Inmate Edwards to the Brevard County Jail Complex (BCJC) for further processing under a no bond status and an accompanying Baker Act Form.

While enroute, Officer Krukoski requested assistance from Brevard County Jail Complex (BCJC) personnel upon his arrival, advising Inmate Edwards had become "agitated again and began kicking, stomping and screaming in the back seat." Officer Krukoski arrived at the BCJC at approximately 1309 hours, at which time Inmate Edwards was transferred to the custody of Brevard County Sheriff's Office Corrections Deputies who were awaiting his arrival based upon the previous request/notification of Officer Krukoski (Sergeant Perez).

At approximately 1351 hours, Corrections Deputy ██████ attempted to perform the Jail booking process with Inmate Edwards. As Inmate Edwards was being escorted to begin the process, Inmate Edwards became uncooperative. The video recording depicts at approximately 1352 hours, ██████ attempting to direct Inmate Edwards to a processing location. Inmate Edwards and ██████ both began falling to the ground. While falling, Inmate Edwards punched ██████ with his left fist, which appeared to have struck ██████ in the head. Both fall to the ground with ██████ on the bottom. At this time, the back of ██████ head strikes the concrete floor. While on the ground Inmate Edwards positioned himself on top of ██████ where he grabbed ██████ shirt and duty belt with his right hand, pulling him closer. Corrections Sergeant Richard Zimmerman and Corrections Deputy Robert Wagner Jr. then run to ██████ aid and attempt to free ██████ from Inmate Edwards' hold. Inmate Edwards then used his left elbow and forearm area to strike ██████ at least three times to ██████ head. Inmate Edwards then used his left arm to push ██████ head and neck to the ground while grabbing his shirt. Sergeant Zimmerman used both hands to pry Edwards left arm from ██████ neck and head area, ultimately freeing ██████ from the hold. Once Inmate Edwards' left arm grip was removed, ██████ was able to maneuver his head away from Inmate Edwards. As the struggle continued, Corrections Deputies then assisted by attempting to neutralize Edwards' aggressive resistance, utilizing response to resistance techniques and agency issued less lethal force (CEW & OC Spray). Corrections Deputies were eventually able to secure Inmate Edwards in handcuffs and place him into an Emergency Restraint Chair (ERC) at approximately 1357 hours.

While in the ERC, Edwards was observed having what is described as a medical event. BCSO correctional personnel then attend to Inmate Edwards at approximately 1423 hours. Inmate Edwards was transferred to the Jail's Medical Ward at approximately 1435 hours, and an emergency 9-1-1 activation was initiated at 1438 hours. BCJC

medical personnel with the assistance of Corrections Deputies provided cardiopulmonary resuscitation (CPR), administered a dose of Narcan (Naloxone), applied an automated external defibrillator (AED) and provided Oxygen to Inmate Edwards until the arrival of Brevard County Fire Rescue (BCFR) personnel (Station 29) at approximately 1449 hours.

At approximately 1505 hours, Inmate Edwards was transported by BCFR to Rockledge Regional Medical Center (RRMC).

On December 10, 2018, at approximately 2000 hours, Inmate Gregory Edwards was pronounced deceased by RRMC Doctor Edward Lin.

Video surveillance was obtained from Walmart, the West Melbourne Police Department body cameras/in car camera system, citizens and the Brevard County Jail Complex. The video recordings capture interactions involving Gregory Lloyd Edwards beginning as he approached Walmart and ending with his transport to the Rockledge Regional Medical Center from the Brevard County Jail Complex.

Interviews

Officer Jacob Mathis - West Melbourne Police Department

Officer Jacob Mathis completed a supplemental report to West Melbourne Police Department Case Report Number 18-36323, which reflected that on December 9, 2018, Officer Mathis was conducting routine patrol at Walmart, located at 845 Palm Bay Road, Palm Bay, Brevard County, Florida. At approximately 1119 hours, while on patrol a citizen approached Officer Mathis and reported a possible fight near the entrance of Walmart.

Officer Mathis' written report reflects he proceeded to the Walmart entrance area where he observed a black male later identified as LaBrandon Koonce on top of another black male later identified as Gregory Edwards. When Officer Mathis approached, Witness Koonce advised that Suspect Edwards had hit his boss who was later identified as [REDACTED] and he (Koonce) was holding Suspect Edwards down until law enforcement arrived. Officer Mathis then directed Witness Koonce to remove himself from Suspect Edwards and Officer Mathis assumed his restraint position. Officer Mathis' report reflects that Suspect Edwards attempted to break free and a struggle ensued as he got on top of Suspect Edwards. Suspect Edwards was described as kicking and flailing his arms in an attempt to escape. Officer Mathis documented in his report that he tried to handcuff Suspect Edwards (6-00, 256 lbs. - Medical Examiner Report), but was unable. Officer Mathis described how Suspect Edwards attempted to bite him during the active physical resistance. Suspect Edwards refused all commands to calm down and stop resisting.

A copy of Officer Mathis' written supplemental report (2018-00036323), body camera recording along with his in-car camera recording are enclosed as evidentiary exhibits.

Sergeant Michael Perez - West Melbourne Police Department

Sergeant Michael Perez submitted a supplemental report to West Melbourne Police Department Case Report Number 18-36323, which reflected that on December 9, 2018, at approximately 1119 hours, West Melbourne Police Sergeant Michael Perez, responded to Walmart, located at 845 Palm Bay Road, Palm Bay, Brevard County, Florida, to assist West Melbourne Police Officer Jacob Mathis who had requested expedited back-up.

Sergeant Perez reported upon arrival he observed Officer Mathis holding Gregory Edwards on the ground. Once Edwards was secure, Sergeant Perez met with Edwards' wife, Kathleen Edwards, who advised the following in substance:

Mrs. Edwards advised Sergeant Perez that her husband, Gregory Edwards, was a former Combat Medic, diagnosed with Post-Traumatic Stress Disorder (PTSD.) Mrs. Edwards stated Gregory Edwards had been out of the military for years, but had recently been in a manic state, which he experienced around the holidays. Mrs. Edwards advised Gregory Edwards was Baker Act last year around the same time, for the

same type of manic behavior he had displayed during this event. Mrs. Edwards reported last year during the Baker Act process, Gregory Edwards had battered medical staff at the hospital. Gregory Edwards was arrested for that offense and was later placed on felony probation. Mrs. Edwards stated Gregory Edwards had not slept for the last three to four days and had been hallucinating. Mrs. Edwards informed Sergeant Perez that for the past few days Gregory Edwards had been walking around the house thinking people were outside and waking their daughter up to check on her during the night. Mrs. Edwards stated she brought Gregory Edwards to the Walmart with her because she could not leave him home alone. Mrs. Edwards believed if Gregory Edwards was left by himself, he might harm himself. Mrs. Edwards also advised that Gregory Edwards had an appointment scheduled at the VA Clinic on Monday, December 10, 2018, due to the manic behavior he had displayed during the previous week. Mrs. Edwards added when Gregory Edwards was Baker Acted last year, as part of his release requirements he was placed into counseling for PTSD. While in counseling Gregory Edwards was prescribed medication, but Ms. Edwards did not believe Gregory Edwards was taking his medication.

Sergeant Perez then spoke with the victim, [REDACTED]. [REDACTED] stated Gregory Edwards began striking him from behind for no reason and that he did not know Gregory Edwards. [REDACTED] reported one of his employees, Mr. LaBrandon Koonce, came to his aid, pulling Gregory Edwards off of him and holding Gregory Edwards down.

Sergeant Perez then spoke to [REDACTED] employee, Mr. LaBrandon Koonce. Mr. Koonce stated he was in the back of the truck loading toys with the roll up door open when Gregory Edwards entered the back of the box truck. Mr. Koonce told Gregory Edwards to get out of the truck at which time Gregory Edwards took his shoes off, began laughing, fell backwards onto the bags of toys and just laid there. Mr. Koonce advised that Gregory Edwards finally got out of the truck. Moments later Mr. Koonce heard [REDACTED] calling for help. Mr. Koonce observed Gregory Edwards striking [REDACTED] from behind and exited the truck, pulling Gregory Edwards off of [REDACTED]. Mr. Koonce then tackled Gregory Edwards to the ground and physically held him there until law enforcement arrived.

Sergeant Perez's written report reflected that he was responding to the Walmart based upon Officer Mathis radio communication that he had a walk-up complaint, followed by a second notification by BCSO Dispatch relating to a battery. Sergeant Perez's report reflects Officer Mathis requested another unit and then asked for an expedited response. Upon arrival, Sergeant Perez advised Officer Mathis was holding a subject (Gregory Edwards) on the ground and Palm Bay Police Officers were on scene along with members of BCFR.

A copy of Sergeant Perez's written supplemental report (2018-00036323), body camera recording along with his in-car camera recording are enclosed as evidentiary exhibits.

On March 15, 2019, at approximately 1250 hours, I met with Sergeant Michael Perez at the West Melbourne Police Department and conducted a voluntary, sworn, audio-recorded interview at 2290 Minton Road, West Melbourne, Florida.

Sergeant Perez stated in substance the following:

Sergeant Perez stated that on December 9, 2018, Gregory Edwards was arrested by WMPD Officer Krukoski. While Officer Krukoski was enroute to the BCJC, Sergeant Perez stated he could not recall exactly how he communicated with Officer Krukoski, either by telephone or text messenger, but was inquiring the status of Gregory Edwards. Sergeant Perez stated that Officer Krukoski advised that Gregory Edwards was getting agitated. Sergeant Perez then called the BCJC booking at telephone number, 321-690-1539 and spoke to a BCJC representative. Sergeant Perez advised he could not remember the actual conversation, but believes he advised he had an officer enroute with arrestee's name and listed charges. Sergeant Perez also believes he informed the BCJC representative that Gregory Edwards was beginning to get "agitated" or "worked up" during the transport. Sergeant Perez stated that he requested BCJC personnel to assist his officer upon arrival. Sergeant Perez printed out and provided his CAD comments from December 9, 2018, where he documented that he telephoned the BCJC reference Gregory Edwards.

Officer Kevin Krukoski - West Melbourne Police Department

On December 9, 2018, at approximately 1120 hours, West Melbourne Police Department Officer Kevin Krukowski responded to Walmart, located at 845 Palm Bay Road, Palm Bay, Brevard County, Florida, in reference to an in-progress battery.

WMPD Officer Kevin Krukoski reflected in his written case report that upon arrival Officer Mathis was observed on the ground with a bystander (Koonce) helping hold the suspect down, later identified as Gregory Edwards. Officer Mathis advised Officer Krukoski that he needed leg restraints and he (Officer Krukoski) retrieved a "Hobble Leg Restraint" from his patrol car and applied it to Suspect Edwards' knees to keep him from kicking. Officer Krukoski documented that he then returned to his patrol vehicle to obtain leg shackles and placed them on Suspect Edwards' ankles as well. Officer Krukoski noted that Suspect Edwards was then moved to his patrol vehicle where he was searched and then "checked by Brevard County Fire Rescue and cleared." (BCFR Station 83 Carlos Iriban sworn statement reflects no request to evaluate/clear Suspect Edwards) (BCFR Jonathan Weiss sworn statement reflects that WMPD Officers wanted BCFR to medically clear Suspect Edwards, but cancelled the request as they (BCFR) awaited to evaluate Suspect Edwards who was in the backseat of the WMPD patrol car.) Camera recordings depict BCFR personnel standing outside of the patrol car, door open, but are never observed evaluating Suspect Edwards prior to departing the scene.) Officer Krukoski reported he made contact with the victim, [REDACTED], who was in the back of the BCFR ambulance receiving medical treatment. [REDACTED] advised Officer Krukoski that he and his employee, LaBrandon Koonce were loading the box truck with toys from Walmart as gifts for underprivileged children. [REDACTED] advised

that Gregory Edwards climbed into the back of the truck where the toys were and he [REDACTED] asked Witness Koonce to get Suspect Edwards out. As [REDACTED] began to walk away he felt someone start punching him from behind and he yelled for help. Witness Koonce then grabbed Suspect Edwards pulling him off of [REDACTED]. Victim [REDACTED] advised that Witness Koonce then held Gregory Edwards on the ground until law enforcement arrived. [REDACTED] suffered injuries described as bruising/abrasions to his arms, head and neck area. [REDACTED] advised he had never seen Gregory Edwards before and wanted to pursue battery charges.

At the conclusion of Officer Krukoski's criminal investigation into the allegation of battery, Gregory Lloyd Edwards was charged with Battery, Violation of Felony Probation and Resisting an Officer with Violence.

While enroute to the Brevard County Jail Complex, Officer Krukoski requested assistance from BCJC personnel upon his arrival, advising Inmate Edwards had become "agitated again and began kicking, stomping and screaming in the back seat." Officer Krukoski arrived at the BCJC at approximately 1309 hours, at which time Inmate Edwards was transferred to the custody of Brevard County Sheriff's Office Corrections Deputies who were awaiting his arrival based upon the request/notification of Officer Krukoski.

A copy of Officer Krukoski's written case report (2018-00036323), body camera recording, and his in-car camera recording are enclosed as evidentiary exhibits.

On March 18, 2019, at approximately 1534 hours, I met with West Melbourne Police Department Officer Kevin Krukoski to conduct a voluntary, sworn, audio-recorded interview. The interview was conducted at the West Melbourne Police Department.

Officer Krukoski stated in substance the following:

Officer Krukoski is a Patrol Officer for West Melbourne Police Department and has been employed with them for approximately two years.

On December 9, 2018, Officer Krukoski responded to the Walmart located at 845 Palm Bay Road, Palm Bay, Florida, and ultimately arrested Gregory Edwards. Officer Krukoski stated that when Gregory Edwards was placed into the back seat of his marked patrol vehicle, Gregory Edwards was calm and was muttering undistinguishably. After Officer Krukoski completed his paperwork he proceeded to the BCJC with Gregory Edwards still seated in his back seat.

Officer Krukoski stated that while enroute to the BCJC, Gregory Edwards became agitated and began kicking and screaming as well as yelling at Officer Krukoski to let him out of the vehicle. Officer Krukoski described Gregory Edwards as going in and out of an agitated state. Based on Gregory Edwards' violent behavior at Walmart in conjunction with his aggressive behavior in the backseat, Officer Krukoski sent a message to Sergeant Perez via the CAD System. In the message, Officer Krukoski

requested Sergeant Perez contact and notify the BCJC due to Gregory Edwards agitation.

Once at the BCJC, Officer Krukoski was met in the Sally Port by two BCJC Corrections Deputies who assisted in removing Gregory Edwards from his patrol vehicle. Once inside the BCJC, Officer Krukoski provided BCJC Corrections Deputies with Gregory Edwards arrest paperwork and departed the facility. Officer Krukoski advised that in his observation, Gregory Edwards appeared compliant with the BCSO Corrections Deputies while he was present.

I then asked Officer Krukoski if BCFR medically cleared Gregory Edwards prior to leaving Walmart as his case report indicated. Officer Krukoski advised he did not see BCFR medically evaluate Gregory Edwards, however, BCFR personnel indicated to Officer Krukoski that they did medically clear Gregory Edwards. Officer Krukoski further explained that when Gregory Edwards was placed in the backseat of his patrol vehicle, BCFR was present near the vehicle. Officer Krukoski explained since BCFR was standing by, near his vehicle, he left to obtain statements from witnesses and the victim. When Officer Krukoski returned back to his vehicle he asked BCFR personnel if Gregory Edwards was, "good," and BCFR advised, "He's good." Palm Bay Police Department

On December 9, 2018, at approximately 1126 hours, the Palm Bay Police Department received an Assist Other Agency call, and responded to Walmart, located at 845 NE Palm Bay Road, Palm Bay, Brevard County, Florida. Palm Bay Police Officers Jeffrey Reardon and Steven Smith both arrived on scene and cleared the call reflecting no direct involvement with the arrest of Gregory Edwards.

Corrections Deputy [REDACTED]

On December 9, 2018, at approximately 1720 hours, Agent Wayne Simock conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy [REDACTED], at the Brevard County Sheriff's Office Criminal Investigative Services (CIS) Office, located at 340 Gus Hipp Boulevard, Rockledge, Florida.

Corrections [REDACTED] stated in substance the following:

[REDACTED] has been employed by the Brevard County Sheriff's Office since April 3, 2006, and is assigned to the Brevard County Jail Complex as a Corporal.

While employed with the Brevard County Sheriff's Office, [REDACTED] has been previously held the assignment of Field Training Officer.

[REDACTED] described his duties in the Booking area as follows:

requested Sergeant Perez contact and notify the BCJC due to Gregory Edwards agitation.

Once at the BCJC, Officer Krukoski was met in the Sally Port by two BCJC Corrections Deputies who assisted in removing Gregory Edwards from his patrol vehicle. Palm Bay Police Officers Jeffrey Reardon and Steven Smith both arrived on scene and cleared the call reflecting no direct involvement with the arrest of Gregory Edwards.

Corrections Deputy Brian Otto - Corporal

On December 9, 2018, at approximately 1720 hours, Agent Wayne Simock conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy [REDACTED], at the Brevard County Sheriff's Office Criminal Investigative Services (CIS) Office, located at 340 Gus Hipp Boulevard, Rockledge, Florida.

Corrections [REDACTED] stated in substance the following:

[REDACTED] has been employed by the Brevard County Sheriff's Office since April 3, 2006, and is assigned to the Brevard County Jail Complex as a Corporal.

While employed with the Brevard County Sheriff's Office, [REDACTED] has been previously held the assignment of Field Training Officer.

[REDACTED] described his duties in the Booking area as follows:

██████████ receives and processes incoming inmates, which includes, but is not limited to, ensuring booking paperwork from arresting officers/deputies are complete. ██████████ ensures all incoming inmates are screened by the intake nurse, photographed and fingerprinted.

On December 9, 2018, ██████████ began his shift at 0600 hours, and was assigned to the processing responsibilities of the Booking area along with Field Training Officer (FTO) Robert Wagner Jr. and Sergeant Richard Zimmerman.

On December 9, 2018, the booking area (Sergeant Richard Zimmerman) received a telephone call from a member of the West Melbourne Police Department in reference to an arrestee, later identified as Inmate Gregory Edwards. The West Melbourne Police Department had requested assistance in bringing Inmate Edwards into the Brevard County Jail Complex upon their arrival. According to West Melbourne Police Department Officer, Inmate Edwards was a military veteran who suffered from PTSD and the officer transporting Inmate Edwards was approximately 10 minutes from arriving at the Jail. ██████████ advised that Inmate Edwards was reported to be "acting up." ██████████ could not be specific as to what West Melbourne Police Department meant by "acting up," since he did not speak with the West Melbourne officer directly. ██████████ advised upon West Melbourne Police Departments' arrival, Sergeant Zimmerman and FTO Wagner left the Booking area and assisted the West Melbourne Police Officer (Officer Krukoski) in escorting Inmate Edwards into the BCJC. ██████████ stated that Inmate Edwards was not combative while being escorted into the booking area and was then dressed into a jail/booking uniform without incident. ██████████ stated that Inmate Edwards was then placed into booking holding cell number seven (7) by ██████████ as FTO Wagner began entering Inmate Edwards' personal/arrest information into the Jail Management Computer System.

██████████ stated that during this timeframe, Inmate Edwards started pacing back and forth inside the cell and threw his bag lunch against the door. ██████████ stated that Inmate Edwards then started banging on the door window. ██████████ advised that he then walked over to the cell door window and asked what was wrong, asking Inmate Edwards why he was banging on the window. ██████████ stated that Inmate Edwards did not answer, but stopped banging on the window for a brief time, then a short time later resumed banging on the window. ██████████ stated he then walked over to the cell door, opened it and informed Inmate Edwards it was time for him to be processed, explaining what that processing meant as he was going to be photographed and fingerprinted.

Once Inmate Edwards exited the cell, ██████████ handed him his flip flops, which had been lying on the floor outside the cell. Inmate Edwards dropped the flip flops onto the floor, but did not put them on his feet. ██████████ stated he then attempted to escort Inmate Edwards towards the AFIS Live Scan fingerprint machine. ██████████ stated that while escorting Inmate Edwards in the direction of the processing equipment, Inmate Edwards told ██████████ that he wasn't going to be put into the system. ██████████ advised he responded and told him he was already in the system, but that he still

needed to be fingerprinted and photographed. At that time ██████ advised that Inmate Edwards clenched his fists, turned and started moving away from Corrections ██████. ██████ placed his hand onto Inmate Edwards' right shoulder in an attempt to guide him toward the Live Scan machine. ██████ stated he then observed Inmate Edwards clench his fists again as he brought them up into what ██████ believed to be an aggressive fighting stance. ██████ stated that due to the active resistance Inmate Edwards was displaying by clenching his fists and getting into what he believed was a fighting stance, ██████ reached out to Inmate Edwards shoulder area and attempted to redirect Inmate Edwards to the floor so he could get Inmate Edwards into a position where he could place handcuffs on him.

As ██████ struggled to secure Inmate Edwards, both fell to the floor. ██████ stated that he fell onto his back and struck the back of his head on the concrete floor. ██████ stated that Inmate Edwards landed on top of him and once on the ground, Inmate Edwards started striking him. ██████ stated that he momentarily lost consciousness and he felt Inmate Edwards pulling on his belt and handcuff holders. ██████ stated he couldn't get out from underneath Inmate Edwards.

██████ advised that FTO Robert Wagner and Sergeant Richard Zimmerman came to his aid. With their assistance, ██████ stated he was able to move from underneath Inmate Edwards. ██████ advised that he was able to see Lieutenant Fayson and Deputy Blazewicz assisting as well by attempting to gain control of Inmate Edwards. ██████ stated he then deployed his agency issued chemical agent to the area of Inmate Edwards face in an attempt to gain compliance. ██████ advised his attempt was unsuccessful. ██████ stated he was positioned on Inmate Edward's right side and was trying to gain control of Inmate Edwards' arm, which was tucked up underneath his body. ██████ stated he heard someone say a Taser was going to be deployed. ██████ advised that Deputy Blazewicz then deployed her agency issued Conducted Electrical Weapon (CEW.) ██████ stated he recalled seeing the probes of the CEW in Inmate Edwards' buttocks area. ██████ advised Inmate Edwards continued to actively fight with the deputies until he was finally handcuffed. ██████ reported hearing other deputies giving verbal commands to Inmate Edwards such as, "stop resisting" and "put your hands behind your back."

██████ stated that when the incident concluded, it was discovered that during the struggle as Inmate Edwards was pulling on ██████ duty belt, his agency issued handcuffs had fallen out and were located on the floor where the incident took place. ██████ stated the handcuffs were then returned to him.

██████ advised that during the incident he was in fear of being injured. He had been advised Inmate Edwards was an Army veteran who suffered from PTSD and likely had a high level of combat training.

██████ sustained several injuries as a result of the incident and was transported to RRMCC for medical attention. ██████ stated he was treated for abrasions to his

body, a contusion to the back of his head and a concussion. [REDACTED] was later released from the hospital.

At the conclusion of [REDACTED] interview, Brevard County Sheriff's Office Crime Scene Investigator Lindsey Cox documented [REDACTED] to include his injuries via digital photographs.

Corrections Deputy Richard Zimmerman – Sergeant

On December 13, 2018, at approximately 1026 hours, I conducted a voluntary, sworn, audio-recorded interview with Corrections Sergeant Richard Zimmerman, in the presence of Coastal Florida Police Benevolence Association (PBA) Representative Al Boettjer and Attorney Martin White at the Brevard County Sheriff's Office Criminal Investigative Services Office, located at 340 Gus Hipp Boulevard, Rockledge, Florida.

Corrections Sergeant Zimmerman stated in substance the following:

Sergeant Zimmerman has been employed by the Brevard County Sheriff's Office since November 4, 1996, and is assigned to the Brevard County Jail Complex with the classified rank of Sergeant.

On December 9, 2018, Sergeant Zimmerman began his shift at 0600 hours and was assigned to the booking area of the BCJC.

On December 9, 2018, Sergeant Richard Zimmerman received a telephone call from a member of the West Melbourne Police Department in reference to an arrestee, later identified as Inmate Gregory Edwards. The West Melbourne Police Department had requested assistance in bringing Inmate Edwards into the Brevard County Jail Complex upon their arrival. According to West Melbourne Police Department, Inmate Edwards was a military veteran who suffered from PTSD and the officer transporting Inmate Edwards was approximately 10 minutes from arriving at the Jail.

Sergeant Zimmerman stated when WMPD arrived in the Sally Port, he and Corrections Deputy Robert Wagner Jr. proceeded outside to assist with the arrestee who was later identified as Inmate Gregory Edwards. Sergeant Zimmerman and Deputy Wagner escorted Inmate Edwards into the jail, searched him and conducted a Rapid ID to confirm his identity. Sergeant Zimmerman stated Inmate Edwards was then led to the changing area. Once changed out of his clothing, Inmate Edwards was placed into holding cell number seven (7) and provided with a bag lunch. Sergeant Zimmerman advised that these functions were all completed without incident.

Sergeant Zimmerman stated he had no further interaction until he observed Inmate Edwards and [REDACTED] standing outside of holding cell number seven (7). Sergeant Zimmerman advised he then lost sight of both individuals. Sergeant Zimmerman immediately responded to the holding cell area where he observed [REDACTED] struggling to secure Inmate Edwards on the floor. Sergeant Zimmerman stated that both

he and Deputy Wagner tried to assist [REDACTED] in securing Inmate Edwards who was actively resisting. Sergeant Zimmerman stated he then positioned himself near Inmate Edwards head area and performed a pain compliance technique, "hollow behind the ear" in an attempt to gain both compliance and control. Sergeant Zimmerman advised the compliance technique did not have an effect on Inmate Edwards and Inmate Edwards continued to resist.

During the struggle, Sergeant Zimmerman heard someone announce "Taser" and there was a deployment to Inmate Edwards. Sergeant Zimmerman advised Inmate Edwards was finally secured and placed into the Emergency Restraint Chair (ERC). While deputies were securing Inmate Edwards into the ERC, Sergeant Zimmerman utilized an "upper jaw thrust" technique. Sergeant Zimmerman stated he performed this technique to prevent Edwards from moving his head around while being secured. Once secured, he observed a vented "spit mask" was placed upon Inmate Edwards and he was rolled into holding cell number nine (9).

Sergeant Zimmerman responded to holding cell number nine (9) a short time later and noticed a nurse and corrections deputies around Inmate Edwards. Sergeant Zimmerman advised he observed Nurse Nadeau providing Inmate Edwards with oxygen and that Inmate Edwards was then transported to the Medical Ward. Once in the Medical Ward the charge nurse requested 9-1-1 be called. Sergeant Zimmerman stated he directed Corporal Regina Ellis to activate 9-1-1. Sergeant Zimmerman stated that Inmate Edwards was then removed from the ERC and placed onto the floor where CPR was initiated. Sergeant Zimmerman stated he continued to assist with CPR until BCFR arrived and assumed CPR.

Sergeant Zimmerman stated that he had no further involvement with Inmate Gregory Edwards.

CSO Conrad Schneider documented Sergeant Zimmerman with digital photography on December 9, 2018.

Deputy Robert Wagner Jr. – Field Training Officer

Corrections Deputy Robert Wagner Jr. would not provide a voluntary, sworn, audio-recorded statement relating to his interactions with Inmate Gregory Edwards.

Deputy Robert Wagner Jr. has been employed by the Brevard County Sheriff's Office since March 2, 2009, and is currently assigned to the Brevard County County Jail Complex as a Field Training Officer.

On December 18, 2018, at approximately 1421 hours, via electronic mailing, I received a proffer statement on behalf of Deputy Robert Wagner Jr., through his legal counsel, Alan Diamond, Esq., with Funk, Szachacz & Diamond, LLC. The proffer statement included the following:

"On December 9, 2018, Corrections Deputy R. Wagner was working in the booking area of the jail when BCSO received information that WMPD was transporting Gregory Edwards who had been combative and that WMPD would need assistance escorting Edwards into the facility. Initially, Edwards is not openly aggressive and is placed in a holding cell for processing. From the video it is apparent that Edwards becomes agitated and begins to bang on the cell door. ██████ goes to the door to assist and opens the door to address Edwards. It is at this point Edwards attacks ██████. Wagner was at the computer in the booking room and immediately gets up to assist as Edwards has ██████ in a choke hold and is wrestling with him on the floor. Wagner tries to pull Edwards off of ██████. There were multiple verbal commands given to Edwards to stop resisting and release ██████. Edwards is hitting ██████ in the head and will not release him. Wagner tries to gain control of Edwards' hands to no avail. Pursuant to training, Wagner administers a few strikes to Edwards' thigh to cause distraction and in an attempt to get pain compliance to the commands to release ██████. Again this has no effect on Edwards' violent and aggressive actions. Multiple deputies arrive to assist. Edwards' attack on ██████ has caused ██████ to become disoriented-and he maybe even lose consciousness during the attack. Edwards is attempting to remove ██████ flashlight from his duty belt and Wagner is grasping his wrist to prevent him from obtaining it and possibly use it as a weapon. Edwards has "enhanced" strength and will not comply with verbal commands all the while Wagner is trying to gain control of Edwards' hands to place him in restraints. At one point there are less than 7 deputies trying to hold Edwards down and gain control of his hands to apply cuffs-again unsuccessfully. ██████ Administers OC spray which does not cause any change in Edwards' aggressive actions. Edwards is still uncooperative, combative and inhumanly strong. Lt. Fayson applies knee strikes to get compliance.

Eventually, after it is apparent that even 7+ deputies cannot safely gain control of Edwards; Dep. Blazewicz deploys her CEW firing the probes into Edwards. This attempt to gain control causes a visible reaction such that Deputies are able to get Edwards cuffed and placed in the restraint chair for control and transport. Deputies try to secure his legs in the straps on the chair but again Edwards is fighting their attempts. Again Wagner must administer a few closed fist flows (approximately 3) to Edwards' leg to gain compliance so that he can be safely strapped in to the restraint chair. The pain compliance technique works and Edwards is secured.

At this point the deputies are all exhausted having struggled with Edwards- he is secured in the restraint chair and the straps are checked for proper fit and tightness, but Edwards remains cuffed for his and officer safety pursuant to Lt. Fayson's orders. Edwards is still aggressive, and verbal-to the point that he is emitting guttural howls and a spit guard is place over his head due to his conduct. As he is wheeled in to the holding cell here are no signs of physical distress-Edwards is still verbal (very loud) and moving (although still restrained) while in the chair. Wagner received a small scratch on his hand during the altercation and he seeks medical help from the nurse on staff. Edwards is secured in the holding cell and remains in the chair-he is visible from the booking room and Wagner is watching him. He is still verbal and moving and struggling. Wagner and the nurse both observe Edwards and see no signs of distress. The OC spray which

Otto deployed is beginning to affect Wagner and he attempts to wash it from his face. Minutes later Cpl. Mustafa observes defendant and she and a nurse enter the holding cell. It is at this point that the defendant appears to be in some form of medical distress. He is breathing-but unresponsive. Oxygen is brought and he is taken to medical for further treatment. Corrections Deputy Wagner had no further interacting with Edwards once he leaves booking."

Corrections Deputy Wagner was documented on December 9, 2018, by CSI Conrad Schneider. Due to Deputy Wagner indicating his uniform shirt was torn during the struggle with Inmate Edwards, CSI Schneider collected Deputy Wagner's shirt as an evidentiary item.

Corrections Deputy Freddy Cedeno

On December 12, 2018, at approximately 1050 hours, Agent Wheeler and I conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy Freddy Cedeno, in the presence of Al Boettjer, a consultant with CJ Christie Consulting, at the Brevard County Sheriff's Office, located at 340 Gus Hipp Boulevard, Rockledge, Florida.

Corrections Deputy Cedeno stated in substance the following:

Deputy Cedeno has been employed by the Brevard County Sheriff's Office since January 8, 2018, and is assigned to the Brevard County Jail Complex.

On December 9, 2018, Deputy Cedeno began his shift at 0600 hours, and was assigned to the 300 pod when he heard assistance was needed in the booking area. Deputy Cedeno immediately responded to the booking area to provide assistance.

Once in the booking area, he observed several deputies on the ground, attempting to gain control of an Inmate, Gregory Edwards. Deputy Cedeno saw Deputy Popielarczyk on the ground struggling as she tried to control Inmate Edwards' legs. Deputy Cedeno relieved Deputy Popielarczyk and assumed her position. While trying to hold Inmate Edwards legs, Deputy Cedeno heard deputies giving Inmate Edwards verbal commands and orders, to which he did not comply, and continued to resist. Corrections deputies could not gain control of Inmate Edwards's hands and arms, therefore, Deputy Blazewicz deployed her Conducted Electrical Weapon (CEW) to Inmate Edwards. The CEW did not appear to have an effect on Inmate Edwards, and he continued to actively resist the corrections deputies. Deputy Blazewicz then deployed a dry-stun with her CEW to Inmate Edwards, and corrections deputies were able to secure Inmate Edwards with handcuffs behind his back. Once secured, corrections deputies placed Inmate Edwards into the ERC. Deputy Cedeno stated he retrieved leg restraints and brought them back to the deputies in case they were needed. Deputy Cedeno was then directed by Lt. Fayson to place a vented "spit mask" on Inmate Edwards, which he did. Deputy Cedeno stated Inmate Edwards continued to resist, yell, and tense up while secured in the ERC. Inmate Edwards was then rolled into a holding cell and Deputy Cedeno returned to 300 pod.

Deputy Cedeno stated a short time later, he heard additional units were needed in the booking area again. When he arrived back into the booking area, he observed that Inmate Edwards did not appear conscious, but his chest was rising and falling. Nurse Nadeau was tending to Inmate Edwards and had placed an oxygen mask on him.

Deputy Cedeno stated he had no further involvement with Inmate Gregory Edwards.

Deputy Cedeno was documented by digital photographs on December 9, 2018, by CSI Conrad Schneider.

Corrections Deputy DaShawn Edward

On December 12, 2018, at approximately 1035 hours, Agent Wheeler and I conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy DaShawn Edward, in the presence of Al Boettjer, a consultant with CJ Christie Consulting, at the Brevard County Sheriff's Office CIS Office, located at 340 Gus Hipp Boulevard, Rockledge, Florida.

Corrections Deputy Edward stated in substance the following:

Deputy Edward has been employed by the Brevard County Sheriff's Office since July 13, 2015, assigned to the Brevard County Jail as a Dual-Certified Deputy Sheriff.

On December 9, 2018, Deputy Edward began his shift at 0600 hours, and was assigned to another area of the Jail Complex when he heard that assistance with an Inmate was needed in the booking area. Deputy Edward immediately responded to the booking area to provide assistance.

When Deputy Edward entered the booking area, he saw multiple deputies attempting to control a non-compliant Inmate, later identified as Inmate Gregory Edwards. Deputy Edward stated he then placed himself in-between two corrections deputies and assisted. Deputy Edward advised at one point, corrections deputies were able to secure one of Edwards's arms, but he would not release his other arm, even after verbal commands were given. Deputy Edward disengaged with Inmate Edwards once both of his arms were secured. Deputy Edward advised Inmate Edwards was then placed into an ERC, where Inmate Edwards continued to resist. Deputy Edward stated he placed the hip strap for the ERC around Inmate Edwards and also secured the strap on Inmate Edwards left leg. After he was fully secured in the ERC, Deputy Edward rolled Inmate Edwards into a holding cell. Deputy Edward stated that Inmate Edwards was conscious and was still yelling and trying to resist while in the ERC.

Deputy Edward stated he had no further involvement with Inmate Gregory Edwards. Deputy Edward was documented by digital photographs on December 9, 2018, by CSI Conrad Schneider.

Corrections Major Kelly Haman – Watch Commander

On December 9, 2018, at approximately 1919 hours, I conducted a voluntary, sworn, audio-recorded interview with Corrections Major Kelly Haman at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Major Kelly Haman stated in substance the following:

Major Haman has been employed by the Brevard County Sheriff's Office since October 12, 1999, and is assigned to the Brevard County Jail Complex with the Exempt rank of Major (Watch Commander).

On December 9, 2018, Major Haman began her shift at approximately 1330 hours, and was in her office when she heard Lieutenant Fayson calling for assistance in the booking area. Major Haman advised she then responded to the booking area to assist.

Once in the booking area, Major Haman observed Inmate Gregory Edwards actively and physically resisting several corrections deputies. Verbal commands and a chemical agent had already been deployed and were unsuccessful in obtaining compliance. Major Haman stated she instructed Deputy Blazewicz to deploy her CEW to Inmate Edwards. When the CEW did not have an observed effect on Inmate Edwards, Major Haman stated Lieutenant Fayson ordered Deputy Blazewicz to apply another cycle of the CEW. Major Haman advised Deputy Blazewicz administered a dry-stun of the CEW to Inmate Edwards. Major Haman advised it appeared during this CEW cycle that corrections deputies were able to gain some compliance of Inmate Edwards. Major Haman advised Inmate Edwards' arms were underneath of his body, but they tensed right back up when the cycle was complete. Major Haman stated that due to Inmate Edwards' active resistance, Deputy Blazewicz initiated another dry-stun cycle of the CEW to Inmate Edwards. Major Haman stated after this cycle the deputies were able to secure Inmate Edwards' hand.

Major Haman stated Inmate Edwards was then secured with handcuffs and placed in the ERC. Once restrained in the ERC, Major Haman left to check on Deputy Otto's injuries. After checking on [REDACTED], Major Haman proceeded to the tent area of the jail. A short time later Major Haman heard Lieutenant Fayson initiate 9-1-1 over the radio and she responded to the Medical Ward. Once in the Medical ward, Major Haman learned Inmate Edwards was now unresponsive and CPR was initiated.

Major Haman advised Inmate Edwards was then transported to RRMCC, via BCFR.

Major Haman had no further involvement with Inmate Gregory Edwards.

Corrections Deputy Allison Blazewicz

On December 9, 2018, at approximately 1621 hours, Agent Philipp Urbanetz made contact with Corrections Deputy Allison Blazewicz at RRMC, located at 110 Longwood Drive, emergency room twelve, Rockledge, Brevard County, Florida. Deputy Blazewicz had accompanied [REDACTED] to the hospital for medical treatment in reference to the injuries he sustained from Inmate Edwards.

Deputy Blazewicz advised Agent Urbanetz she had a CEW cartridge and wires without the probes wrapped up in a latex glove secured in her vehicle. Deputy Blazewicz further advised the CEW cartridge and wires were the ones she deployed to Inmate Gregory Edwards during the response to resistance. Deputy Blazewicz directed Agent Urbanetz to her vehicle, where Deputy Blazewicz opened her vehicle and provided Agent Urbanetz with the CEW cartridge and wires. Agent Urbanetz then accompanied Deputy Blazewicz to the Brevard County Sheriff's Office CIS Office.

CSI Cox then took custody of Deputy Blazewicz CEW cartridge and the agency issued uniform she was wearing during the incident as evidentiary items.

Deputy Blazewicz would not to provide a voluntary, sworn, audio-recorded statement to Agent Urbanetz relating to her interactions with Inmate Gregory Edwards.

Deputy Allison Blazewicz has been employed by the Brevard County Sheriff's Office since February 16, 2015, and is assigned to the Brevard County Jail Complex.

Deputy Blazewicz was documented by digital photographs on December 9, 2018, by CSI Cox, and on December 11, 2018, by CSI Schneider.

Corrections Deputy George Fayson - Lieutenant

Corrections Lieutenant George Fayson would not provide a voluntary, sworn, audio-recorded statement regarding his interaction with Inmate Gregory Edwards.

Lieutenant George Fayson has been employed by the Brevard County Sheriff's Office since November 2, 1992, and is assigned to the Brevard County Jail Complex with the classified rank of Lieutenant.

Lieutenant Fayson was documented by digital photographs on December 9, 2018, by CSI Conrad Schneider.

Corrections Deputy Keith Tiller

On December 9, 2018, at approximately 1912 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy Keith Tiller at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Tiller stated in substance the following:

Deputy Tiller has been employed by the Brevard County Sheriff's Office since October 1, 2007, and is assigned to the Brevard County Jail Complex responsible for prisoner transportation to facilities located outside of the Brevard County Jail.

On December 9, 2018, Deputy Tiller began his shift at approximately 0600 hours, and was at the BCJC when he heard assistance was needed in the booking room. Corrections Deputy Tiller responded to the booking area to assist.

Once in the booking area, Deputy Tiller observed several Corrections Deputies trying to secure Inmate Gregory Edwards on the floor. Deputy Tiller heard the corrections deputies giving multiple verbal commands to Inmate Edwards to stop resisting and cooperate with the deputies. Deputy Tiller observed Inmate Edwards continue to resist and refuse to follow the instructions the corrections deputies were giving.

Deputy Tiller assisted by holding Inmate Edwards' left leg down to prevent him from kicking anyone. Deputy Tiller advised Deputy Blazewicz arrived and was assigned a CEW, at which time Major Kelly Haman directed her to deploy the CEW on Inmate Edwards. Deputy Tiller recalled the CEW was used on Inmate Edwards twice, but did not appear to affect him. Deputy Tiller stated Inmate Edwards was non-compliant the entire time, but was eventually restrained in handcuffs. Deputy Tiller stated Inmate Edwards was then placed into the ERC, where he applied the left shoulder strap. Deputy Tiller stated Inmate Edwards continued to brace himself and pull away in what he believed was an attempt to prevent the straps on the chair from being secured into place. Deputy Tiller stated Inmate Edwards was breathing "real hard," and was "grunting." Deputy Tiller advised that once Inmate Edwards was secured, Nurse Nadeau checked Inmate Edwards's restraints to verify they were not too tight and Inmate Edwards was then placed into holding cell nine (9). Deputy Tiller then returned to his normal assigned job duties located in the 400 pod area.

Deputy Tiller stated that a short time later he heard assistance was needed in the booking area again and he responded to assist. Deputy Tiller stated he observed Inmate Edwards unresponsive in holding cell nine (9). Deputy Tiller stated that Nurse Nadeau responded to Inmate Edwards and placed an oxygen mask on him. Deputy Tiller stated Inmate Edwards was then taken to the Medical Ward while still secured in the ERC. Deputy Tiller stated he assisted in wheeling Inmate Edwards to the Medical Ward.

Deputy Tiller advised that once they arrived at the medical ward, the charge nurse immediately ordered the corrections deputies initiate 9-1-1. Deputy Tiller was then

informed by Sergeant Zimmerman to leave the medical ward and go outside to meet the ambulance as it arrived. Deputy Tiller stated that once the ambulance arrived, BCFR personnel tended to Inmate Edwards and when Inmate Edwards was transported to RRMC, he rode in the back of the ambulance with Inmate Edwards.

Deputy Tiller advised Inmate Edwards was placed into emergency room eighteen (18), where RRMC staff assumed his medical care. Deputy Tiller stated he remained with Edwards until he was relieved from his assignment at approximately 1800 hours that evening.

Deputy Tiller had no further involvement with Gregory Edwards.

Corrections Deputy Branden Hartley

On December 9, 2018, at approximately 1955 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy Branden Hartley at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Hartley stated in substance the following:

Deputy Hartley has been employed by the Brevard County Sheriff's Office since April 23, 2018, and is assigned to the Brevard County Jail Complex.

On December 9, 2018, Deputy Hartley began his shift at approximately 0600 hours, and was assigned to the 400 pod, when he heard a call for assistance in the booking room. Deputy Hartley stated he responded to the booking area to assist.

Due to Corrections Deputies already involved, Deputy Hartley did not initially engage to assist, but noticed the Corrections Deputies were having difficulty getting Inmate Edwards' right hand secured in handcuffs. Deputy Hartley stated he then attempted to help secure the right hand by applying one response to resistance "knee strike" to Inmate Edwards' elbow area. Deputy Hartley advised that while this was occurring, a CEW was deployed on Inmate Edwards in an attempt to gain compliance. Deputy Hartley advised that once Corrections Deputies gained control of Inmate Edwards, he was placed into the ERC. Deputy Hartley stated he then secured Inmate Edwards' right shoulder strap, lap belt on the right side and the right foot. Deputy Hartley stated that throughout the response to the resistance, numerous verbal commands were given to Inmate Edwards by Corrections Deputies to stop his resistance.

Deputy Hartley stated that once Inmate Edwards was secured in the ERC, he was placed into holding cell nine (9). Deputy Hartley stated he then left the booking area.

Deputy Hartley advised that a short time later, he heard another assistance call to the booking area, and a stretcher was requested. He went to retrieve a stretcher and returned to the booking area where he observed Inmate Edwards with an oxygen mask on and his eyes were "fluttering." Deputy Hartley advised that Inmate Edwards was

unresponsive and moved to the Medical Ward while still secured in the ERC. Deputy Hartley advised he held the oxygen tank while escorting Inmate Edwards to the Medical Ward. When they arrived in the Medical Ward, all restraints were released from the ERC and Inmate Edwards was placed on his back where Corrections Deputies initiated CPR. Deputy Hartley stated BCFR personnel then arrived on scene and began to render medical aid and then transported Inmate Edwards.

Deputy Hartley had no further involvement with Gregory Edwards.

Corrections Deputy Veronica Shinholster

On December 9, 2018, at approximately 2011 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy Veronica Shinholster at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Shinholster stated in substance the following:

Deputy Shinholster has been employed by the Brevard County Sheriff's Office since April 7, 1997, and is assigned to the Brevard County Jail Complex.

On December 9, 2018, Deputy Shinholster began her shift at approximately 0600 hours, and was in the booking area when she observed an incident involving an Inmate identified as Gregory Edwards. Deputy Shinholster stated that the issue was being addressed by other Corrections Deputies, so she moved other Inmates and a trustee who were in the immediate area into another holding cell for their safety.

Deputy Shinholster stated that during the incident she could hear Corrections Deputies providing verbal commands to Inmate Edwards requesting he cooperate.

This concluded Deputy Shinholster's involvement with Gregory Edwards.

Corrections Deputy Shannon Popielarczyk

On December 9, 2018, at approximately 1855 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy Shannon Popielarczyk at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Popielarczyk stated in substance the following:

Deputy Shannon Popielarczyk has been employed by the Brevard County Sheriff's Office since November 28, 2005, and is assigned to the Brevard County Jail Complex responsible for Transportation.

On December 9, 2018, Deputy Popielarczyk began her shift at 0600 hours, and was dropping off prisoners in the booking area.

While in the booking area she observed [REDACTED] and an Inmate later identified as Gregory Edwards. As Deputy Popielarczyk turned to leave she heard what sounded like a commotion behind her. Deputy Popielarczyk turned back and saw both [REDACTED] and Inmate Edwards on the ground in what appeared to be a physical altercation. She immediately assisted [REDACTED] with Inmate Edwards by attempting to gain control of Inmate Edwards's legs. Deputy Popielarczyk said her efforts were ineffective. Deputy Popielarczyk stated while trying to gain control of Inmate Edwards, she heard other corrections deputies giving verbal commands for Inmate Edwards to stop resisting and to cooperate with the deputies. Deputy Popielarczyk stated Inmate Edwards was not following any verbal commands and was continuing to brace his body and actively resist their efforts. Deputy Popielarczyk stated Inmate Edwards was exhibiting what she described as "super human strength," because Inmate Edwards was lifting her off of the ground with his legs. Deputy Popielarczyk advised Inmate Edwards continued to resist, therefore, Deputy Popielarczyk disengaged and requested assistance from another corrections deputy. Deputy Popielarczyk stated Inmate Edwards' resistance was active and physical, therefore, Inmate Edwards was sprayed with Oleoresin Capsicum (O.C.).

Deputy Popielarczyk stated the O.C. spray was not successful in gaining compliance or control of Inmate Edwards, therefore a CEW was utilized. Deputy Popielarczyk stated Inmate Edwards continued to resist even after the CEW was deployed, but corrections deputies were able to eventually gain control of his hands and he was handcuffed behind his back.

Deputy Popielarczyk advised that once Inmate Edwards was handcuffed, Major Haman gave the order for Inmate Edwards to be placed into the ERC and Deputy Popielarczyk retrieved the ERC. Deputy Popielarczyk advised that she held Inmate Edwards legs down while he was placed into the chair.

Deputy Popielarczyk advised when she left the booking room area Inmate Edwards was secured in the ERC and the "spit mask" was utilized. Deputy Popielarczyk stated that Inmate Edwards was breathing and conscious, but she noticed his pupils were dilated. Deputy Popielarczyk advised she believed Inmate Edwards was impaired by drugs, and/or alcohol due to his behavior.

This concluded Deputy Popielarczyk's involvement with Gregory Edwards.

Corrections Deputy Adam Turco

On December 9, 2018, at approximately 2016 hours, Agent Wayne Simock and Agent Philipp Urbanetz conducted a voluntary sworn, audio-recorded interview with Brevard County Sheriff's Office Corrections Deputy Adam Turco at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Turco stated in substance the following:

Deputy Turco has been employed by the Brevard County Sheriff's Office since July 27, 2015, assigned to the Brevard County Jail Complex.

On December 9, 2018, Deputy Turco began his shift at 0600 hours, and was assigned to the tent area of the BCJC. While in the tent area, Deputy Turco heard radio traffic advising the need for deputies in reference to a medical issue. Deputy Turco stated Major Kelly Haman directed him to respond to the call for assistance.

Deputy Turco stated he left tent four and went directly to the Medical Ward. Upon entering the Medical Ward, Deputy Turco saw Sergeant Zimmerman performing chest compressions on Inmate Gregory Edwards near the nurses' station. Deputy Turco took over chest compressions for Sergeant Zimmerman and after a several rounds of CPR, Corporal Wright replaced his position. Deputy Turco recalled an AED was applied to Inmate Edwards and it advised to continue CPR. BCFR personnel arrived on scene shortly after and assumed all medical treatment for Inmate Edwards. Deputy Turco stated he escorted the BCFR personnel to the Sally Port area where he entered the ambulance along with Inmate Edwards. He remained in the ambulance until it was outside the perimeter security fence. Once outside the fence, Deputy Tiller entered the ambulance and traveled to the hospital with Inmate Edwards.

This concluded Deputy Turco's involvement with Inmate Gregory Edwards.

Corrections Deputy John Wright - Corporal

On December 9, 2018, at approximately 1904 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy John Wright at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Wright stated in substance the following:

Deputy Wright has been employed by the Brevard County Sheriff's Office since February 17, 2003, assigned as a Corporal to the Brevard County Jail Complex.

On December 9, 2018, Deputy Wright began his shift at 0600 hours, and was assigned to the BCJC Medical Ward. During the course of his shift, Deputy Wright observed Inmate Gregory Edwards transported to the Medical Ward in an ERC. Deputy Wright assisted Sergeant Zimmerman and Deputy Turco move Inmate Edwards from the ERC to the floor where they provided CPR to Inmate Edwards. All three parties completed a rotation of chest compressions on Inmate Edwards until BCFR arrived on scene. Prior to BCFR arriving on scene, an automated external defibrillator (AED) was applied and a dose of Narcan was administered to Inmate Edwards.

This concluded Deputy Wright's involvement with Inmate Gregory Edwards.

Corrections Deputy Andrea Mustafa

On December 9, 2018, at approximately 1925 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy Andrea Mustafa at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Mustafa stated in substance the following:

Deputy Andrea Mustafa has been employed by the Brevard County Sheriff's Office since January 17, 2006, assigned to the Brevard County Jail Complex.

On December 9, 2018, Deputy Mustafa began her shift at 0600 hours, and was assigned to the booking control room.

While in the Booking Control Room Deputy Mustafa stated she observed Inmate Gregory Edwards in booking cell nine (9) exhibiting what appeared to be a medical event. Deputy Mustafa notified Deputy Wagner and Lieutenant Fayson of her observations. Corrections deputies then entered the cell and removed the "spit mask" from Inmate Edwards. Deputy Mustafa advised she then wiped any remaining O.C. spray from his face with a towel. Deputy Mustafa stated Nurse Nadeau came to assist and she then left to retrieve a stretcher from the Medical Ward. Deputy Mustafa stated once she returned to the booking room the decision had already been made to take Inmate Edwards to the Medical Ward while secured in the ERC.

This concluded Deputy Mustafa's involvement with Inmate Gregory Edwards.

Corrections Deputy Regina Ellis - Corporal

On December 9, 2018, at approximately 1933 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy Regina Ellis at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Ellis stated in substance the following:

Deputy Regina Ellis has been employed by the Brevard County Sheriff's Office since January 5, 2004, assigned as a Corporal to the Brevard County Jail Complex.

On December 9, 2018, Deputy Ellis began her shift at 0600 hours, and was assigned to the Medical Ward of the BCJC.

While in the Medical Ward she observed Sergeant Zimmerman, Deputy Hartley, Deputy Turco, and Deputy Tiller bring Gregory Edwards into the medical area secured in the ERC. Deputy Ellis's role was to keep a log of who enters the Medical Ward and at what time they enter. Deputy Ellis stated the BCJC medical staff tended to Inmate Edwards and requested 9-1-1 be activated. Deputy Ellis stated Nurse Ashley Fried instructed

the corrections deputies to remove Inmate Edward from the ERC and to place him on the floor for CPR.

Deputy Ellis stated the parties on scene rotated and provided life saving measures to Inmate Edwards until BCFR arrived.

This concluded Deputy Ellis' involvement with Inmate Gregory Edwards.

Corrections Deputy Adam Hester

On December 9, 2018, at approximately 1939 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy Adam Hester at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Hester stated in substance the following:

Deputy Hester has been employed by the Brevard County Sheriff's Office since October 10, 2016, and is assigned to the Brevard County Jail Complex.

On December 9, 2018; Deputy Hester began his shift at 0600 hours, and was on food movement duties when he heard two calls for assistance over the radio that requested available corrections deputies respond to the booking room.

Deputy Hester stated he did not respond on the first request, but did respond to the second call for assistance. Deputy Hester stated and when he arrived in booking, he observed Inmate Gregory Edwards in an ERC. Deputy Hester stated when entered the holding cell, Nurse Nadeau was providing oxygen to Inmate Edwards. Deputy Hester stated he removed the restraints from Inmate Edwards's legs and observed Inmate Edwards was breathing and his eyelids were fluttering, but there were no other movements were observed. Deputy Hester stated Lieutenant Fayson then made the decision to transport Inmate Edwards to the Medical Ward. Deputy Hester stated once Inmate Edwards left the booking area, he returned directly to his normal assigned duties.

Deputy Hester stated that he delivered restraints to the Medical Ward in case they were needed to transport Inmate Edwards to the hospital, but he did not apply any of the restraints to Inmate Edwards.

This concluded Deputy Hester involvement with Inmate Gregory Edwards.

Corrections Deputy Ryan Hummel

On December 9, 2018, at approximately 1945 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy Ryan Hummel at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Hummel stated in substance the following:

Deputy Ryan Hummel has been employed by the Brevard County Sheriff's Office since September 17, 2018, assigned to the Brevard County Jail Complex.

On December 9, 2018, Deputy Hummel began his shift at 0600 hours, and was assigned to the Medical Unit of the BCJC.

On December 9, 2018, Deputy Hummel was stationed in the Medical Ward when he heard a call for assistance. Due to being on a direct watch of another Inmate, Deputy Hummel did not leave to assist. Deputy Hummel stated he saw Inmate Gregory Edwards enter the Medical Ward. Deputy Hummel stated it appeared Inmate Edwards was breathing and had an oxygen mask on. Deputy Hummel stated Inmate Edwards was then moved to the ERC to the floor where CPR and the AED were applied. Deputy Hummel stated Inmate Edwards was later transported by BCFR to RRMC.

This concluded Deputy Hummel's involvement with Inmate Gregory Edwards.

Corrections Deputy Crystal Idleburgh - Corporal

On December 9, 2018, at approximately 1949 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy Crystal Idleburgh at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Idleburgh stated in substance the following:

Deputy Crystal Idleburgh has been employed by the Brevard County Sheriff's Office since February 25, 2008, assigned as a Corporal to the Brevard County Jail Complex.

On December 9, 2018, Deputy Idleburgh began her shift at 0600 hours, and was assigned to the Booking area of the BCJC.

Deputy Idleburgh stated that during the course of her duties she was in the Releasing section of the Booking Room when she observed Inmate Gregory Edwards enter the jail. Deputy Idleburgh stated she then left the Booking area to complete an assignment and when she returned to the booking area, Inmate Edwards was secured in an ERC. Deputy Idleburgh stated that Inmate Edwards's eyes were closed, and the nurse was being summoned to evaluate him. Deputy Idleburgh stated several corrections deputies were releasing ERC restraints. Deputy Idleburgh stated she observed Nurse Nadeau apply a sternum rub to Inmate Edwards and then placed an oxygen mask on him. Deputy Idleburgh advised Inmate Edwards was then taken to the Medical Ward while still secured in the ERC.

This concluded Deputy Idleburgh's involvement with Inmate Gregory Edwards.

Corrections Deputy Stephanie Smith

On December 9, 2018, at approximately 2017 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Corrections Deputy Stephanie Smith at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Corrections Deputy Smith stated in substance the following:

Deputy Stephanie Smith has been employed by the Brevard County Sheriff's Office since July 9, 2012. Deputy Smith was initially hired as a Corrections Technician, becoming certified as a Corrections Deputy on May 5, 2013, where she is assigned to the Brevard County Jail Complex.

On December 9, 2018, Deputy Smith began her shift at 0600 hours, and was assigned to the Booking area.

During the course of her shift, Deputy Smith entered the Booking area and observed Inmate Gregory Edwards on the ground, "flailing his body," and fighting with corrections deputies. Deputy Smith observed Inmate Edwards was then handcuffed and placed into an ERC. Corrections Deputy Smith left the booking area after Gregory Edwards was placed into the ERC.

This concluded Deputy Smith's involvement with Inmate Gregory Edwards.

Booking Technician Sarah Papesh

On December 9, 2018, at approximately 1846 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Booking Technician Sarah Papesh at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Booking Technician Papesh stated in substance the following:

Sarah Papesh has been employed by the Brevard County Sheriff's Office since October 16, 2017, and is assigned as a Booking Technician at the Brevard County Jail Complex.

On December 9, 2018, Booking Technician Papesh began her shift at 0600 hours, and was assigned to the Booking Data Collection room. Booking Technician Papesh observed Inmate Gregory Edwards banging on the windows of his holding cell. Booking Technician Papesh stated [REDACTED] addressed Inmate Edwards to ascertain if he was alright at which time Inmate Edwards confirmed he was. Booking Technician Papesh advised [REDACTED] then returned to his normal duties. Booking Technician Papesh stated a short time later she heard Inmate Edwards yelling, but could not see what was going on. Booking Technician Papesh stated she heard what she believed was [REDACTED] yelling as if he was hurt, but she could not recall what he was specifically yelling. Due to Booking Technician Papesh's location in the Booking Data Collection room, she could not witness the interaction.

This concluded Booking Technician Papesh's involvement with Inmate Gregory Edwards.

Booking Technician Jeanette Donaho

On December 9, 2018, at approximately 1841 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Booking Technician Jeanette Donaho at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Booking Technician Jeanette Donaho stated in substance the following:

Jeanette Donaho has been employed by the Brevard County Sheriff's Office since March 1, 2004, and is assigned as a Booking Technician at the Brevard County Jail Complex.

On December 9, 2018, Booking Technician Donaho began her shift at 0600 hours, and was assigned to the Booking Control room.

During the course of her duties, Booking Technician Donaho observed Corrections [REDACTED] remove Inmate Gregory Edwards from the holding cell for what she believes was to take his booking photograph. Booking Technician Donaho stated she then observed employees running towards [REDACTED] and Inmate Edwards. Booking Technician Donaho was advised to send out an all help available page for the incident. Booking Technician Donaho stated she did not observe the initial interaction between [REDACTED] and Inmate Edwards, but did see them on the ground as she called for assistance.

Booking Technician Donaho stated once Inmate Edwards was restrained in the ERC, he was placed in holding cell nine (9). Booking Technician Donaho stated she heard Inmate Edwards making screaming type noises while in the holding cell. Booking Technician Donaho stated the next time she observed Inmate Edwards, he was being removed from the holding cell so LPN Nadeau could provide Oxygen to him. Booking Technician Donaho advised Inmate Edwards was then transported to the Medical Ward.

This concluded Booking Technician Donaho's involvement with Inmate Gregory Edwards.

Booking Technician Denise D'Agostino

On December 9, 2018, at approximately 1850 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with Booking Technician Denise D'Agostino at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Booking Technician D'Agostino stated in substance the following:

Denise D'Agostino has been employed by the Brevard County Sheriff's Office since July 30, 2007, and is assigned as a Booking Technician to the Brevard County Jail Complex.

On December 9, 2018, Booking Technician D'Agostino began her shift at 0600 hours, and was assigned to the Booking area.

During the course of her shift, Booking Technician D'Agostino walked into the Booking area and heard yelling. Booking Technician D'Agostino stated she observed an Inmate and corrections deputies in a struggle on the ground. Booking Technician D'Agostino did not witness corrections deputies secure Gregory Edwards and had no further involvement.

This concluded Booking Technician D'Agostino's involvement with Inmate Gregory Edwards.

Deborah Nadeau – Licensed Practical Nurse - Armor Correctional

On December 13, 2018, at approximately 1221 hours, I conducted a voluntary, sworn, audio-recorded interview with Nurse Deborah Nadeau at the Brevard County Jail Complex, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Nurse Nadeau stated in substance the following:

Nurse Nadeau has been employed by Armor Correctional as an LPN for the past nine years. Nurse Nadeau stated she has been assigned to the Brevard County Jail Complex for the entire time period.

On December 9, 2018, Nurse Nadeau began her shift at 0600 hours, and was assigned to the Booking area.

During the course of her shift, Nurse Nadeau was told that an outside agency was bringing in an arrestee, later identified as Inmate Gregory Edwards who was combative, had PTSD and had not been taking his prescribed medications.

Nurse Nadeau advised she did not see Gregory Edwards arrive in Booking, however, she did see him banging on the glass of holding cell number seven (7) where a corrections deputy addressed him through the holding cell window. When Inmate Edwards continued to bang on the cell window, the corrections deputy readdressed Inmate Edwards and told him he was going to process him. The corrections deputy then led Inmate Edwards out of cell number seven (7) and Inmate Edwards appeared calm. When the corrections deputy told Inmate Edwards to move towards the camera for photographs and fingerprints, Inmate Edwards appeared to refuse. Nurse Nadeau stated the corrections deputy then asked Inmate Edwards to go to the camera again, but Edwards still refused. Nurse Nadeau stated the corrections deputy then went to reach for Inmate Edwards and Inmate Edwards struck the deputy in the face. Nurse

Nadeau saw the deputy and Inmate immediately fall to the ground where it appeared as if the corrections deputy struck his head on the concrete floor.

Nurse Nadeau stated Inmate Edwards then got on top of the corrections deputy and she called for the assistance of the other corrections deputies who immediately responded. Nurse Nadeau described Inmate Edwards as having "super strength."

Nurse Nadeau stated once Inmate Edwards was restrained, he was placed in the ERC. Nurse Nadeau stated she did not medically assess Inmate Edwards at that time because he was combative and screaming. Nurse Nadeau stated she was directed by BCJC personnel to allow Inmate Edwards to calm down before she medically evaluated him.

Nurse Nadeau stated approximately ten to fifteen minutes later she heard Inmate Edwards abruptly yell and then stop. Nurse Nadeau and corrections deputies immediately responded to Inmate Edwards's holding cell. Nurse Nadeau stated Inmate Edwards' eyes were open, he appeared lethargic and had no movement. Nurse Nadeau stated a corrections deputy then removed the "spit mask" from him and she applied a sternum rub, which did not elicit a response from Inmate Edwards. Nurse Nadeau then went to her office and obtained an oxygen mask, which she placed on Inmate Edwards. Nurse Nadeau stated Inmate Edwards' pulse was [REDACTED] and his oxygen level was [REDACTED]. Nurse Nadeau stated he still wasn't acting what she described as normal and he was exhibiting signs of a possible seizure. Nurse Nadeau stated while providing oxygen to Inmate Edwards he did blink his eyes and his chest was moving, but he did not respond verbally. Nurse Nadeau stated she then made the decision to have Inmate Edwards taken to the Medical Ward while secured in the ERC. Upon arrival at the Medical Ward, other medical staff assumed care for Inmate Edwards.

On March 11, 2019, at approximately 1248 hours, I conducted a voluntary, sworn, audio-recorded interview with Nurse Deborah Nadeau at the Brevard County Jail Complex, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Nurse Nadeau stated in substance the following:

Nurse Nadeau advised she remembered the incident that took place at the BCJC on December 9, 2018, involving inmate Gregory Edwards. Nurse Nadeau advised prior to Gregory Edwards arriving at the BCJC, a booking officer advised, "They had a combative coming in." Nurse Nadeau did not remember who made the statement.

Nadeau saw the deputy and Inmate immediately fall to the ground where it appeared as if the corrections deputy struck his head on the concrete floor.

Nurse Nadeau stated Inmate Edwards then got on top of the corrections deputy and she called for the assistance of the other corrections deputies who immediately responded. Nurse Nadeau described Inmate Edwards as having "super strength."

Nurse Nadeau stated once Inmate Edwards was restrained, he was placed in the ERC. Nurse Nadeau stated she did not medically assess Inmate Edwards at that time because he was combative and screaming. Nurse Nadeau stated she was directed by BCJC personnel to allow Inmate Edwards to calm down before she medically evaluated him.

Nurse Nadeau stated approximately ten to fifteen minutes later she heard Inmate Edwards abruptly yell and then stop. Nurse Nadeau and corrections deputies immediately responded to Inmate Edwards's holding cell. Nurse Nadeau stated Inmate Edwards' eyes were open, he appeared lethargic and had no movement. Nurse Nadeau stated a corrections deputy then removed the "spit mask" from him and she applied a sternum rub, which did not elicit a response from Inmate Edwards. Nurse Nadeau then went to her office and obtained an oxygen mask, which she placed on Inmate Edwards. Nurse Nadeau stated Inmate Edwards' pulse was 64 and his oxygen level was 98. Nurse Nadeau stated she then made the decision to have Inmate Edwards taken to the Medical Ward while secured in the ERC. On March 11, 2019, at approximately 1248 hours, I conducted a voluntary, sworn, audio-recorded interview with Nurse Deborah Nadeau at the Brevard County Jail Complex, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Nurse Nadeau stated in substance the following:

Nurse Nadeau advised she remembered the incident that took place at the BCJC on December 9, 2018, involving inmate Gregory Edwards. Nurse Nadeau advised prior to Gregory Edwards arriving at the BCJC, a booking officer advised, "They had a combative coming in." Nurse Nadeau did not remember who made the statement.

Nurse Nadeau stated that [REDACTED] was the deputy who addressed Inmate Edwards banging on the glass of holding cell number seven (7.) Nurse Nadeau reported [REDACTED] then asked her if she was ready to screen Inmate Edwards at which Nurse Nadeau agreed. When [REDACTED] proceeded to retrieve Inmate Edwards for processing, he was still banging on cell window. [REDACTED] addressed Inmate Edwards and told him he was going to process him and led Inmate Edwards out of cell number seven (7). Nurse Nadeau advised that Inmate Edwards appeared calm. Nurse Nadeau stated that [REDACTED] told Inmate Edwards to move towards the camera for photographs and fingerprints where it appeared that Inmate Edwards refused. Nurse Nadeau stated [REDACTED] then asked Inmate Edwards to go to the camera again, but Edwards still refused. Nurse Nadeau stated [REDACTED] then went to reach for Inmate Edwards and Inmate Edwards struck the deputy in the face. Nurse Nadeau saw [REDACTED] and Inmate Edwards immediately fall to the ground where it appeared as if [REDACTED] struck his head on the concrete floor.

Nurse Nadeau stated that when Inmate Edwards got on top of [REDACTED], she called for the assistance of Deputy Wagner who immediately responded.

Nurse Nadeau stated she remained in her office during the entire incident, which she observed through her glass window. Nurse Nadeau stated she did not medically assess Inmate Edwards because it was not safe. Nurse Nadeau reported she did not medically assess Inmate Edwards until he was secured in the ERC and placed into holding cell number nine (9) with a spit mask on and had stopped yelling.

According to the BCJC video surveillance, the first time Nurse Nadeau tends to Gregory Edwards is at approximately 14:26:25 hours. Nurse Nadeau also advised a Correctional Deputy never told her not to medically assess Gregory Edwards. According to Nurse Nadeau, there is a rule that she is not to go out until the deputies tell her that it is safe. Therefore, Nurse Nadeau did not medically assess Gregory Edwards until an "unknown corrections deputy" requested her assistance, deeming the area safe.

Ashley Freid - Charge Nurse - Armor Correctional

On December 9, 2018, at approximately 2001 hours, I conducted a voluntary, sworn, audio-recorded interview with Charge Nurse Ashley Freid at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Nurse Freid stated in substance the following:

Nurse Freid is employed by Armor Correctional and is currently assigned as the Charge Nurse in the Brevard County Jail Complex Medical Ward.

On December 9, 2018, Nurse Freid heard a call over the radio where all available units were needed in the Booking area. Nurse Freid called the Booking nurse, LPN Nadeau, who advised an Inmate arrived, was combative, "and took down one of the officers."

Nurse Freid stated that approximately thirty minutes later a call came in requesting the medical staff respond to the Booking area with a stretcher. Nurse Freid immediately ordered two of her nurses to respond to Booking with a stretcher.

Nurse Freid stated corrections deputies then arrived at the Medical Ward with Inmate Gregory Edwards who was secured in an ERC. Nurse Freid described Inmate Edwards as unresponsive, his eyes were open, his color was an ashen, he had some blood coming from his nose and his breathing was described as "almost non-existent." Nurse Freid stated she directed 9-1-1 be initiated and one of her nurses to take Inmate Edwards' vitals, where it was discovered Inmate Edwards was not breathing. Nurse Freid directed the corrections deputies to remove Inmate Edwards from the ERC and place him on the ground so CPR could be initiated. Nurse Freid stated during the CPR process she administered a dose of Narcan to Inmate Edwards, which had no visible results. Nurse Freid also stated an AED was applied to Edwards, which did not advise to shock, and that Inmate Edwards' oxygen level was [REDACTED]. Nurse Freid advised CPR was continued by Jail staff until the arrival of BCFR.

The only visible injuries Nurse Freid observed on Inmate Edwards' was his right wrist area, consistent with the placement of handcuffs and/or restraints.

This concluded Ms. Freid's involvement with Inmate Gregory Edwards.

Ayana Robinson - Licensed Practical Nurse - Armor Correctional

On December 9, 2018, at approximately 1953 hours, I conducted a voluntary, sworn, audio-recorded interview with Nurse Ayana Robinson at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida. LPN Robinson stated in substance the following:

Nurse Robinson is employed by Armor Correctional as a LPN and is currently assigned to the Brevard County Jail Complex Medical Ward.

On December 9, 2018, Nurse Robinson heard a radio call that requested all available personnel to the Booking area. Nurse Robinson stated she and Nurse Yolanda Jones responded because they thought that request was for medical personnel as well. When they arrived at Booking, they observed Inmate Edwards in an ERC, shaking and trying to get out with a "spit mask" on. Nurse Robinson and Nurse Jones left the booking area and returned to the Medical Ward.

Approximately thirty minutes later, Nurse Robinson heard another radio call that requested all available personnel respond to the Booking area, and that a stretcher be brought to Booking as well. Nurse Robinson advised that she and Nurse Jones responded back to the Booking with a stretcher.

Once in Booking, Nurse Robinson observed Inmate Edwards in a holding cell surrounded by corrections deputies and Nurse Nadeau. Corrections deputies began transporting Inmate Edwards to the Medical Ward secured in the ERC. Both Nurse

Nurse Freid stated that approximately thirty minutes later a call came in requesting the medical staff respond to the Booking area with a stretcher. Nurse Freid immediately ordered two of her nurses to respond to Booking with a stretcher.

Nurse Freid stated corrections deputies then arrived at the Medical Ward with Inmate Gregory Edwards who was secured in an ERC. Nurse Freid described Inmate Edwards as unresponsive, his eyes were open, his color was an ashen, he had some blood coming from his nose and his breathing was described as "almost non-existent." Nurse Freid stated she directed 9-1-1 be initiated and one of her nurses to take Inmate Edwards' vitals, where it was discovered Inmate Edwards was not breathing. Nurse Freid directed the corrections deputies to remove Inmate Edwards from the ERC and place him on the ground so CPR could be initiated. Nurse Freid stated during the CPR process she administered a dose of Narcan to Inmate Edwards, which had no visible results. Nurse Freid also stated an AED was applied to Edwards, which did not advise to shock, and that Inmate Edwards' oxygen level was 37%. Nurse Freid advised CPR was continued by Jail staff until the arrival of BCFR.

The only visible injuries Nurse Freid observed on Inmate Edwards' was his right wrist area, consistent with the placement of handcuffs and/or restraints.

This concluded Ms. Freid's involvement with Inmate Gregory Edwards.

Ayana Robinson - Licensed Practical Nurse - Armor Correctional

On December 9, 2018, at approximately 1953 hours, I conducted a voluntary, sworn, audio-recorded interview with Nurse Ayana Robinson at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida. LPN Robinson stated in substance the following:

Nurse Robinson is employed by Armor Correctional as a LPN and is currently assigned to the Brevard County Jail Complex Medical Ward.

On December 9, 2018, Nurse Robinson heard a radio call that requested all available personnel to the Booking area. Nurse Robinson stated she and Nurse Yolanda Jones responded because they thought that request was for medical personnel as well. When they arrived at Booking, they observed Inmate Edwards in an ERC, shaking and trying to get out with a "spit mask" on. Nurse Robinson and Nurse Jones left the booking area and returned to the Medical Ward.

Approximately thirty minutes later, Nurse Robinson heard another radio call that requested all available personnel respond to the Booking area, and that a stretcher be brought to Booking as well. Nurse Robinson advised that she and Nurse Jones responded back to the Booking with a stretcher.

Once in Booking, Nurse Robinson observed Inmate Edwards in a holding cell surrounded by corrections deputies and Nurse Nadeau. Corrections deputies began transporting Inmate Edwards to the Medical Ward secured in the ERC. Both Nurse

Robinson and Nurse Jones followed the corrections deputies as they rolled Inmate Edwards to the Medical Ward in the ERC.

Once at the Medical Ward, Nurse Robinson and Nurse Jones advised Nurse Freid of Inmate Edwards' status. Nurse Robinson stated that 9-1-1 was activated and CPR was initiated on Inmate Edwards. Nurse Robinson applied the oxygen/pulse monitor to Inmate Edwards' finger and stood by in case she was needed to assist with CPR. Nurse Robinson described Inmate Edwards' as breathing with his eyes open, but unresponsive.

This concluded Nurse Robinson's involvement with Inmate Edwards.

Yolanda Jones – Licensed Practical Nurse - Armor Correctional

On December 9, 2018, at approximately 2012 hours, I conducted a voluntary, sworn, audio-recorded interview with Nurse Yolanda Jones at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Nurse Jones stated in substance the following:

Nurse Jones is employed by Armor Correctional as a LPN and is currently assigned to the Brevard County Jail Complex Medical Ward.

On December 9, 2018, Nurse Jones heard a radio call that requested all available personnel to the Booking area. Nurse Jones and Nurse Robinson both responded to provide assistance.

Once in Booking they observed Inmate Edwards in an ERC. Nurse Jones advised that she and Nurse Robinson's assistance was not needed, so they returned to the Medical Ward.

Nurse Jones stated that approximately thirty minutes later corrections deputies requested all available personnel respond back to the Booking area and they also requested a stretcher. Nurse Jones and Nurse Robinson both responded to back Booking with a stretcher.

Once in Booking, Nurse Jones observed Inmate Edwards in a holding cell secured in the ERC. Nurse Jones advised Inmate Edwards was surrounded by corrections deputies and Nurse Nadeau and appeared to be unresponsive. Nurse Jones stated Inmate Edwards' breathing appeared shallow, but Nurse Nadeau was providing him with oxygen through an oxygen mask. Nurse Jones advised a decision was made to push Gregory Edwards to the Medical Ward while he was still secured in the ERC. Nurse Jones stated she and Nurse Robinson followed the corrections deputies and Inmate Edwards back to the Medical Ward.

Once at the Medical Ward, Nurse Jones informed Nurse Freid of Inmate Edwards's medical condition at which time Nurse Freid initiated 9-1-1 and CPR was initiated. Nurse Jones stated she assisted in performing CPR on Inmate Edwards until Sergeant Zimmerman relieved her. Nurse Jones was asked by Nurse Freid to check Inmate Edwards's glucose, which was [REDACTED]. After checking the glucose, Nurse Jones continued to assist with rescue breaths on Inmate Edwards until BCFR personnel arrived and assumed medical care.

Nurse Jones stated she applied the AED to Inmate Edwards and while doing so, did not observe any visible injuries to Gregory Edwards' chest area. Nurse Jones advised she observed raised areas of redness and/or bruising on Gregory Edwards' facial area and some blood inside his nose. Nurse Jones also observed marks on Gregory Edwards' wrists, which were consistent with handcuff marks.

This concluded Nurse Jones' involvement with Inmate Gregory Edwards.

Hany Abdeohady – Licensed Practical Nurse - Armor Correctional

On December 9, 2018, at approximately 1935 hours, I conducted a voluntary, sworn, audio-recorded interview with Nurse Hany Abdeohady at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Nurse Abdeohady stated in substance the following:

Nurse Abdeohady is employed by Armor Correctional as a LPN and is currently assigned to the Brevard County Jail Complex Medical Ward.

On December 9, 2018, Nurse Abdeohady observed Inmate Gregory Edwards being brought into the Medical Ward. Nurse Abdeohady stated he observed the actions of Nurse Freid, Nurse Jones and Nurse Robinson. Nurse Abdeohady stated he only observed the actions of the nurses, which as described were consistent with the statements of Nurse Freid, Nurse Jones and Nurse Robinson. Nurse Abdeohady stated he never had any personal involvement with the medical care of Inmate Edwards.

This concluded Nurse Abdeohady's involvement with Inmate Gregory Edwards.

Once at the Medical Ward, Nurse Jones informed Nurse Freid of Inmate Edwards's medical condition at which time Nurse Freid initiated 9-1-1 and CPR was initiated. Nurse Jones stated she assisted in performing CPR on Inmate Edwards until Sergeant Zimmerman relieved her. Nurse Jones was asked by Nurse Freid to check Inmate Edwards's glucose, which was 95. After checking the glucose, Nurse Jones continued to assist with rescue breaths on Inmate Edwards until BCFR personnel arrived and assumed medical care.

Nurse Jones stated she applied the AED to Inmate Edwards and while doing so, did not observe any visible injuries to Gregory Edwards' chest area. Nurse Jones advised she observed raised areas of redness and/or bruising on Gregory Edwards' facial area and some blood inside his nose. Nurse Jones also observed marks on Gregory Edwards' wrists, which were consistent with handcuff marks.

This concluded Nurse Jones' involvement with Inmate Gregory Edwards.

Hany Abdeohady – Licensed Practical Nurse - Armor Correctional

On December 9, 2018, at approximately 1935 hours, I conducted a voluntary, sworn, audio-recorded interview with Nurse Hany Abdeohady at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Nurse Abdeohady stated in substance the following:

Nurse Abdeohady is employed by Armor Correctional as a LPN and is currently assigned to the Brevard County Jail Complex Medical Ward.

On December 9, 2018, Nurse Abdeohady observed Inmate Gregory Edwards being brought into the Medical Ward. Nurse Abdeohady stated he observed the actions of Nurse Freid, Nurse Jones and Nurse Robinson. Nurse Abdeohady stated he only observed the actions of the nurses, which as described were consistent with the statements of Nurse Freid, Nurse Jones and Nurse Robinson. Nurse Abdeohady stated he never had any personal involvement with the medical care of Inmate Edwards.

This concluded Nurse Abdeohady's involvement with Inmate Gregory Edwards.

Kenneth Bloodworth – BCJC Inmate

On December 9, 2018, at approximately 2122 hours, Agent Urbanetz and Agent Simock conducted a voluntary sworn, audio-recorded interview with Inmate Kenneth Bloodworth at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Inmate Bloodworth stated in substance the following:

On December 09, 2018, Inmate Bloodworth was booked into custody at the Brevard County Jail Complex. Inmate Bloodworth explained he was in a Booking holding cell at approximately 1300 hours. While in the holding cell, Inmate Bloodworth observed another Inmate later identified as Inmate Gregory Edwards. Inmate Bloodworth stated Inmate Edwards was observed pounding on the holding cell wall in one of the adjoining holding cells and continued to bang his fists against the cell wall and glass.

Inmate Bloodworth stated Inmate Edwards was then removed from the holding cell to have his picture taken and did not follow the directions of the corrections deputy. Inmate Bloodworth described Inmate Edwards as having a, "crazy look in his eyes." Inmate Bloodworth advised Inmate Edwards looked like he wanted to fight.

According to Inmate Bloodworth, Inmate Edwards swung at and struck the "bald headed corrections deputy" (Corrections [REDACTED]) and positioned himself on top of [REDACTED]. Inmate Bloodworth stated Inmate Edwards looked "like a caged animal," and continued to fight with the corrections deputies. Inmate Bloodworth advised it appeared as though Inmate Edwards was under the influence of drugs, because he continued to fight the Deputies as they tried to restrain him.

Inmate Bloodworth stated the deputies then "pepper sprayed" Inmate Edwards, which did not stop him from being combative. Inmate Bloodworth stated a female deputy (Deputy Allison Blazewicz) "tased" Inmate Edwards and he continued to resist the deputies. Inmate Bloodworth stated Inmate Edwards would not provide his hands to the deputies as instructed, but was eventually restrained in an ERC. Inmate Bloodworth advised Inmate Edwards continued to yell and fight and was then moved into another neighboring holding cell where Inmate Bloodworth could see him. Inmate Bloodworth advised Inmate Edwards continued to yell and was forcefully trying to get out of the ERC. Inmate Bloodworth advised Inmate Edwards stopped yelling, his eyes rolled to the back of his head and he went unresponsive. Inmate Bloodworth advised the corrections deputies then provided medical care to Inmate Edwards.

Inmate Bloodworth reiterated that Inmate Edwards initiated the incident, pounded on the holding cell walls, failed to follow directions and hit the corrections deputy. According to Mr. Bloodworth, the corrections deputy was nice and polite to Inmate Edwards even as Inmate Edwards was acting up.

Anthony Berry - BCJC Inmate

On December 9, 2018, at approximately 2139 hours, Agent Urbanetz and Agent Simock conducted a voluntary sworn, audio-recorded interview with Inmate Anthony Berry at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Inmate Berry stated in substance the following:

On December 09, 2018, Inmate Berry was a trustee assigned to the Booking area of the Brevard County Jail Complex for cleaning duties.

While in the Booking area he observed an Inmate, later identified as Gregory Edwards, banging on the glass and door of a holding cell. Inmate Edwards was then taken out of the holding cell and was walked over to the photograph station where he began to yell and scream at a Corporal with a "bald head," later identified as [REDACTED]. Inmate Berry advised that Inmate Edwards yelled that he wasn't going to take a picture, and thought Inmate Edwards, "had to be on something." Inmate Berry then heard [REDACTED] say, "don't do it."

Inmate Berry stated he was moved to the supply room closet in the Booking room by a corrections deputy, where he could only hear the commotion. Inmate Berry described the sounds, advising they sounded like the frantic shuffle of feet. Inmate Berry stated he did not see any interaction.

Gregory Raymond - BCJC Inmate

On December 9, 2018, at approximately 2155 hours, Agent Urbanetz and Agent Simock conducted a voluntary sworn, audio-recorded interview with Inmate Gregory Raymond, at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Inmate Raymond stated in substance the following:

On December 9, 2018, Inmate Raymond stated he was in the Booking room of the Brevard County Jail and observed a light skin black male, later identified as Inmate Gregory Edwards. Inmate Raymond stated Inmate Edwards was wearing a red jump suit in a holding cell. Inmate Raymond advised Inmate Edwards was eating a sandwich, but then he started to bang on the holding cell glass window.

Inmate Raymond stated [REDACTED] removed Inmate Edwards from the holding cell and escorted him in the direction he wanted Inmate Edwards to go. Inmate Raymond stated he did not observe the beginning of the confrontation, but believed Inmate Edwards may have hit Corrections [REDACTED] first. Mr. Raymond stated he then observed Inmate Edwards on top of [REDACTED].

Inmate Raymond then observed several deputies enter the Booking room attempting to get Inmate Edwards off of [REDACTED], but Inmate Edwards continued to resist and

fight the deputies. Inmate Raymond stated corrections deputies "pepper sprayed" Inmate Edwards and when Inmate Edwards still refused to comply, corrections deputies deployed a Taser on Inmate Edwards.

Inmate Raymond stated he observed that the corrections deputies were eventually able to restrain Inmate Edwards and then placed him in an ERC. Inmate Raymond stated Inmate Edwards grunted and yelled and tried to break out of the chair. According to Inmate Raymond, when Inmate Edwards stopped moving in the chair, the deputies rendered medical aid.

Kristopher Moffitt - BCJC Inmate

On December 9, 2018, at approximately 2211 hours, Agent Urbanetz and Agent Simock conducted a voluntary sworn, audio-recorded interview with Inmate Kristopher Moffitt at the BCJC, located at 860 Camp Road, Cocoa, Brevard County, Florida.

Inmate Moffitt stated in substance the following:

Inmate Moffitt stated he was utilizing the Booking room telephone when he saw a black male Inmate, later identified as Gregory Edwards being loud and disruptive. Inmate Moffitt advised Inmate Edwards was taken out of the holding cell and he continued to be "combative" and yelled. Inmate Moffitt stated Inmate Edwards then got into a fight with a corrections deputy and other deputies arrived to help. Inmate Moffitt advised Inmate Edwards continued to scream even after he was secured in an ERC.

According to Inmate Moffitt, it appeared Inmate Edwards passed out in the chair and deputies provided medical care to him.

Attached as enclosure to this report is a copy of Inmate Moffitt's audio recorded jail telephone call, which captured portions of the incident between Inmate Gregory Edwards and the corrections deputies.

Charlene Raisman

On February 1, 2019, at approximately 0818 hours, I received a telephone call from Ms. Charlene Raisman. During a voluntary, sworn, audio-recorded interview, Ms. Raisman stated the following in substance:

On December 9, 2018, while leaving the parking lot of Walmart, located at 845 NE Palm Bay Road, Palm Bay, Florida, Ms. Raisman observed two white males had a black male pinned on the ground. Ms. Raisman initially believed someone may have been suffering from a medical issue, but as she approached one of the white males yelled at her to call 9-1-1. [REDACTED] called 9-1-1 and waited for WMPD and BCFR to arrive. While waiting for first responders, Ms. Raisman realized this was not a medical issue, but that a battery had occurred because she observed an older male with a scratch on his forehead and a torn shirt standing nearby. Ms. Raisman stated the black male being

Inmate Moffitt stated in substance the following:

Inmate Moffitt stated he was utilizing the Booking room telephone when he saw a black male Inmate, later identified as Gregory Edwards being loud and disruptive. Inmate Moffitt advised Inmate Edwards was taken out of the holding cell and he continued to be "combative" and yelled. Inmate Moffitt stated Inmate Edwards then got into a fight with a corrections deputy and other deputies arrived to help. Inmate Moffitt advised Inmate Edwards continued to scream even after he was secured in an ERC.

According to Inmate Moffitt, it appeared Inmate Edwards passed out in the chair and deputies provided medical care to him.

Attached as enclosure to this report is a copy of Inmate Moffitt's audio recorded jail telephone call, which captured portions of the incident between Inmate Gregory Edwards and the corrections deputies.

Charlene Raisman

On February 1, 2019, at approximately 0818 hours, I received a telephone call from Ms. Charlene Raisman. During a voluntary, sworn, audio-recorded interview, Ms. Raisman stated the following in substance:

On December 9, 2018, while leaving the parking lot of Walmart, located at 845 NE Palm Bay Road, Palm Bay, Florida, Ms. Raisman observed two white males had a black male pinned on the ground. Ms. Raisman initially believed someone may have been suffering from a medical issue, but as she approached one of the white males yelled at her to call 9-1-1. Ms. Raisman then called 9-1-1 and waited for WMPD and BCFR to arrive. While waiting for first responders, Ms. Raisman realized this was not a medical issue, but that a battery had occurred because she observed an older male with a scratch on his forehead and a torn shirt standing nearby. Ms. Raisman stated the black male being

held on the ground was struggling to get away from the two males pinning him down. Ms. Raisman stated the black male was also screaming, "You're not going to take me, you're not going to take me." Once Law Enforcement arrived, the black male became more belligerent and continued to struggle. During the incident, Ms. Raisman observed who she thought to be the black male's girlfriend, or wife, telling him to calm down. Ms. Raisman stated she was upset at the girlfriend/wife, who appeared pregnant, because she allowed her toddler child to watch the incident. The toddler kept asking, "What's wrong with daddy," and this was disturbing to Ms. Raisman. This concluded Ms. Raisman's involvement.

On February 1, 2019, Ms. Raisman contacted me again, and stated she had remembered she took a short video clip of the incident. Ms. Raisman provided me with the video clip, which is attached to this report as an evidentiary exhibit.

BCFR Firefighter/Paramedic Corbin Smith - Station 29

On December 12, 2018, at approximately 0843 hours, Agent Ethan Kersey conducted a voluntary, sworn, audio-recorded interview with Fire-medical Corbin Smith at Brevard County Fire Rescue, Station 29, located at 3970 Canaveral Groves Boulevard, Cocoa, Brevard County, Florida.

Firefighter/Paramedic Corbin Smith stated in substance the following:

Fire-medical Smith is employed by BCFR and has been for the past two and one half years as a Firefighter/Paramedic.

On December 9th, 2018, Fire-medical Smith was assigned to Station 29, who was dispatched to the BCJC in reference to a "Battery" involving an inmate and corrections deputy. While enroute, it was changed to a "Code 99." Fire-medical Smith described a "Code 99" as a deceased person.

Upon arrival at the BCJC, BCFR personnel gathered their lifesaving equipment and were led into the Jail's Medical Ward. Once inside they observed Patient Gregory Edwards laying on medical backboard on the floor. Fire-medical Smith stated he was informed Patient Edwards had no pulse and was not breathing. Fire-medical Smith observed the Jail staff performing CPR and they had also connected an automated external defibrillator (AED) to Patient Edwards.

Fire-medical Smith stated BCFR personnel then removed the BCJC AED and replaced it with a BCFR Life Pak AED, assuming CPR. Fire-medical Smith stated he began initializing an IV while Fire-medical Ricks began chest compressions, Fire-medical Steven Hughes intubated, and Lt. Sherbrook gathered the Patient Edwards personal information.

Fire-medical Smith advised that after approximately ten to fifteen minutes of performing CPR they were able to obtain pulse readings from Patient Edwards, who was then

transported, via ambulance, to RRMCC. Fire-medical Smith advised he rode in the back of the ambulance and prepared the medications that were to be administered to Patient Edwards by Fire-medical Jason Webster. Fire-medical Smith stated once they completed the transport to the hospital, the BCFR staff returned to Station 29.

Fire-medical Smith added that while on scene at the BCJC he overheard patient Edwards had been in an altercation with an unknown officer in Booking, where Gregory Edwards went unconscious and was brought to the Medical Ward.

BCFR Firefighter/Paramedic Steven Hughes - Station 29

On December 12, 2018, at approximately 0902 hours, Agent Ethan Kersey conducted a voluntary, sworn, audio-recorded interview with Firefighter/Paramedic Steven Hughes at Brevard County Fire Rescue, Station 29, located at 3970 Canaveral Groves Boulevard, Cocoa, Brevard County, Florida. Firefighter/Paramedic Hughes stated in substance the following:

Fire-medical Steven Hughes is employed by BCFR and has been for the past sixteen years.

On December 9th, 2018, Fire-medical Hughes was assigned to Station 29, who was dispatched to the BCJC in reference to a, "Battery," involving an Inmate.

Upon arrival to the BCJC, BCFR was met by multiple corrections deputies. Fire-medical Hughes stated they gathered their lifesaving equipment and were led into the Jail's Medical Ward. Fire-medical Hughes recalled seeing a male, later identified as Patient Gregory Edwards in a supine position on a backboard, which was on the floor. Fire-medical Hughes stated he observed BCJC medical staff administering CPR to Patient Edwards. Fire-medical Hughes also observed BCJC medical staff had connected an AED to Patient Edwards. Fire-medical Hughes advised the BCJC's AED was removed from and BCFR replaced it with their AED.

Fire-medical Hughes stated his role was to check on the patient's airway and breathing. Fire-medical Hughes advised patient Edwards had no pulse and was not breathing. After approximately twenty minutes of CPR, Patient Edwards was transported to RRMCC.

Fire-medical Hughes explained Gregory Edwards was "PEA," (Pulseless Electrical Activity), when he was transported to the hospital. Fire-medical Hughes did not travel to the hospital, returning to Station 29.

BCFR Firefighter/Paramedic George Ricks - Station 29

On December 12, 2018, at approximately 0835 hours, Agent Ethan Kersey conducted a voluntary, sworn, audio-recorded interview with Firefighter/Paramedic George Ricks at Brevard County Fire Rescue Station 29, located at 3970 Canaveral Groves Boulevard, Cocoa, Brevard County, Florida.

Fire-medical George Ricks stated in substance the following:

Fire-medical Ricks is employed by BCFR and has been for the past three years as a Firefighter/Paramedic.

On December 9th, 2018, Fire-medical Ricks was assigned to Station 29 who was dispatched to the BCJC in reference to a, "Battery" involving an Inmate.

Upon arrival to the BCJC, BCFR was met by multiple corrections deputies. BCFR gathered their lifesaving equipment and were led into the Jail's Medical Ward.

Once inside the Medical Ward, Fire-medical Ricks observed a male, later identified as Inmate Edwards, laying on his back on a medical backboard on the floor. BCJC medical staff were in the process of providing CPR to Inmate Edwards. Fire-medical Ricks also observed that BCJC medical staff had connected an AED to Inmate Edwards, but Fire-medical Ricks removed the BCJC's AED and connected BCFR's Life Pak AED.

Once the AED was connected to Inmate Edwards, it registered as "asystole" meaning having no pulse. Fire-medical Ricks advised he began chest compressions and after several minutes another BCFR member took over chest compressions. Fire-medical Ricks stated he did not observe any visible injuries to Inmate Edwards.

Fire-medical Ricks stated after approximately fifteen minutes of CPR, Inmate Edwards was transported to RRMC. Fire-medical Ricks advised he drove the ambulance while Fire-medical Jason Webster, Fire-medical Corbin Smith and an unknown corrections deputy rode in the back of the ambulance with Inmate Edwards. Fire-medical Ricks stated once Inmate Edwards was transported to the hospital, BCFR returned to Station 29.

BCFR Firefighter/Paramedic Lieutenant Brian Sherbrook – Station 29

On December 12, 2018, at approximately 0853 hours, Agent Ethan Kersey conducted a voluntary, sworn, audio-recorded interview with Firefighter/Paramedic Lieutenant Brian Sherbrook at Brevard County Fire Rescue Station 29, located at 3970 Canaveral Groves Boulevard, Cocoa, Brevard County, Florida.

Fire-medical Lieutenant Brian Sherbrook stated in substance the following:

Lieutenant Sherbrook is employed by BCFR and has been for the past eighteen years as a Firefighter/Paramedic.

On December 9th, 2018, Lieutenant Sherbrook was assigned to Station 29 who was dispatched to the BCJC.

Upon arrival to the BCJC, BCFR was met by multiple corrections deputies. BCFR gathered their lifesaving equipment and were led into the jail's Medical Ward.

Lieutenant Sherbrook stated he observed a male, Inmate Edwards laying on his back on a medical backboard on the floor. Lieutenant Sherbrook proceeded to gather the patient's personal information and medical status. Lieutenant Sherbrook stated his crew conducted CPR on Inmate Edwards for approximately fifteen minutes and then transported him to RRMC. Lieutenant Sherbrook did not travel to RRMC, returning to Station 29.

BCFR Firefighter/Paramedic Carlos Iriban – Station 83

On December 14, 2018, at approximately 0630 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with BCFR Firefighter/Paramedic Carlos Iriban, at Brevard County Fire Rescue Station 83, located at 5148 Minton Road, Malabar, Brevard County, Florida.

Firefighter/Paramedic Iriban stated in substance the following:

Fire-medical Iriban is employed by BCFR and has been for the past one and one half years.

On December 9, 2018, Fire-medical Iriban was assigned to BCFR Station 83. While on another call for service Fire-medical Iriban was informed they needed to respond to Walmart.

Upon arrival, Fire-medical Iriban stated he observed a lot of people and police officers on scene. Fire-medical Iriban retrieved a stretcher from the ambulance and proceeded to the victim of a battery, later identified as [REDACTED]. [REDACTED] wished for his injuries to be examined, but later refused to be transported to a local hospital. Fire-medical Iriban advised he then returned to the ambulance and awaited further instructions.

While waiting, Fire-medical Iriban observed a male, later identified as Gregory Edwards on the ground, in handcuffs. According to Fire-medical Iriban it appeared Suspect Edwards was resisting because several officers were on top of him attempting to hold him down. Fire-medical Iriban stated Suspect Edwards was then escorted to the police vehicle and placed in the backseat.

Fire-medical Iriban stated he was never asked to medically evaluate Suspect Edwards, nor did he provide any medical assistance.

Fire-medical Iriban stated after the police no longer needed their assistance, they left the area.

BCFR Firefighter/Paramedic Jonathan Weiss - Station 83

On Wednesday, December 19, 2018, at approximately 0634 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with BCFR Firefighter/Paramedic Jonathan Weiss at Brevard County Fire Rescue Station 83, located at 5148 Minton Road, Malabar, Brevard County, Florida.

Fire-medec Weiss stated in substance the following:

Fire-medec Weiss is employed by BCFR and has been for the past fourteen years.

On December 9, 2018, Fire-medec Weiss was assigned to BCFR Station 83 and recalled responding to Walmart reference to a physical altercation.

Upon arrival, Fire-medec Weiss observed one male that appeared to be the victim, later identified as [REDACTED], because his shirt was ripped. Fire-medec Weiss observed another male, later identified as Suspect Edwards on the ground with approximately three to five police officers holding him down. Fire-medec Weiss stated WMPD officers secured Suspect Edwards and informed Fire-medec Weiss they wanted Suspect Edwards medically cleared. While waiting to medically clear Suspect Edwards, WMPD officers cancelled them. Fire-medec Weiss stated that as a result, they never medically cleared Suspect Edwards prior to departing the scene.

BCFR Trainee Laura Clarisse - Station 83

On Friday, December 14, 2018, at approximately 0630 hours, Agent Wendy Wheeler conducted a voluntary, sworn, audio-recorded interview with BCFR Trainee Laura Clarisse at Brevard County Fire Rescue Station 83, located at 5148 Minton Road, Malabar, Brevard County, Florida.

BCFR Trainee Clarisse stated in substance the following:

On December 9, 2018, BCFR Trainee Clarisse was present with BCFR Station 83, when they responded to Walmart.

Upon arrival, BCFR Trainee Clarisse observed a male in handcuffs attempting to get away from the officers. BCFR Trainee Clarisse recalled the male was, "grunting."

BCFR Trainee Clarisse stated BCFR provided on scene medical treatment to the victim, [REDACTED]. BCFR Trainee Clarisse advised the police on scene said it was unsafe to check on the handcuffed male because he could possibly kick them.

BCFR Trainee Clarisse stated the male, identified as Suspect Edwards was sitting upright in the police vehicle, attempting to catch his breath from the altercation. BCFR Trainee Clarisse did not see any visible injures on Gregory Edwards prior to leaving the scene.

LaBrandon Koonce

The following information was provided by LaBrandon Koonce to WMPD Sergeant Michael Perez on December 9, 2018. The statements audio-video recorded by body camera as well as a sworn written statement.

On the morning of December 9, 2018, LaBrandon Koonce, an employee of [REDACTED] and Brenda [REDACTED], was at the Walmart, located at 845 Palm bay Road, Palm Bay, Brevard County, Florida. Witness Koonce stated to West Melbourne Police Department Sergeant Perez that he was located in the back of a box truck loading toys purchased by the [REDACTED] for the "Kids without a Christmas" program. Witness Koonce stated a male later identified Gregory Edwards, "came out of nowhere, and hopped in the truck."

Witness Koonce advised he told Suspect Edwards he couldn't be in the truck and Suspect Edwards looked at Witness Koonce and laughed. Witness Koonce then stated Suspect Edwards took his shoes off and then laid down on the toys. Witness Koonce told Suspect Edwards to get up and out of the truck. Witness Koonce stated Suspect Edwards jumped out of the truck.

Witness Koonce advised he then heard [REDACTED] yelling for help. Witness Koonce stated he looked up and observed Suspect Edwards attacking and punching [REDACTED]. Witness Koonce stated he then grabbed Suspect Edwards from behind and held him on the ground until law enforcement arrived.

[REDACTED] *Marsey's law*

On December 17, 2018, at approximately 0725 hours, Agent Wheeler conducted a voluntary, sworn, audio-recorded interview with [REDACTED] at [REDACTED] Melbourne, Brevard County, Florida.

[REDACTED] stated in substance the following:

[REDACTED] had volunteered his truck to be used for the annual "Kids without a Christmas" program.

On December 9, 2018, at Walmart, [REDACTED] was filling one of his trucks with donated toys when he observed an unknown black male, later identified as Gregory Edwards inside with the toys. [REDACTED] stated that Suspect Edwards was asked to leave the back of the truck and then fell on top of the toys and just laid there. After being asked to leave again, Suspect Edwards stood up and appeared as though he was going to comply. [REDACTED] stated he turned around and walked away from the vehicle.

LaBrandon Koonce

The following information was provided by LaBrandon Koonce to WMPD Sergeant Michael Perez on December 9, 2018. The statements audio-video recorded by body camera as well as a sworn written statement.

On the morning of December 9, 2018, LaBrandon Koonce, an employee of [REDACTED] and Brenda [REDACTED], was at the Walmart, located at 845 Palm bay Road, Palm Bay, Brevard County, Florida. Witness Koonce stated to West Melbourne Police Department Sergeant Perez that he was located in the back of a box truck loading toys purchased by the [REDACTED] for the "Kids without a Christmas" program. Witness Koonce stated a male later identified Gregory Edwards, "came out of nowhere, and hopped in the truck."

Witness Koonce advised he told Suspect Edwards he couldn't be in the truck and Suspect Edwards looked at Witness Koonce and laughed. Witness Koonce then stated Suspect Edwards took his shoes off and then laid down on the toys. Witness Koonce told Suspect Edwards to get up and out of the truck. Witness Koonce stated Suspect Edwards jumped out of the truck.

Witness Koonce advised he then heard [REDACTED] yelling for help. Witness Koonce stated he looked up and observed Suspect Edwards attacking and punching [REDACTED]. Witness Koonce stated he then grabbed Suspect Edwards from behind and held him on the ground until law enforcement arrived.

Michael Mich

On December 17, 2018, at approximately 0725 hours, Agent Wheeler conducted a voluntary, sworn, audio-recorded interview with [REDACTED] at [REDACTED] Melbourne, Brevard County, Florida.

[REDACTED] stated in substance the following:

[REDACTED] had volunteered his truck to be used for the annual "Kids without a Christmas" program.

On December 9, 2018, at Walmart, [REDACTED] was filling one of his trucks with donated toys when he observed an unknown black male, later identified as Gregory Edwards inside with the toys. [REDACTED] stated that Suspect Edwards was asked to leave the back of the truck and then fell on top of the toys and just laid there. After being asked to leave again, Suspect Edwards stood up and appeared as though he was going to comply. [REDACTED] stated he turned around and walked away from the vehicle.

██████████ advised as he turned and started to walk away from the truck, he was attacked from behind by Suspect Edwards who punched him multiple times to the back of his head. ██████████ advised he was punched to his left temple, right temple, back and arms. ██████████ stated throughout the attack Suspect Edwards laughed. ██████████ advised that one of his employees, LaBrandon Koonce came to his aid. ██████████ stated Witness Koonce pulled Suspect Edwards from him and then pinned Suspect Edwards to the ground. ██████████ advised Suspect Edwards was trying to bite Witness Koonce.

██████████ recalled Suspect Edwards as being incredibly strong because it took two to three grown males to keep him on the ground. ██████████ stated that while Suspect Edwards was on the ground he would go "dormant" where he would relax and then come back up struggling and fighting to get off the ground.

██████████ advised that while waiting for law enforcement to arrive, a female later identified as Mrs. Edwards placed her cellular telephone next to suspect Edwards's ear so he could hear his brother on speaker phone. ██████████ advised he believed this was done in an attempt to calm Suspect Edwards down, but it had no effect on his behavior.

██████████ advised that WMPD arrived on scene and attempted to put Suspect Edwards into handcuffs who actively and physically resisted their attempts to secure him. ██████████ stated he did not witness WMPD officers use any type of force against Suspect Edwards while they were on the ground. ██████████ advised that the officer just held Suspect Edwards on the ground and struggled as he tried to keep his hands under control. ██████████ advised that as additional officers arrived, the struggle with Gregory Edwards continued until he was finally secured in handcuffs.

██████████ stated he observed Mrs. Edwards recording with her cellular telephone and he heard her ask the officers if they knew when Suspect Edwards would arrive at Circles of Care. ██████████ stated he also heard Mrs. Edwards also tell all the witnesses her husband had been up for five nights, had threatened suicide, felt threatened by him and that is why she brought him to Walmart with her.

██████████ believed Suspect Edwards seemed either impaired or in an altered state of mind because he was "swan diving" into the toys inside the truck and was not understanding their conversation.

Brenda Mich

On December 18, 2018, at approximately 0846 hours, Agent Wheeler and I conducted a voluntary, sworn, audio-recorded interview with Brenda Mich at 4340 Fortune Place, West Melbourne, Brevard County, Florida.

Brenda Mich stated in substance the following:

Witness Mich reported she and [REDACTED] were collecting toys for "Kids without Christmas," on December 9, 2018, at the Walmart, located at 845 NE Palm Bay Road, Palm Bay, Florida.

During the toy collection, Witness Mich was inside Walmart shopping for toys when she heard that [REDACTED] was attacked and hurt outside of the store. Witness Mich went outside and found [REDACTED] with injuries. Witness Mich stated [REDACTED] glasses and watch were broken and his shirt was ripped.

Witness Mich then saw the police restraining an individual, later identified as Gregory Edwards, on the ground who was resisting them.

Witness Mich stated that while [REDACTED] was being treated by BCFR, she remained near the scene and observed a female later identified as Kathleen Edwards standing beside her watching as Suspect Edwards resisted the police. Witness Mich advised Mrs. Edwards told two other citizens "This is what you get for serving your country." Witness Mich then asked Mrs. Edwards if Suspect Edwards was her husband and Mrs. Edwards replied "yes." Witness Mich advised she recalled Mrs. Edwards stating that Suspect Edwards had been up for five days, they came to Walmart to get medication for him so he could sleep, and she didn't want to leave him at home because she was afraid he was going to kill himself. Witness Mich advised that Mrs. Edwards also told her that when she saw Suspect Edwards lying on the toys, she thought he was trying to steal them, but they don't need anything because they have lots of money and live in Grant.

On December 18, 2018, Witness Mich provided me with [REDACTED] torn shirt, his broken glasses, and his broken watch. Witness Mich additionally email me photographs taken of [REDACTED] injuries. The evidentiary items were provided to CSI Cox and the photographs are included as evidentiary enclosures.

Kathleen Edwards

On December 9, 2018, at approximately 2100 hours, Sergeant Kevin Roberts was directed to respond to 4029 Gardenwood Circle, Grant Valkaria, and make contact with Gregory Edwards' wife, Mrs. Kathleen Edwards.

Sergeant Roberts responded and spoke to Mrs. Edwards, and advised her Gregory Edwards was hospitalized, and she needed to respond to RRMC. Mrs. Edwards advised she would not be traveling to the hospital at that time due to her being pregnant and having a young child. I requested Sergeant Roberts relay to her that due to Gregory Edwards' medical condition, she was strongly encouraged to respond to the hospital. Sergeant Roberts then relayed to Mrs. Edwards the urgency to which Mrs. Edwards agreed to find assistance and drive to RRMC.

While at the hospital, I made telephone contact with Mrs. Edwards who then advised she could not make it to the hospital, therefore, Agent Wheeler and I responded to her residence.

On December 9, 2018, at approximately 2238 hours, Agent Wheeler and I arrived at the Edwards' residence. Upon arrival we were met by Mrs. Edwards who invited Agent Wheeler and me inside.

Mrs. Edwards stated she had just got off the telephone with Mr. Edwards nurse, where she provided consent for the hospital to give Mr. Edwards additional blood. Mrs. Edwards stated she did not have family in the area and was trying to make arrangements to travel to the hospital because she was thirty-eight weeks pregnant in addition to having a young child.

I then inquired as to if Mr. Edwards had been home earlier in the day and Mrs. Edwards said he was, in fact they were at Walmart together today when Gregory Edwards was arrested.

Mrs. Edwards explained that Mr. Edwards had not slept for the last four to five days and she could not leave him alone by himself. Mrs. Edwards stated she took Mr. Edwards to Walmart with her so that she could buy something to help him sleep. Mrs. Edwards advised that while at Walmart, Mr. Edwards had a psychotic episode, wasn't in his right state of mind, "attacked everybody" and was arrested.

Mrs. Edwards stated she told the police officers that Mr. Edwards was a Combat Veteran, was suffering from PTSD and had psychotic episodes. Mrs. Edwards advised she was not sure what triggered this episode, but she believed it was due to the stress of the new baby and the holidays.

Mrs. Edwards stated Mr. Edwards had PTSD Psychosis and hallucinates as if he was schizophrenic, but had no other known medical problems. Mrs. Edwards advised that over the prior two weeks, Mr. Edwards had not been in his right state of mind. Mrs. Edwards described when she spoke to Mr. Edwards that he would look at her, but "he doesn't hear what I'm saying." Due to Mr. Edwards' odd behavior, Mrs. Edwards was planning on taking Mr. Edwards to the VA Clinic on Monday, December 10, but could not say if he would have even agreed to go, and she was not in the right physical condition (pregnancy) to, "man handle him" to make him go. Mrs. Edwards then stated, "I was kind of relieved when they picked him up," referring to Gregory Edwards being arrested at the Walmart.

Mrs. Edwards then advised Mr. Edwards was prescribed mental health medication but was not taking it as prescribed. Furthermore, Mr. Edwards' doctor had recently taken him off of his prescribed medication due to the medication affecting their sex life.

Mrs. Edwards advised that Gregory Edwards was on probation and not allowed to drink alcohol because it would violate his probation. Mrs. Edwards explained Gregory

Edwards had an alcohol use disorder, therefore he had resorted to "huffing," cans of air duster because it would not show up in a drug test. Mrs. Edwards advised the last time she observed Mr. Edwards inhaling air duster was on Saturday night, December 8, 2018, but she did not give an exact time. Mrs. Edwards reported she would routinely find empty air duster cans in the wastebasket and then directed Agent Wheeler and me into Mr. Edwards's office area where she pointed out a trashcan full of empty air duster cans. The trashcan and contents were photographed. Mrs. Edwards requested the nurses be notified that Mr. Edwards had been inhaling air duster, which I did.

Mrs. Edwards stated she was going to go to the hospital and requested the address. I provided Mrs. Edwards with the address to the hospital to which she said she was going to respond after she got dressed.

The interaction with Mrs. Edwards was digitally recorded and is attached as an enclosure.

On December 10, 2018, at approximately 1006 hours, I attempted to make telephone contact with Ms. Edwards, but was met with negative results, and left a voicemail message.

On December 10, 2018, I requested Brevard County Sheriff's Office Victim's Advocate Peggy Brooks make contact with Ms. Edwards. Victim's Advocate Brooks reached out to Ms. Edwards and offered her services and assistance. Ms. Edwards was upset and did not accept any services offered.

On December 11, 2018, at approximately 1714 hours, I made telephone contact with Ms. Edwards to give condolences as well as to see if she was in need of anything. This telephone call was cut short as Ms. Edwards was profane, advising me to speak to her lawyer and ended the telephone call abruptly.

James Oeser

On December 12, 2018, at approximately 1516 hours, Agent Ethan Kersey conducted a voluntary, sworn, audio-recorded statement with James Oeser at Walmart Supercenter Store, located at 845 Palm Bay Road, West Melbourne, Florida.

James Oeser stated in substance the following:

Witness Oeser stated that on December 9, 2018, at 0700 hours, he began his shift at Walmart as a Door Greeter. While on his lunch break Witness Oeser walked out of the west side front doors where he observed a police vehicle with its emergency lights on, parked in front of the east side front doors. Witness Oeser walked over to the area to see what was going on, where he observed a law enforcement officer holding a male down on the ground. Witness Oeser stated he did not see any activities leading up to the encounter with law enforcement.

Mr. Oeser had no further information to provide pertaining to this incident.

John Tress

On December 13, 2018, at approximately 1229 hours, Agent Ethan Kersey conducted a voluntary, sworn, audio-recorded statement with John Tress at Walmart Supercenter Store, located at 845 Palm Bay Road, West Melbourne, Florida.

John Tress stated in substance the following:

Witness Tress stated that on December 9, 2018, at 0700 hours, he began his shift at Walmart as a Door Greeter. Witness Tress was working by the stores east side front doors when a customer entered the Walmart yelling that there was a fight occurring outside. Witness Tress advised he walked outside where he observed a large African American male holding down another male on the ground. Witness Tress stated he did not observe any punches or kicks being exchanged by the two males. Witness Tress advised he knew that the African American male who was on top of the other male was the driver of the "Toys for Tots" truck.

After a few minutes Witness Tress heard police sirens and was told by a fellow employee to reenter the store at which he returned back to work inside the store.

Witness Tress had no further information to provide pertaining to this incident.

Wendy Haynes

On December 13, 2018, at approximately 1239 hours, Agent Ethan Kersey conducted a voluntary, sworn, audio-recorded statement with Wendy Haynes at Walmart Supercenter Store, located at 845 Palm Bay Road, West Melbourne, Florida.

Wendy Haynes stated in substance the following:

Witness Haynes stated that on December 9, 2018, at approximately 0800 hours, she began her shift at Walmart as an Assistant Manager. Witness Haynes advised she was working at the front of the store when a "Toys for Tots" volunteer came into the store and told her that two men were fighting outside the store. Witness Haynes exited the east side front doors and observed two males laying on the ground. Witness Haynes advised an African American male was holding down another male. Witness Haynes did not observe any punches or kicks being exchanged by the two males, but said that a female was talking on a cellular telephone telling the male being held down to calm down. Witness Haynes advised that this same unknown female took her cellular telephone and held it up to the male's ear as she continued to tell him to calm down. Witness Haynes stated a few minutes later law enforcement arrived, and she returned back inside of the store.

Witness Haynes had no further information to provide pertaining to this incident.

Joanne Borsella - Florida Department of Corrections - Probation Officer

On December 18, 2018, at approximately 0935 hours, Agent Wheeler and I conducted a voluntary, sworn audio-recorded interview with Probation Officer Joanne Borsella.

Officer Joanne Borsella stated in substance the following:

Officer Borsella is employed as a Felony Probation Officer with the Florida Department of Corrections and has been for approximately twenty years.

Officer Borsella advised that Gregory Edwards was on probation for a violent felony offense.

A review of the probation and the associated felony case are as follows:

On October 2, 2017, at approximately 1919 hours, Gregory Lloyd Edwards, male, 5-11, 200 lbs., was a patient at Wuesthoff Medical Center, located at 110 Longwood Avenue, as a patient under a Baker Act. Suspect Edwards was seated in the Baker Act Room being prepared to be moved to the Baker Act Facility when he refused. Suspect Edwards then intentionally and unprovoked punched an Emergency Medical Care provider in the face. Security Officers and the Charge Nurse then tried to separate the suspect Edwards from the victim. Suspect Edwards then bit a Security Officer and struck a second Security Officer in the face several times. Suspect Edwards additionally grabbed the Charge Nurse. Suspect Edwards was charged by Capias with three (3) counts of felony battery 784.07.2.B Battery of LEO or Firefighter and one (1) count of misdemeanor battery 784.03.A. Rockledge Police Department case number 2017-00036334, Court case number 05-2017-CF-048115-AXXX-XX.

On January 2, 2018, Gregory Lloyd Edwards was arrested and transported to the Brevard County Jail on a bond of \$15,500 for the above noted offenses.

On February 1, 2018, Gregory Lloyd Edwards, being represented by Attorney Ernest L. Chang entered a plea of guilty (3) counts of felony battery 784.07.1.C Battery on Emergency Medical Care Provider and one (1) count of misdemeanor battery 784.03. Edwards was placed twenty-four (24) months felony supervised probation by the Department of Corrections.

Attorney Scott McCullough

On December 12, 2018, at approximately 0042 hours, an email was received from Attorney Scott McCullough, McCullough & Leboff, P.A., noting that he was representing the Edwards family and any further correspondence should be completed through him. The email correspondence is included as enclosures of this report.

On December 12, 2018, I received a telephone message from Attorney McCullough's office regarding the status of the investigation. After receiving the telephone message, the call was returned on the same day and a voice message left on the office telephone.

On or about December 17, 2018, Lieutenant Vitaliano spoke with Attorney McCullough by telephone. During the conversation Attorney McCullough was advised of the active criminal investigation and the investigative procedures. Attorney McCullough appeared satisfied with the conversation. Additionally, Lieutenant Vitaliano advised Attorney McCullough that the investigation had revealed Mrs. Edwards had recorded the incident at Walmart with her cellular telephone. Attorney McCullough confirmed the recording and advised he had a copy of the video. Lieutenant Vitaliano requested a copy of the video and Attorney McCullough agreed to email the video recording.

On December 21, 2018, Lieutenant Vitaliano sent an email to Attorney McCullough advising the video had not been received by the Sheriff's Office. On December 23, 2018, Attorney McCullough emailed four (4) video recordings, which were purportedly recorded by Mrs. Edwards. These videos are included as enclosures of this report.

On January 23, 2019, Attorney McCullough directed an email to Lieutenant Vitaliano requesting to be updated on the status of the investigation. On January 24, 2019, Lieutenant Vitaliano responded to Attorney McCullough via email explaining the status of the investigation. That same day Attorney McCullough acknowledged receipt of the email and thanked him for the update. On January 25, 2019, Lieutenant Vitaliano received an email from Frieda Marhee, associate of Mr. McCullough stating, "What drug are they looking for in his system?! Ummm". The email correspondence is included as enclosures of this report.

On March 5, 2019, the Brevard County Sheriff's Office received correspondence through the United States Mail from Attorney Scott T. McCullough dated February 21, 2019. The correspondence requested any and all investigative materials and a copy of an Order issued by Judge Michelle Baker "Order Appointing Personal Representative" and "Letters of Administration," both filed February 19, 2019. The correspondence is included as enclosures of this report.

On March 5, 2019, Brevard County Sheriff's Office Commander Jimmy Donn of Professional Standards responded to Attorney McCullough noticing acknowledgement of the court records, File number 2019-CP-012932 and reaffirming the requested materials are not public records until the State Attorney has rendered a finding. The correspondence is included as enclosures of this report.

Linda Sullivan - Stewart Reference Laboratory - Supervisor

On February 7, 2019, Lieutenant Rob Vitaliano spoke with Linda Sullivan of Stewart Reference Laboratory, which is the toxicology lab contracted by the Brevard Medical Examiner's Office. Ms. Sullivan is the supervisor for the toxicology/forensics services. The discussion inquired the process of how the lab conducts toxicology tests for volatile substances such as 1, 1 Difluoroethane, which is the toxic substance identified from huffing certain aerosol products. Lieutenant Vitaliano also inquired how long 1, 1 Difluoroethane would remain in a subject's body. Supervisor Sullivan advised there are many factors to consider when evaluating toxicology results. Because 1,1 Difluoroethane is so volatile in nature, it has a short half-life and rapid elimination from the blood, so it is critical to immediately seal the blood or tissue desired to be tested. If the sample is not sealed or was opened at any stage prior to toxicology testing, then there is a great likelihood the substance may not be present in the sample at the time of testing.

Additionally, significant physical activity of the subject and the amount of time the blood is collected from the time of ingestion is also important. All of these factors contribute to the depletion of 1, 1 Difluoroethane in a blood sample. Supervisor Sullivan stated that because a blood sample does not test positive for 1, 1 Difluoroethane does not mean that the subject did not inhale the substance, or that it did not adversely affect a subject's body. Supervisor Sullivan further advised that 1, 1 Difluoroethane is very toxic and causes significant cardiac issues, many times fatal within the subject who has inhaled/ingested the substance.

Supervisor Sullivan advised she is available for testimony and provided several articles related to the topic, which are enclosures.

In-Car Video recordings were recovered of WMPD Officer Krukoski's marked patrol vehicle. This video footage captures when Gregory Edwards was placed into Officer Krukoski's vehicle until he arrived at the Sally Port area of BCJC.

Brevard County Jail Complex Video Recording

Brevard County Jail Complex video recording were recovered from the time Gregory Edwards arrived at the BCJC Sally Port until he was transported by BCFR to Rockledge Regional Medical Center.

Kathleen Edwards – Cellular Telephone Video Recording

Attorney Scott McCullough provided four cell phone video recordings purportedly provided by Mrs. Edwards, taken by her with her cellular telephone on December 9, 2018.

These video clips are attached to this report as an enclosure for review.

Palm Bay Facebook Crime Watch Video Recording

On December 13, 2018, telephone contact was made with Vanessa Colon. Ms. Colon advised she was at Walmart located at 845 NE Palm Bay Road, Palm Bay, on December 9, 2018. While at Walmart Ms. Colon observed Gregory Edwards being arrested by WMPD and recorded and then posted the video recordings to Palm Bay's Face Book Crime Watch Page. Ms. Colon provided, via email, the video recordings she purportedly had taken.

The video recording depicted WMPD holding Gregory Edwards on the ground during their arrest and WMPD officers escorting Gregory Edwards to the WMPD patrol vehicle.

The video recordings are attached as an enclosure.

Charlene Raisman's Cellular Telephone Video Recording

A cellular telephone video recording was recovered that was purportedly taken by Charlene Raisman on December 9, 2018, at the Walmart, located 845 NE Palm Bay Road, Palm Bay, Florida. The video recording was provided by Ms. Raisman, depicting WMPD officers holding Gregory Edwards on the ground during the arrest.

Computer Aided Dispatch (CAD) Reports

West Melbourne Police Department - CAD Report

The West Melbourne Police Department (WMPD) CAD report of December 9, 2018, initiated at approximately 1120 hours, when the BCSO Communications Center received an emergency 9-1-1 telephone call in reference to a male who possibly fell down in front of the Walmart located at 845 NE Palm Bay Road, Palm Bay, Florida. The caller then advised the male did not fall down, but a battery may have occurred. At approximately 1124 hours, BCSO Communications Center was advised a black male, identified as Gregory Edwards was under arrest. Palm Bay Police Department (PBPD) was documented as arriving on scene at approximately 1127 hours, to assist. At approximately 1238 hours, WMPD Officer Krukoski advised he was enroute to the BCJC with Gregory Edwards. At 1301 hours, WMPD Sergeant Michael Perez telephoned the BCJC Booking office, speaking with Sergeant Richard Zimmerman and advised one of his officers (Krukoski) was enroute to the BCJC and the subject was beginning to get agitated or "worked up" in transport. Sergeant Perez requested assistance receiving Gregory Edwards from the vehicle upon arrival to the BCJC. WMPD Officer Krukoski arrived at the BCJC at 1309 hours and received assistance with Gregory Edwards by BCSO Corrections Deputies.

Palm Bay Police Department - CAD Report

The Palm Bay Police Department (PBPD) CAD report of December 9, 2018, initiates at approximately 1126 hours, when PBPD Officers were dispatched to Walmart located at 845 NE Palm Bay Road, Palm Bay, Florida, in reference to an Assist Other Agency (AOA) call for service. PBPD officers arrived at approximately 1128 hours, and cleared the call at 1137 hours.

Brevard County Sheriff's Office - CAD Report

The Brevard County Sheriff's Office (BCSO) CAD report initiated on December 9, 2018, at approximately 1438 hours, BCSO received a 9-1-1 call in reference to a possible battery between an Inmate and Deputy that occurred at 860 Camp Road, Cocoa, Brevard County, Florida. While at RRM, Agent Urbanetz collected Deputy Blazewicz' Agency issued CEW. Both Deputy Blazewicz and her department issued CEW were collected and brought back to the Brevard County Sheriff's Office CIS office. Agent Urbanetz also collected Gregory Edwards' initial admission blood, which was secured and later turned over to the Medical Examiner's Office.)

CSI Schneider photographed and processed multiple scenes at Brevard County Jail complex to include the general booking area, holding cell seven, holding cell nine and the Medical Ward.

The booking area consisted of a large central area with multiple offices/holding cells around the central area. CSI Schneider observed and documented AFID tags and two small pieces of green plastic on the floor immediately southeast of cell eight. These

On December 9, 2018, at approximately 1547 hours, I arrived at 860 Camp Road, Cocoa, Brevard County, Florida.

The following is a synopsis of the investigative assignments and documentation. The Case Report and associated Supplemental Reports are attached as enclosures.

Upon arrival I was informed by Lieutenant Robert Vitaliano that Inmate Gregory Edwards had been transported to RRMCC and was in serious condition. While at RRMCC, Agent Urbanetz collected Deputy Blazewicz' Agency issued CEW. Both Deputy Blazewicz and her department issued CEW were collected and brought back to the Brevard County Sheriff's Office CIS office. Agent Urbanetz also collected Gregory Edwards' initial admission blood, which was secured and later turned over to the Medical Examiner's Office.)

CSI Schneider photographed and processed multiple scenes at Brevard County Jail complex to include the general booking area, holding cell seven, holding cell nine and the Medical Ward.

The booking area consisted of a large central area with multiple offices/holding cells around the central area. CSI Schneider observed and documented AFID tags and two small pieces of green plastic on the floor immediately southeast of cell eight. These

items are designed to deploy from the CEW when activated. The placement of the AFID tags were consistent with a CEW being discharged in the area.

CSI Schneider was then directed by Lieutenant Vitaliano to a sharps container located on the wall of an office on the southwest side of the booking area. The sharps container was believed to contain the probes deployed from Deputy Blazewicz' CEW. Two CEW probes with attached wires were located inside the sharps container. The tips of the probes appeared to have suspected blood.

CSI Schneider then collected Inmate Edwards' personal belongings which included a black Seiko watch, a grey metal ring, a pair of white headphones, a pair of blue/black New Balance flip flops, a pair of camo shorts with a brown belt, a black Under Armour shirt and a pair of plaid boxer briefs.

CSI Schneider was assigned to process and document the BCJC Medical Ward. This scene consisted of a large central area with smaller rooms around it. A hallway led from the central area to the surrounding rooms. A portion of the medical area appeared to have been sectioned off as a crime scene. CSI Schneider stated he was advised by BCSO Corrections Deputy DaShawn Edward that the sectioned off area was where the medical staff provided life saving measures. Medical waste items and a small reddish-brown drip stain was observed in this area.

Also located and documented in the Medical Ward was the ERC and AED associated with Inmate Edwards. These items were located in the central room of the Medical Ward. The used AED pads and packaging were in a trash bin near the AED.

On December 11, 2018, Inmate Gregory Edwards medical records were recovered from the Brevard County Jail Complex, which included a print out of the AED used on Gregory Edwards. It should be noted, on this same date, I noticed a time discrepancy on the AED. Corrections Deputy Sergeant Karl Pischinger verified the AED used on Inmate Gregory Edwards reflected a time discrepancy of approximately one hour and two minutes. This was attributed to the time change.

CSI Schneider photographed all the corrections deputies identified as being directly involved with Inmate Gregory Edwards. Corrections Deputy Wagner's uniform shirt was observed to have been ripped during the altercation and was collected as evidence.

Conducted Energy Weapon - Taser

Sergeant Michael Charest, Brevard County Sheriff's Office Master CEW Instructor responded to CIS and downloaded Deputy Blazewicz' CEW (S/N X00-243382.)

BCSO Sergeant Michael Charest – Career Development Supervisor

On March 14, 2019, at approximately 1500 hours, I met with BCSO Sergeant Michael Charest at 340 Gus Hipp Boulevard, Rockledge, Florida. I conducted a voluntary, sworn audio-recorded interview with Sergeant Charest.

Sergeant Charest stated in substance the following:

Sergeant Charest has been employed by the Brevard County Sheriff's Office since September 12, 1994, and is currently assigned as the Career Development supervisor responsible for agency personnel training.

Sergeant Charest also holds Instructor Certification in High Liability training as well as Taser Master Instructor.

On December 9, 2018, Agent Wendy Wheeler contacted Sergeant Charest requesting he respond to the BCSO Criminal Investigative Services, located at 340 Gus Hipp Boulevard, Rockledge, in reference to downloading an agency issued Taser assigned to Corrections Deputy Allison Blazewicz.

Sergeant Charest stated that upon arrival, he was provided a Taser X26, serial number X00-243382. Sergeant Charest then downloaded the Taser utilizing the Taser Evidence Sync System. The Taser Evidence Sync internal report indicated the Taser download was initiated on December 9, 2018 at 18:05:56 hours and was completed at 18:09:27 hours.

The download report generated by Sergeant Charest revealed a history of the Taser from July 9, 2013, 16:01:36 hours, to the date of the download, which was December 9, 2018, at 18:05:56 hours. As it pertains to the events on December 9, 2018, the device report indicated Corrections Deputy Blazewicz activated her assigned Taser trigger six (6) times, all at various lengths of time. Sergeant Charest explained when a Taser trigger is pressed (Activation), it is designed to automatically cycle for five (5) seconds. Sergeant Charest stated that if the user does not release the trigger, it will continue to cycle until the trigger is released.

Sergeant Charest stated the device report does not reflect information such as if the Taser actually made contact with a subject (Application) through either a cartridge probe

deployment or Drive Stun where electricity flows to the subject. The report only identifies what time the trigger was pressed, length of the cycle and battery percentage at the time of deployment.

A Conducted Electrical Weapon (CEW), is a product of Axon Inc., previously known as Taser. The device is hand-held and propels small probes connected by a thin conductive wire. When deployed, the device will create temporary neuromuscular incapacitation. The nerve interruption lasts for only the time period the device is activated. The CEW is designed to cause a subject to stop resisting or fighting. A Drive Stun is a trained technique of CEW usage considered to be pain compliance. The Drive Stun technique is where the user physically applies the CEW to the subject in an attempt to increase the length of the spread of device contact. A successful probe deployment occurs when there is an adequate spacing between the probes. The probes are less effective if not properly spaced, or in fatty tissue. CEW effectiveness is generally dependent upon delivering the probes effectively with a sufficient spread between the two probes, which must remain attached to the subject. Circumstances may dictate additional or prolonged activations if the subject is not responding to the effects.

OC (Oleoresin Capsicum) spray or pepper spray is described as a chemical agent designed to cause a non-lethal inflammation of all mucous membranes in the eyes, nose, mouth and lungs causing tearing and an intense, temporary debilitating burning sensation. The effects of OC spray may last from thirty (30) minutes to two (2) hours

The assignment of a CEW or Chemical Agent requires training and certification.

BCSO Use of Force Training Materials

In review of BCSO Policy/Procedure 600.071, Response to Resistance – Use of Force, Only the minimal amount of force necessary shall be used to control an inmate or situation within the facility; ie, no employee shall apply physical force to the person of an inmate except and only to the degree that it is reasonably necessary in self-defense, to prevent injury to a person or property, to prevent escape, to quell a riot or disturbance, to overcome physical resistance to a lawful command, and then only as a last resort and in accordance with appropriate statutory authority. The level of force applied must be objectively reasonable based on the totality of circumstances (articulable facts) surrounding the immediate situation. Response levels shall be in compliance with BCSO Policy and Procedure 500.76.

In review of BCSO Policy/Procedure 500.76, Response to Resistance, Guidelines are established for all sworn personnel concerning response to resistance, reflecting agency philosophy and established Florida Department of Law Enforcement Standards. A deputy sheriff is expected to select effective, reasonable and legal force options in a verbal or physical encounter.

- A. Response to Resistance
1. Totality of the Circumstances – The deputy's use of force will be based on the totality of the circumstances known to the deputy at the time of the incident. There are several factors used in determining the totality of the circumstances. These include, but are not limited to:
 - a. Severity of the crime
 - b. Subject is an immediate threat
 - c. Subject's mental or psychiatric history, if known to the deputy
 - d. Subject's violent history, if known to the deputy
 - e. Subject's combative skills
 - f. Subject's access to weapons
 - g. Innocent bystanders who could be harmed
 - h. Number of subjects versus number of deputies
 - i. Duration of confrontation
 - j. Subject's size, age, weight, and physical condition
 - k. Deputy's size, age, weight, physical condition, and defensive tactics expertise
 - l. Environmental factors, such as physical terrain, weather conditions, etc.
- B. Resistance Levels

1. Passive Resistance – A subject's verbal and/or physical refusal to comply with a deputy's lawful direction that causes the deputy to use physical techniques to establish control; non-verbal cues in attitude, appearance, demeanor or posture that indicates an unwillingness to cooperate or a threat.
2. Active Resistance – A subject's use of physically evasive movements directed toward the deputy such as bracing, tensing, pushing, or pulling to prevent the deputy from establishing control over the subject. Subject is evading control without trying to hurt the deputy.
3. Aggressive Resistance – A subject's attacking movements toward a deputy that may cause injury but are not likely to cause death or great bodily harm to the deputy or others.
4. Deadly Force – A subject's hostile, attacking movements, with or without a weapon, that create a reasonable perception by the deputy that the subject intends to cause and has the capability of causing death or great bodily harm to the deputy or others.

Documents reviewed in the Document Management System (DMS) for BCSO deputy review relating to Use of Force training and awareness: BCSO Annual Training 2018 Use of Force; Physiological Response to Use-of-Force; 600.07I Response to Resistance Use of Force; Legal Eagle August 2016; 500.76 Response to Resistance; Legal Eagle November 2017; 600.07K Restraint Chair; Jail Complex New Hire Orientation; and 600.07J Physical Restraints; 500.77 Weapons.

Brevard County Medical Examiner's Office Autopsy and Toxicology Report

On December 11, 2018, I attended the autopsy of Gregory Lloyd Edwards at the Medical Examiner's Office. The decedent was male, 38 years of age, 6'-00", 256 pounds.

Prior to the autopsy Medical Examiner Dr. Qaiser and Medical Examiner Investigator Rick Huckabee were informed of the information related to the death of Gregory Edwards. They were also informed that Gregory Edwards was suspected to have been huffing from aerosol cans prior to his initial encounter with law enforcement. It was requested that the Edwards admission blood be tested for the chemical compound identified as 1, 1 Difluoroethane, which is associated with the aerosol product.

After completing the autopsy Dr. Qaiser advised he did not observe any significant injuries or trauma and the case would be pending toxicology.

On January 11, 2019, I was notified by Brevard County Medical Examiner's Office that the toxicology report had been completed. This initial toxicology report indicated that Gregory Edwards' hospital admission blood was tested and only contained the following:

Diphenhydramine, Naloxone, Caffeine and Caffeine Metabolite.

After further review of the toxicology report it did not appear the blood sample was tested for the aerosol huffing chemical identified as 1, 1 Difluoroethane. Contact was made with Medical Examiner Investigator Craig Engelson who re-submitted the blood sample back to the lab on January 15, 2019, requesting the admission blood to be tested for 1, 1 Difluoroethane.

On February 6, 2019, I met with Dr. Qaiser at the Medical Examiner's Office to provide the West Melbourne Police Department and BCJC video recordings for Dr. Qaiser's review. Dr. Qaiser additionally requested to examine a vented spit hood identical to the hood used with Inmate Gregory Edwards. Lieutenant Vitaliano obtained a vented spit hood from the Jail and delivered it to Dr. Qaiser the same day. Dr. Qaiser reviewed the videos and hood advising the autopsy report was pending.

Brevard County Medical Examiner's Office Autopsy and Toxicology Report

On December 11, 2018, I attended the autopsy of Gregory Lloyd Edwards at the Medical Examiner's Office. The decedent was male, 38 years of age, 6'-00", 256 pounds.

Prior to the autopsy Medical Examiner Dr. Qaiser and Medical Examiner Investigator Rick Huckabee were informed of the information related to the death of Gregory Edwards. They were also informed that Gregory Edwards was suspected to have been huffing from aerosol cans prior to his initial encounter with law enforcement. It was requested that the Edwards admission blood be tested for the chemical compound identified as 1, 1 Difluoroethane, which is associated with the aerosol product.

After completing the autopsy Dr. Qaiser advised he did not observe any significant injuries or trauma and the case would be pending toxicology.

On January 11, 2019, I was notified by Brevard County Medical Examiner's Office that the toxicology report had been completed. This initial toxicology report indicated that Gregory Edwards' hospital admission blood was tested and only contained the following:

On February 6, 2019, I met with Dr. Qaiser at the Medical Examiner's Office to provide the West Melbourne Police Department and BCJC video recordings for Dr. Qaiser's review. Dr. Qaiser additionally requested to examine a vented spit hood identical to the hood used with Inmate Gregory Edwards. Lieutenant Vitaliano obtained a vented spit hood from the Jail and delivered it to Dr. Qaiser the same day. Dr. Qaiser reviewed the videos and hood advising the autopsy report was pending.

On February 26, 2019, I received a final copy of the Medical Examiner's autopsy report. Dr. Qaiser determined the cause of death to be "Excited Delirium and Complications" due to "Hyperactive and Violent State with Subsequent Restraint." Other significant conditions were identified as "Desquamative Interstitial Pneumonitis, Early Hepatic Cirrhosis, Obesity, Post-Traumatic Stress Disorder, and Minor External Body Injuries."

The toxicology report indicated no presence of 1, 1 Difluoroethane in the admission blood.

For detailed information regarding the autopsy and toxicology, please refer to the Brevard County Medical Examiner's Office Final Autopsy Report, which is included as an enclosure.

Investigative Summary

This investigation has identified that Mr. Gregory Lloyd Edwards was suffering from significant Psychosis for several days prior to arriving at the Wal-Mart on December 9, 2018. According to Mrs. Kathleen Edwards, Mr. Gregory Edwards had not slept for at least three to four days, was suicidal and exhibiting significant signs of schizophrenia and Post-Traumatic Stress Disorder. Mrs. Edwards observed Gregory Edwards "huffing" (inhaling chemical vapors) from aerosol cans on the night of December 8, 2019. Gregory Edwards previously drank large amounts of alcohol, however, due to his felony probation status, he resorted to "huffing" aerosol to avoid a detection in his probation drug screening. Mrs. Edwards voluntarily showed multiple empty cans of Endust aerosol cans in a garbage can in their residence (photographed), which were identified as the aerosol cans Gregory Edwards had been "huffing." This product, (Endust) was researched and discovered to contain the active ingredient of 1, 1-Difluoroethane.

When Mr. Gregory Edwards encountered civilians and law enforcement at the Wal-Mart he was described as being incoherent, confused and violent. Mr. Gregory Edwards attacked a civilian without cause and was eventually tackled and held down until law enforcement arrived. West Melbourne Police arrived and also had to physically restrain Mr. Gregory Edwards who was violent in his resistance efforts. After a struggle, Mr. Gregory Edwards was secured and placed into a West Melbourne Police marked patrol vehicle. Mr. Gregory Edwards was not examined or cleared by BCFR Station 83 (BCFR statements/Video recording) prior to transport by the West Melbourne Police Department. Mr. Gregory Edwards was then transported to the Brevard County Jail Complex by the West Melbourne Police Department. During the transport, Mr. Gregory Edwards began to complain of numbness and feelings of "frostbite." The in-car camera video recording reflects Gregory Edwards experiencing some type of medical event during the transport. When Dr. Qaiser viewed the video recording he described the event as symptoms consistent with a person experiencing Excited Delirium.

While being transported, WMPD Officer Krukoski communicates that Mr. Gregory Edwards had become "agitated again and began kicking, stomping and screaming in the back seat," notifying corrections deputies to be prepared for their arrival.

Upon arrival at the Jail, Mr. Gregory Edwards initially complies, but then physically attacks a corrections deputy who states he is in fear of injury. During this struggle, multiple corrections deputies described Gregory Edwards as grunting, refusing to comply, aggressively resisting and displaying great strength. After securing Mr. Gregory Edwards in handcuffs, a restraint chair and a vented spit mask, Mr. Gregory Edwards was observed unresponsive and was moved to the Jail Medical Ward for medical treatment to include cardiopulmonary resuscitation (CPR), administered a dose of Narcan (Naloxone), applied an automated external defibrillator (AED) and provided Oxygen until the arrival of Brevard County Fire Rescue who assumed emergency lifesaving efforts before transport to the hospital where he was pronounced deceased on December 10, 2018 at 2000 hours.

Dr. Qaiser's autopsy findings identified Mr. Gregory Edwards as suffering from Desquamative Interstitial Pneumonitis (DIP). Research on this medical condition identified DIP as being a lung disease resulting from several potential causes. One of the major contributors of this disease could be caused by ingesting "inhaled agents," (Research article is attached as an enclosure) which is consistent with Mrs. Edwards's statement that Mr. Gregory Edwards was inhaling vapors from aerosol cans (huffing).

Additionally, Dr Qaiser diagnosed Mr. Gregory Edwards with "Early Hepatic Cirrhosis." This condition can be caused by alcoholism, which is consistent with Mrs. Edwards's statement that Gregory Edwards had an alcohol use disorder.

Dr. Qaiser documented Gregory Edwards had sustained "Minor External Body Injuries," all consistent with response to resistance and restraint techniques, none of which were contributed to his death.

VA Progress Reports

VA Progress Reports begin April 17, 2018, and end on November 19, 2018. The reports reflect patient's historical diagnosis of *Psychosis, Chronic PTSD, Schizoaffective Disorder, Alcohol Use Disorder* and *Cannabis Abuse*. No observed notation of history or disclosure of violence was documented in the medical report even as it related to the October 2017, violent incident where Gregory Edwards attacked medical staff at the Rockledge Regional Medical Center. Additional notation reflects patient was not on medication on advice of urologist.

18th Judicial Circuit Court, State Attorney Review

The Brevard County Sheriff's Office respectfully requests the review of the investigation concerning the in-custody death of Gregory Lloyd Edwards to determine whether or not

the actions of the involved personnel were in compliance with F.S.S. 776.05, Justifiable Use of Force by a Law Enforcement Officer.
