OPEN LETTER – PUBLIC RECORD REQUEST Regarding The In-Custody Death Of Combat Veteran, Gregory Edwards

Debra (others as FYI & for comment seeking purposes):

Thank you for the BCSO INTERNAL AFFAIRS (IA) report regarding Mr. Gregory Edwards' in-custody death within the Brevard County jail.

(THE PRR) Based on the NOW received IA report - our publication request **(PRR)** copies of the recorded IA interviews of Deputies Fayson, Blazewicz and Wagner, as are noted as being conducted and recorded within the IA investigative report.

This publication received numerous recorded and REDACTED interviews from the State Attorney's office (Mr. Brown). However, these recorded interviews appeared to be connected to the CRIMINAL investigation into Mr. Edwards' death, and not the IA investigation into his death.

Our publication anticipates publishing a follow-up article, to our August 12, 2019 posting, regarding Mr. Edwards' death.
