On the above-stated date and time, deputies responded to 166 Anchorage Avenue, unit 1, Cape Canaveral, Brevard County, Florida, 32920 in reference to a domestic disturbance.

Upon arrival, deputies made contact with victim Ms. Amanda Lynn Paul stating in a sworn audio recording that her husband of eight years in which she has children with Mr. Timothy James Paul ( Defendant ) bit her left hand, slapped her left forearm and struck her with his elbow on the upper left lip while laying on a chair together during an arguement. Ms. Paul stated that the strike to the lip caused her mouth to bleed momentarily.

Deputies then made contact with witness Ms. Meghan leann Paul, who stated that she was woken up by a commotion caused by them and hearing Ms. Amanda Paul crying. Upon turning on the lights, she was informed by the victim of what just occurred. She also stated that she noticed some blood in the victim's mouth.

It should be noted; prior to deputies arrival, the defendant fled the scene when he discovered law enforcement was called. Deputies, Aviation Unit and a Deputy K9 unit, began canvassing the area for the defendant. Shortly after, the defendant was discovered approximately .4 miles from the scene running towards a heavily wooded ditch line by a K9 unit. Announcements were made for the defendant to exit the heavily wooded ditch line with negative compliance. He was then apprehended by the K9 unit and his K9 partner.
