Happy Easter! First, I've decided to respond to you due to your incessant emails over the last couple of days. Have you decided not to be the victim now??

I'm referring to your most recent action going into the Cobb County Police Station on March 7, 2019 and involving Detective Brandon Moore with your claims of how I am not to be contacting you throwing around a very stale 2012 Protective Order, which we all know is BS since if I truly threatened your life in open court - the bailiff should have arrested me. Another BS motion signed by your buddy Judge George Maxwell. I've copied Detective Moore so he can see that not only did you once again file a false police report, you continue to contact ME, and if anything you wasted the officers time which I'm sure he has bigger cases to deal with other than a narcissist and sociopath, claiming to be a victim. Filing a false police report is a misdemeanor in Georgia pursuant to § 16-10-26 - False report of a crime.
