Mr. Landman:

Our organization - VolusiaExposed.Com has published an article announcing that twelve individuals have filed JNC applications regarding Judge John Harris' open judicial seat.

Within the above article - our publication outlined our concerns regarding applicant John C. Murphy.

Our publication also has some developing concerns regarding applicant Judge Michelle Naberhaus. Our concerns are detailed within our September 15, 2018 email to Court Public Information Officer - Michelle Kennedy. (see below - with attachment)

While our organization continues to vet these concerns - we thought it to be prudent, and in the public's best interest, to make the JNC aware of these concerns. The JNC may or may not wish to independently vet and address their concerns with Judge Naberhaus.

Sir, additionally - please accept this email as a public record request for copies of all twelve judicial applications. Being that the judicial applications were required to be filed in both redacted and electronic format - compliance with this PRR should be fairly easy.

Obviously, the JNC is currently the custodian of these public records. VolusiaExposed.Com has no preference whether you provide us with these requested records prior to the JNC interviews - or after the JNC interviews. However, if the JNC can forward us the judicial applications PRIOR to the October 5, 2018 hearing - our publication will make them available for public review ASAP. Doing so may provide the JNC with further public feed back on the applicants, Regardless - we do request that your office provide us with copies prior to turning the custody of those records over to the governor's office.

Please advised us in advance of any costs associated with our PRR. We anticipate no cost - due to our past experience with other JNCs.

Dear Michelle:

It has been reported to VolusiaExposed.Com - that recently (August 2018) Brevard County Judge Michelle Naberhaus attended a political rally supporting Governor Rick Scott's run for U.S. Senator.

VolusiaExposed.Com has been provided with a video, and a still photo reportedly depicting Judge Naberhaus shaking Governor Rick Scott's hand at this political rally (see attached PDF file).

Can your office confirm or deny that Judge Naberhaus attended this political rally?

VolusiaExposed.Com has concerns that IF Judge Naberhaus attended this political rally - that her attendance is a possible violation of Florida's Judicial Canons (particular attention given to Canon 7)

If Judge Naberhaus attended this political rally - but holds the opinion that her attendance is NOT a violation of Florida Judicial Canons - we would be interested in hearing her argument / position on the matter.

Absent evidence being presented which would relieve our concerns - we anticipate posting an article addressing this matter within the next two weeks.
