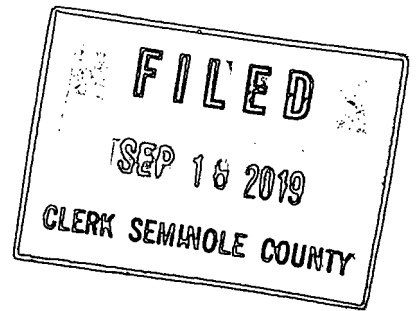

AFFIDAVIT FOR ARREST WARRANT

State of Florida
County of Seminole

BEFORE ME, JOSE TIRADO a sworn law enforcement officer, personally came Investigator Andrew Caroen, of the Seminole County Sheriff's Office, who being duly sworn deposes and says: that Affiant has reason to believe and does believe that probable cause exists for the arrest of **ANDREW JOHN JONES, white, male, Date of Birth October 17, 1978, brown hair, brown eyes, standing 6'4", weighing 200 lbs,** for a violation of the laws of the State of Florida, to wit: F.S. 794.05(1) – Unlawful sexual activity by a person 24 years or older with a person 16 or 17 years of age.

THE FACTS tending to establish the grounds for this application and the probable cause of Affiant believing that such facts exist are as follows:

Your Affiant, Andrew Caroen, is presently employed by the Seminole County Sheriff's Office, Seminole County, Florida as a duly sworn Deputy Sheriff and has been employed by the Seminole County Sheriff's Office since October 2013.

Your Affiant began working with the Seminole County Sheriff's Office as a Deputy Sheriff on patrol in Seminole Neighborhood Policing. In March 2015, your Affiant was assigned to the Crimes Against Children Unit as a Sworn Criminal Investigator working cases involving Crimes Against Children to include sexual battery, lewd or lascivious battery, and child pornography cases that have led to the arrest of subjects in sexual crimes against children.

Prior to your Affiant's service at the Sheriff's Office, your Affiant was employed by the Longwood Police Department, as a Patrol Corporal, from February 2007 to October 2013, where your Affiant was a sworn law enforcement officer, a patrol supervisor and a Field Training Officer. Your Affiant has attended several specialized training courses, which pertain to the field of Crimes Against

Children. Among these trainings are Child Abuse Investigations, Sex Crimes Investigations, Child Homicide Investigations, Interviews and Interrogations and Undercover Chat Investigations. Your Affiant has conducted previous child pornography investigations.

On August 22, 2019, at approximately 2100 hours, your Affiant and Seminole County Deputy Sheriff Investigator Stephen Breedlove responded to BMC Boats located at 3175 North Highway 17-92, Longwood, Seminole County, Florida 32750. Upon arrival, they made contact with victim [REDACTED] and [REDACTED].

During an interview with [REDACTED], she disclosed that during the early morning hours of Saturday, August 17, 2019 she engaged in vaginal/penal sexual intercourse with Andrew Jones, white male, age 40, Date of Birth October 17, 1978. [REDACTED] advised this occurred at Andrew Jones' residence located at 450 Andrews Drive, Longwood, Seminole County, Florida 32750.

[REDACTED] further detailed that she has been working for Andrew Jones' law firm for the past few months, and also assisting with Andrew Jones' judicial campaign. On the evening of Friday night, August 16, 2019, [REDACTED] was assisting with some campaign work at Andrew Jones' residence, located at 450 Andrews Drive, Longwood, Seminole County, Florida. [REDACTED] disclosed that once she was done working she hung out on the couch with Andrew Jones. [REDACTED] advised that Andrew Jones started kissing and making out with her and put his arms around her. [REDACTED] advised that one thing led to the next and she and Andrew Jones proceeded upstairs to his bedroom. [REDACTED] advised that once in Andrew Jones bedroom she and he engaged in oral sex, her mouth on his penis, and Andrew Jones mouth on her vagina. [REDACTED] advised that she and Andrew Jones then engaged in penal/vaginal sexual intercourse in his bed. [REDACTED] disclosed they were fully nude in his bed, except for wearing socks. [REDACTED] also advised that it was unprotected sex. [REDACTED] advised that after they engaged in sexual activity, she and Andrew Jones proceeded to take a shower together in his bathroom. [REDACTED] disclosed that she got dressed and left his house and went home, arriving home around 0340 hours.

[REDACTED] described that Andrew Jones' bedding consisted of darker green or mint colored sheets, and that his bedroom furniture consisted of darker colored wood, and there were wood floors in the bedroom. [REDACTED] also advised that Andrew Jones has a tattoo along his side near his ribs, which she has never seen prior to them being nude that night and engaging in sexual activity. [REDACTED] described Andrew Jones house as a two story residence with white brick, and Andrew Jones bedroom is upstairs. Nearby his bedroom is a mother in law suite where Andrew Jones' father resides. Andrew Jones' father was at the residence that evening, and knew that [REDACTED] was there, however he retired to his room earlier in the evening and she did not see him again.

[REDACTED] disclosed that later in the day on Saturday August 17, 2019, she met up with Andrew Jones, as she was helping him campaign that day, and he asked her if she was on birth control. [REDACTED] informed him that she was not, and Andrew Jones drove her to a CVS in Longwood, where he purchased her the Plan B emergency contraceptive pill. [REDACTED] advised she did take the Plan B pill. [REDACTED] advised that on August 22, 2019, she cleaned out her car and threw away the bag, receipt and box of the Plan B pill, and threw it in the trash at a Shell gas station located at Red Bug Lake Road and Tuskawilla Road. Sergeant Mike Cannaday responded to this location and successfully recovered a CVS bag, empty box of Aftera Plan B emergency contraceptive pill, and a receipt. The receipt was from

the CVS located at 130 East State Road 434, Longwood, Florida 32750, for Aftera Plan B emergency contraceptive pill. The date of the purchase was from Saturday, August 17, 2019 at 1110 hours and indicated that the contraceptive cost \$42.79 was paid for with \$43.00 cash.

During the late afternoon on August 23, 2019, [REDACTED] told your Affiant that on Saturday, August 17, 2019, Andrew Jones wore a black baseball hat, with white lettering on the front with the words "all pro dad" and had a red football logo right above those words. Video surveillance obtained from the CVS for August 17, 2019, at approximately 1105 hours showed a male matching the description of Andrew Jones enter the CVS and purchase an unknown item. This male was wearing a black baseball hat with white lettering on the front and a red logo above the lettering. Video surveillance also shows a white sport utility vehicle in the parking lot that matches the description of Andrew Jones' vehicle. [REDACTED] also told your Affiant that she still had her clothing that she wore the night she engaged in sexual intercourse with Andrew Jones. These items were collected, submitted into evidence and taken to FDLE for the screening of biological evidence to include DNA, hair, fiber, and other bodily fluids.

On Friday, August 23, 2019, at approximately 0730 hours, a search warrant was executed at Andrew Jones' residence for bedding. During a search of Andrew Jones bedroom, a black baseball hat, with white lettering on the front with the words "all pro dad" and a red football logo right above those words was observed in plain view near his closet. Photographs of the hat were obtained.

On Monday, August 26, 2019, your Affiant received a laboratory report from FDLE, pertaining to [REDACTED]'s clothing which was submitted. Evidence item EM1, one pair of jeans worn by [REDACTED] indicated the presence of semen as identified by microscopy.

On Tuesday, August 27, 2019, at approximately 0600 hours, a search warrant was executed at Andrew Jones' residence for the black baseball hat with white lettering that said "all pro dad" with a red football logo above the lettering. A search of the residence yielded negative results for the baseball hat. A buccal swab search warrant was also executed on Andrew Jones for a DNA sample. Later in the afternoon, buccal swabs were taken from [REDACTED] to obtain a DNA sample from her.

On Thursday, August 29, 2019, your Affiant received a laboratory report from FDLE. The report indicated that complete DNA profiles were obtained from the buccal swabs representing [REDACTED] and Andrew Jones. On the jeans that [REDACTED] wore, her DNA was identified on the jeans, and the semen identified on the jeans matched the DNA of Andrew Jones.

Based on the above facts, statements and physical evidence provided, your Affiant has probable cause to believe and does believe that the above listed probable cause, all leads to the substantiation that defendant, ANDREW JOHN JONES, has committed violations of the laws of the State of Florida, to wit: F.S. 794.05(1) – Unlawful sexual activity by a person 24 years or older with a person 16 or 17 years of age.

WHEREAS, your Affiant makes this affidavit and prays the issuance of an Arrest Warrant with authority to enter any premises to effect said arrest, in due form for the arrest of ANDREW JOHN JONES for the violation of the laws of the State of Florida, to wit: 3 counts of violation of F.S. 794.05(1) – Unlawful sexual activity by a person 24 years of age or older with a person 16 or 17 years of age.
