The 18th Judicial Circuit's apparent tolerance for prosecutorial misconduct.

Mr. Archer:

Recently our publication was made aware that Circuit Court Judge Steven Henderson granted a Motion to Dismiss regarding the above referenced criminal prosecution.

The Motion to Dismiss (see below linked copy) - apparently has it's foundation in allegations, that Assistant State Attorney Bryon Aven engaged in "prosecutorial misconduct" by blatantly allowing false evidence / testimony to be introduced to the jury.

The criminal defendant (Robert Cason) was criminally charged (2017) with two counts of aggravated battery involving a deadly weapon (F.S. 784.045) . Apparently – the alleged "victims" had soiled the back of Cason's taxi cab – and refused to pay the clean up cost – which lead to a physical altercation between the parties. Court records support that Judge Henderson declared a mistrial AND dismissed – with prejudice - the criminal charges against Mr. Cason.

According to available media records – in April 2021 – a Marion County judge had to similarly declare a mistrial because of inappropriate evidence being introduced to the jury by Mr. Aven.

4. The criminal prosecution of Internet media reporter Dana Delaney Loyd.
