On June 20, 2021, at approximately 0220 hours, the victim/pedestrian Passion Lucas was walking northbound in the area of Industry Road just north of the State Road 528 overpass.

At approximately the same time Suzanna Norris, suspect/driver, was driving her white in color 2009 Chevrolet Impala 4 door sedan bearing Florida License Plate 701 0YJ, VIN# 2G1WS57M9912693, northbound on Industry Road in the same area as the victim. Norris' blood alcohol level was in the 0.190 g/100 mL of blood range. Which is two times over the legal limit of 0.080, for the State of Florida.

A Florida Department Law Enforcement laboratory toxicology report shows that her blood results were as follows: The first sample shows an Ethyl alcohol, 0.190 +/- 0.015 g/100 mL if Blood (K=3, 99.7%). The second sample shows an Ethyl alcohol, 0.190 +/- 0.015 g/100 mL if Blood (K=3, 99.7%).

At approximately 0220 hours in the morning Suzanna Norris struck Passion Lucas causing Lucas to sustain serious bodily injuries. EMS personnel arrived a short time later and attempted to render lifesaving measures to Ms. Lucas. A short time later Ms. Lucas was airlifted to Holmes regional Medical Center where she was shortly thereafter pronounced deceased due to the injuries sustained from being struck by Ms. Norris.

After striking Ms. Lucas, Ms. Norris left the scene of the crash without rendering aid or waiting for law enforcement to arrive. In Ms. Norris' subsequent interview she admitted to leaving the scene and returning a short time later.

In her Post Constitutional Right interview, Suzanna Norris stated that she was the sole occupant of the vehicle at the time of the crash. She was unable to determine what she struck at the time of the crash. She went on to say it was something but she did not know if it was an object or a person. She was also unable to determine if the person was walking in or out of the roadway or if they just ran out in front of her.

During the investigation Ms. Norris is viewed on surveillance videos consuming a number of drinks that were later determined to be beer and shots. This was confirmed from credit card receipts gained through our investigation.

Due to Suzanna Norris' actions of operating a motor vehicle on the state roadways of Florida with a blood alcohol level of 0.190 +/- 0.015 g/100 mL, which is two times above the legal limit, and causing the death of
