Narrative

On November 14, 2022 the female juvenile GED instructor Mrs. Williams was checking Inmate [redacted] laptop for completed work. Mrs. Williams found several sexual and vulgar in nature pictures of Inmate [redacted] in the D block shower. Mrs. Williams notified me of the pictures that she discovered. I took Inmate [redacted] s laptop to Warden Faircloth and notified him that Inmate [redacted] and Inmate [redacted] needed to be housed separated. Inmate [redacted] was placed in rotunda cell 1 and an inmate statement was taken. While waiting on Inmate [redacted] to complete her statement she admitted to taking the photos of Inmate [redacted] in the shower. Inmate [redacted] stated that Inmate [redacted] asked her to take the photos. I asked Inmate [redacted] if they touched each other in anyway she stated "No, no way". Inmate [redacted] completed an inmate statement stating that her and Inmate [redacted] have never touch inappropriately. Inmate [redacted] and Inmate [redacted] were moved to North Wing Rotunda.

INCIDENT DOCUMENTED APPROPRIATELY. THE PICTURES THAT WERE TAKEN WERE VERY INAPPROPRIATE AND LEWD IN NATURE. THEY APPEARED TO BE TAKEN IN THE SHOWER AREA OF NORTH WING, D BLOCK. IT WAS FURTHER NOTED THAT THE LAPTOP ASSIGNED TO INMATE [redacted] HAD APPROXIMATELY 5 LOG-IN'S CREATED BY INMATE [redacted] STATEMENTS WERE TAKEN AND INDICATE NO PREA VIOLATIONS EXIST. THE LAPTOPS FOR BOTH INMATES WERE TAKEN WITH THE COOPERATION OF THE SCHOOL BOARD. THESE LAPTOPS WERE GIVEN TO THE INVESTIGATIONS SECTION FOR THE DIVISION SO THEY COULD BE GIVEN TO VSO TO INVESTIGATE AND ENSURE THEY WERE NOT COMPROMISED TO ALLOW INTERNET ACCESS AND THAT NONE OF THE PHOTOS WERE TRANSMITTED. BOTH FEMALE JUVENILES WERE SEGREGATED SEPARATELY TO PREVENT FURTHER INCIDENT. A SEPARATE DISCIPLINARY REPORT IS BEING COMPLETED FOR THIS INCIDENT.

I OBTAINED THE TWO VOLUSIA COUNTY SCHOOL COMPUTERS FROM WARDEN FAIRCLOTH'S OFFICE FOR FURTHER INVESTIGATION. IN AN ATTEMPT TO LEARN HOW EXACTLY THE ILLICIT PHOTOS WERE DISCOVERED I

CONTACTED VOLUSIA SCHOOL TEACHER LAKESHIA WILLIAMS (386-843-3375). MS. WILLIAMS ADVISED THAT SHE RECEIVED A FORWARDED EMAIL FROM CORRECTIONS IT ANALYST JOHN KOLLMER (ATTACHED) THAT WAS INITIATED BY SGT. M. DUN ON SUNDAY NOVEMBER 13, 2022. THE EMAIL WAS ADDRESSED TO J. KOLLMER AND COPIED TO CAPT. K. RILEY, SGT. S. HARRIS, SGT. N. LALASHUIS, SGT. C. KEATING AND SGT. W. HAYNES. THE EMAIL ADVISED THAT WHILE COLLECTING THE COMPUTERS FROM INMATES [REDACTED] AND [REDACTED] CORRECTIONS STAFF NOTICED MULTIPLE USER ACCOUNTS THAT DID NOT APPEAR TO BE CREATED BY VOLUSIA SCHOOLS IT DEPARTMENT. SGT. DUNN ADVISED THAT THE USERS WERE PASSWORD PROTECTED AND THAT [REDACTED] HAS A HISTORY OF HACKING AND CHANGING COMPUTER SETTINGS. MS. WILLIAMS ADVISED THAT SHE REPORTED TO THE CORRECTIONAL FACILITY ON MONDAY (NOVEMBER 14, 2022) TO REVIEW THE COMPUTERS AND CHECK ON THE STUDENTS CLASS WORK WHICH IS WHEN SHE NOTICED (NUDE/ILLCIT PHOTOS) ON THE COMPUTER THAT WAS ASSIGNED TO I/M [REDACTED]. MS. WILLIAMS ADVISED THAT SHE REPORTED HER FINDINGS TO SGT. HARRIS AS REPORTED. MS. WILLIAMS PROVIDED A COPY OF THE EMAIL SENT BY SGT. DUNN. MS. WILLIAMS ADVISED OF THE PASSWORDS THAT SHE WAS AWARE OF HOWEVER THERE WERE ADDITIONAL ACCOUNTS ON EACH COMPUTER THAT SHE WAS UNABLE TO ACCESS.

USING THE PASSWORD PROVIDED FOR I/M [REDACTED] I WAS ABLE TO ACCESS THE 'SCHOOL' PROFILE ON THE COMPUTER ASSIGNED TO [REDACTED] I CONDUCTED A BASIC REVIEW OF THE PHOTOS, DOCUMENTS AND DOWNLOADS FOLDERS. I FOUND THE PHOTOS FOLDER TO CONTAIN MULTIPLE PHOTOS AND VIDEO CLIPS THAT APPEARED TO HAVE BEEN TAKEN WITH THE ON SCREEN CAMERA. I OBSERVED SEVERAL PHOTOS OF [REDACTED] IN HER UNDERWEAR WHILE ON HER HANDS AND KNEES POSING WITH HER BUTTOCKS FACING THE CAMERA. IN THE DOWNLOADS FOLDER I OBSERVED WHAT APPEARED TO BE A SCREEN SHOT FROM SOME FORM OF ON LINE CONVERSATION WITH A PERSON NAMED CHRIS. THE MESSAGE WAS BRIEF BUT INCLUDED THE LINE "IT WORKED" AND A PHOTO OF [REDACTED].

USING THE PASSWORD PROVIDED FOR I/M [REDACTED] I WAS ABLE TO ACCESS THE "[REDACTED]" PROFILE ON THE COMPUTER ASSIGNED TO [REDACTED]. UNDER THAT USER I OBSERVED MULTIPLE PHOTOS AND VIDEO CLIPS THAT APPEARED TO HAVE BEEN TAKEN WITH THE ON SCREEN CAMERA. THESE PHOTOS ALSO CONTAINED SEVERAL NUDE/ILLCIT PHOTOS OF I/M [REDACTED] IN THE SHOWER POSING FOR THE CAMERA.

BASED ON THIS INFORMATION I CONTACTED VOLUSIA SHERIFF'S OFFICE AND SPOKE WITH DETECTIVE SETH AMRHINE AND EXPLAINED THE SITUATION. I INQUIRED INTO WHETHER THE COMPUTERS COULD BE FORENSICALLY SEARCHED TO DETERMINE IF INTERNET ACCESS HAD BEN GAINED AND IF ANY OF THE PHOTOS MAY HAVE BEEN TRANSFERED OUTSIDE OF THE JAIL. DET AMRHINE ADVISED THAT HE WOULD HAVE SOMEONE CONTACT ME. THE LAPTOPS WERE SECURED IN A LOCKED CABINET IN MY OFFICE. ON WEDNESDAY NOVEMBER 16, 2022 I MET WITH VSO DETECTIVE LANCE LAMEE. I EXPLAINED THE SITUATION AND CONCERNS WITH HIM. I PROVIDED THE LOG IN INFORMATION AND REVIEWED THE CONCERNING FILES AS WELL AS DISCUSSED OUR CONCERN WITH ANY OUTSIDE ACCESS. DET. LAMEE STATED THAT HE WOULD TAKE THE COMPUTERS AND WOULD ADVISE ON HOW HE WOULD BE PROCEEDING. BOTH LAPTOPS AND A COPY OF THE EMAILS WERE TURNED OVER TO DET. LAMEE (VSO CASE 22-21846)
