On December 29th, 2021, I placed [REDACTED] was placed under arrest and charged with Grand Theft and Resisting an Officer Without Violence, pursuant to Florida State Statutes 787.02 (1a) and 843.02, respectively.

On December 29, 2021, I responded to [REDACTED] Seminole County, Florida in reference to a sexual battery on a juvenile that had just occurred. Throughout the course of the investigation, I learned that sixteen year old [REDACTED] and her boyfriend, twenty year old Murphy Allredge had potentially committed a sexual battery against [REDACTED]. The act was interrupted by Miss [REDACTED], at which point an argument ensued. During the argument, Mr. [REDACTED] was pushed on the ground by Mr. Allredge, at which point Mr. [REDACTED] dropped his Apple iPhone 8 and the key fob to his 2021 Jeep Wrangler. As Murphy fled the area, Miss [REDACTED] took Mr. [REDACTED] cell phone and attempted to flee as well. Mr. [REDACTED] was able to catch up to Miss [REDACTED] and retrieve his phone. DOE

Continuing on December 29, 2021, I made contact with Officer Andrew Jones and Officer Preston Meyer. Officer Jones advised that while on scene, Miss [REDACTED] began getting agitated, and told them that she was going to leave and/or run. Officer Meyer advised that he told Miss [REDACTED] that she was not free to leave, and that she was being detained. Officer Meyer then placed Miss [REDACTED] into handcuffs. While attempting to handcuff her, she quickly pulled away from him and attempted to reach into her pockets, clearly resisting their efforts to control her. DOE

Continuing on December 29, 2021, I requested that Officer Tracy Fugate conduct a search of Ms. [REDACTED]'s person for the purposes of transporting her to the Winter Springs Police Department for a recorded interview. During said search, Officer Fugate located a white ski mask, a bottle of lubricant, and a key fob for a Jeep Wrangler. This key fob was identified as belonging to [REDACTED] completed a sworn statement indicating his desire to press charges against Ms. [REDACTED] for theft among other things. DOE

My investigation revealed that [REDACTED] knowingly and purposefully deprived Mr. [REDACTED] of his Apple iPhone 8 (valued at \$700.00), as well as his 2021 Jeep Wrangler key fob (valued at \$250) with the intent to permanently deprive him of their use. Furthermore, Miss [REDACTED] willfully resisted Officer Meyer's attempt to place her into handcuffs. At the time of the incident, Officer Meyer
