Two Day After Incident

NARRATIVE

On November 16, 2022, Detective LaMee responded to the Volusia County Branch Jail and met with Lieutenant Gallenkamp after the Volusia Sheriff's Office was notified two inmates had taken inappropriate photos using issued laptops.

LaMee was advised by Lieutenant Gallenkamp that a preliminary investigation revealed the following: Juvenile inmates JANE DOE and JANE were issued two laptops by the Volusia County School Board for the purpose of performing schoolwork. A sergeant at the Volusia County Correctional Facility observed multiple user accounts on the laptops at the Microsoft Windows login screen and the schoolteacher assigned to both juveniles was later notified. JANE and JANE provided the passwords for some of the additional user accounts on the laptops and inappropriate photos of both girls were discovered. The laptops were then seized and held in a secure location until arrangements could be made for them to be turned over to the Volusia Sheriff's Office for further investigation. Both juveniles were interviewed as part of an initial investigation which was forwarded to the Corrections Investigations Unit. Both JANE and JANE advised they had taken the

11 photos using the laptop cameras. Further, they indicated the photos were taken voluntarily and that no force or coercion was involved.
 12
 13 After the laptops were turned over to LaMee, they were taken to the Volusia Sheriff's Office Digital Forensics Unit for examination after proper
 14 consent was obtained for both laptops. An examination of the laptops revealed nude photographs of both juveniles, however, nothing was
 15 discovered that was identified as child pornography. Further, the examination did not find any evidence that either juvenile had sent any of the
 16 photos out to anyone. Also, none of the photos observed gave any indication that Officers at the Correctional Facility were involved.

 18 Based on the forensic examination of both devices, it was determined criminal charges would not be filed as no law violations were discovered.
 19
 20 The laptops were later returned to Volusia County Schools and were reimaged/reset in the presence of Detective LaMee to ensure all photos had
 21 been erased.
