Narrative

On 1-14-2023 at approximately 0940 hours Inmate Jackson, Nicole #1087471 started kicking her door and yelling out of her cell door. At one point Inmate Jackson stated, "I can't wait to kill y'all" and "If anyone comes in my cell I'm gonna fuck em up". Inmate Jackson has been nothing but disrespectful because she states that she is a child and the rules don't apply to her. She stated that she will tell the Department of Children and Families if any officer tries to punish her. She also stated, "I'm going to tell them that y'all(officers) have been touching me inappropriately. That my attorney has been looking at me in a sexual way so I can get him fired. I'm smarter than y'all, I'm playing my role of the sweet, innocent, little girl".

NOT GUILTY

Details

Findings

Inmate Jackson, Nicole # 1087471 was seen by DHO. Inmate agreed to attend the Disciplinary Hearing on 01/19/2023. The 24-hour Delay is noted. Inmate has been given sufficient time to prepare for disciplinary boards. As per the investigation officers report, Inmate was interviewed and given notification of the rule violations on 01/18/2023 by Inv. Lemons. DHO explained the inmate due process rights.

Per staff's report, Inmate Jackson started yelling and kicking her cell door for no reason stating "I will kill all of you. Fuck all of you, I'm going to fuck all of you up when the next time you all come into my cell. I'm going to kill all of you officers and the state prosecutors". Several other statements and threats were recorded by staff. Inmate Jackson made threats towards Officer Walters, Joyal and Hall stating " If I ever see any of you in the future, just give me a gun". while also using derogatory language calling them "Fat Bitches, Whores, and Nigger".

Staff notes that inmate Jackson was told to stop banging, kicking and yelling at her cell door, Inmate Jackson replied "Fuck the rules, All of you and Education". I don't give a fuck about anything! " I'm going to beat that Sergent ass and kill him" (Referring to Sgt. Haynes). DHO notes that Inmate makes unfounded allegations stating, "I'm going to tell that you all (officers) been touching me inappropriately; I'm trying to get my attorney fired and I'm going to tell that he looks at me in a sexual way".

DHO notes that per staff's report, these comments were made as a form of manipulation as evidence by inmate Jackson stating that she has manipulated every officer and Warden and is smarter than all of staff and just plays her role "(Acting dumb)".

During the Disciplinary hearing the following was recorded by DHO:

Charge #27A- Refusing to obey and order of any staff member: Inmate Jackson denies the allegations.

Charge # 31B- Insolence towards staff member: Inmate Jackson denies the allegations.

Charge #3AA- Threats to staff: Inmate Jackson denies the allegations.

51:Staff Harassment/ Manipulation: Inmate Jackson denies the allegations.

Inmate Jackson was alert and oriented. Inmate Jackson was seen at her cell door. It is noted that several staff members were present to include the BMU LT and SGT. Inmate Jackson was asked if she received a copy of the report and understood why she was charged with the VCDC rule violations against her. Inmate Jackson stated that she was aware but is adamant the report is not true specifically stating " I never said anything about killing anyone". No other comments was made by inmate Jackson. DHO explained the appeal process in detail to make sure that she was aware of her due process rights. Inmate stated that she understood.

DHO recommendation: Guilty based on the preponderance of evidence.

Charge #27A- Inmate Jackson refused to stop yelling and kicking her door as per the officer's report.

Charge #31B- Inmate Jackson used several profane and derogatory words towards staff such as Bitch, Whore and Nigger.

Charge # 3AA- Inmate Jackson made threats to staff to kill staff and beat staff's ass.

Charge #51- Staff Harassment/ Manipulation- Inmate Jackson made unfounded claims against staff and stated that she has manipulated every officer and Warden.

Policy Sanction: Inmate is sanctioned to (30 Days BMU). This Discipline sanction is proportionate to the offense and is the standard for all Class "AA" offense.
