AT APPROX 2300 1/2 I LET OFF BACK IN ALL BLOCKS FOR H/C AND
WALK AND CHECK EVERYTHING APPEARED NORMAL THE MINUTE ROUNDS
DIDNT TAKE PLACE DUE TO BREAK. OFF BEGON CAME ON UNIT AT
APPROX 0045 + ASSISTED WITH ROUNDS SHOWER TRUSTEES CLEANED SHOWERS WHILE
I MADE ROUNDS. ROUNDS WERE COMPLETE AT APPROX. 0115 EVERYTHING APPEARED
NORMAL AT THAT TIME. AT 0200 I LOGGED ROUNDS I INTENDED TO STAFF
ROUNDS I STARTED TO TALK TO FOLLOW OFFICERS AND LOST TRACK OF TIME
AND BEFORE I KNEW IT IT WAS TIME FOR 0300 H/C I LET OFF ZEMBA
IN THE BLOCK FOR HEADCOUNT AT THIS TIME EVERYTHING APPEAR TO BE
NORMAL. AT 0345 WE GOT 10 NEW I/M'S FROM I/D AND DUE TO PAPER WORK
AND BECA WE DIDNT GET THE 0400 ROUNDS MADE BUT I LOGGED THEM IN THE
BOOK EARLY THINKING WE WOULD HAVE TIME TO GET IT DONE. AT 0455 THE
ARREST GOT BACK I WENT TO THE REST ROOM & CHOW HALL TO HEAT
SOMETHING UP I GOT BACK CHOW WAS COMING ON THE UNIT. I DID
NOT DO CELL INSPECTION WITH PICKUP BECAUSE THEY CALL FOR THE
GREEN SHIRT TRUSTEES FOR TRASH RUN BEFORE I CAN COMPLETE CELL INSPECTION
AND LET THE TRUSTEES EAT AND WE GOT THE LAST GROUP FROM I/D
