## Public Records Volusia County Fee Schedule

"The charge is limited to actual cost of duplication of the record. The phrase 'actual cost of duplication' is defined in Florida Statutes to mean the cost of the materials and supplies used to duplicate the record, but it does not include the labor costs and overhead costs of such duplication. An exception, however, exists for copies of County maps or aerial photographs supplied by County constitutional officers which may include a reasonable charge for the labor and overhead associated with their duplication." -- *Florida Government-In-The-Sunshine Manual.*

### Volusia County's public records duplication fee policy

**Paper copies** -- The cost to duplicate paper records is 5 cents per page.

If the nature or volume of public records to be copied requires the extensive use of information technology resources or extensive clerical or supervisory assistance, or both, a reasonable service charge based on the cost actually incurred should be charged on a case by case basis. Extensive use of resources is defined as more than 15 minutes. This should be the direct hourly labor rate calculated for the Activity where the records are requested. (Please see formula below or consult Management and Budget for assistance).

**Video cassettes** -- Actual video tape cost and, if any, extensive clerical labor (see calculation sheet)

**Audio cassettes** -- Actual cassette tape cost and, if any, extensive clerical labor (see calculation sheet)


On 11-14-2013 at approx. 1747 hrs. a Code White was called on Unit-1. When I responded to Unit -1 D-Block the officers on the unit stated that the Inmate Dellechiaie, Dennis # 911893 jumped off the upper tier and landed on the lower tier. When I entered the block I observed Dellechiaie lying on the lower tier on his back yelling help me. I instructed the inmates that were standing at their door to sit down in their cells. After sufficient staff arrived I was instructed by Capt. Hunter to leave the block to go to the shift supervisor office to verify who the SDO was. I went back to the unit and told Capt. Hunter that Warden McClelland was the SDO and asked if she needed me to call him or was she. She instructed me to call him. As I was calling Warden McClelland the medical staff was placing Dellechiaie on the backboard to be transported up the stairs and to be placed on the gurney to be removed from the block. I walked down to ID/REC with staff and medical to meet Fire Services and EVAC prior to transport. I was instructed by Capt. Hunter to call back the SDO and give him an update and to get coverage for the weekend at HMC.

On 11/14/13 at 1747 I was in the clinic when a Code White Unit 1 was called. I then immediately responded to Unit 1. As I Arrived at the Officer Station the first group of Supervisors and Officers entered D-Block. I saw the officers head straight down to the left side of the lower tier. As I entered the block I could see and hear that he was alert and talking to staff. I then instructed all inmates to step away from their doors and sit on their bunks. I then sent officers up to the top tier to make sure all inmates were out of their doors. With enough staff already assisting with Inmate Dellechiaie, I turned to the officers at the Officers Station. I had staff open up both sally-port doors of D-Block to allow faster easier access to 1D-Block. I then had staff lock the entire unit down to get the inmates out of the windows. While staff were still treating Inmate Dellechiaie, Inmate Antis, Edward #908475 told staff that he would be the next to jump over the top tier. Inmate Antis continued to act in a bizarre way and staff put handcuffs on him behind his back. Inmate Antis then move the handcuffs to his front and climbed the table in his cell. I responded to his cell and entered the cell with staff moved his hands back to behind his back and had him taken to Unit 2 on a 15S. Once he was gone I was able to turn back to staff working on Inmate Dellechiaie who was alert and talking to staff as they secured him to a back board. Once on the back board he was moved to the stretcher in the dayroom and he was then escorted to ID. Once In ID/Rec Fire Rescue arrived and started treated Inmate Dellechiaie. At that point I left ID/Rec and headed back to the Shift Commanders Office to start my reports.

Upon arriving Officer Webb advised that the above named inmate jumped off the upper tier like he was performing in an agility test. I entered D-Block and medical immediately began to tend to Inmate Dellechiaie.. I instructed SCO. Wyatt to start taking names. I observed staff already in the process of checking all inmates in lockdown. I advised control via radio to call Evac as instructed by medical staff. I called Lt. Luciano using my Division issued phone for control to have direct contact with medical staff to answer all Evacs questions. Once all inmates were checked I notified control to secure the code. Inmate Dellechiaie was secured on a backboard and staff assisted medical in bringing Inmate Dellechiaie upstairs and to the gurney to be secured. I walked out of D-block while the inmate was being removed from the block and I suggested that we meet up with EVAC in ID. Upon arriving in ID we met up with Fire Services who immediately took over until Evac arrived. I was updated by Medic Serrano, who advised me that what EVAC was doing is a good sign that the inmate is stable or they would have already been gone. Evac was currently strapping his leg in velcro straps at this time. I instructed Lt. Seltz to contact SDO and make overtime arrangements with staff. All times listed on Code White Checklist. End of report.







I/M jumped from the second tier in Unit 1, upon arrival I/M Dellechiaie was on the floor complaining of his legs, I (medic ) Serrano began my initial assessment and found that he was alert and oriented to place and time, i instructed CO D'Esposito to hold C-Spine while I moved on towards my physical assessment of the I/M, I noticed that I/M Dellechiaie's Left leg was shortened and rotated outward, I performed and hip assessment and did not feel any crepitus but did feel that his hip had gotten out of place, I/M had pulses in all extremities. I told my Charge Nurse of my findings and suggested that the I/M to be transported to the hospital for futher evaluation and treatment that are beyond our facilities capabilities. I/M Dellechiaie was put on full spinal immobilization and taken to ID/Receiving for transportation via EVAC.





On 11/16/2013 @1245 hours I was at VCBJ, outside of the Control Room when I was advised by Officer M.Marcum #1009 a charge nurse at HMC stated she wanted to talk to me "it was an emergency". I spoke to a woman who identified herself as Charge Nurse, Crystal Robertson, at HMC. She gave me a return phone number 0. She advised me Inmate Dellechiaie, Dennis, #911893, had two cardiac arrest and they resulted in a poor outcome. She asked me if I wanted them to stop codes, withdrawal or continue codes. I advised her I would have to contact our medical department who could further advise her. Immediately, I went to the clinic and gave all this information to Medic John Gordon who was the Charge Nurse on duty. He contacted Dr. Gil-Pineda. I called Warden McClelland and Director, Dr.Ford advising them of the information I received. Offcier A.Digregorio #79 was advised to keep me informed of any changes in this inmate's status. At 1518 hours, Offcier A.Digregorio advised me I/m Dellechiaie was pronounced dead by RN Kim Coleman at HMC. He will file a report in this incident. Director, Dr.Ford, Warden McClelland, OPS, Lt.Gallenkamp, Booking Supervisor Sgt.Lowenstein and Medic John Gordon were notified.


