



Justification: On 7/31/12, I/M Allen was found guilty of sexual battery on another inmate, and told he would be reclassified to Heavy. He came to jail on 3/28/12 from prison, on a 10 year sentence for attempted robbery, wpn. not deadly, with a tentative EOS date of 8/10/12, his other charge is F/Lewd/lascivious conduct by person 18 yoa/older, \$50,000. While in prison he has a total of 10 DRs for lewd of lasc. exhib, and obscene profane acts. He was in SPA lock-down until 5/2/12, and he was reclassified to med-m on 6/30/12. Due to his history of lewd behavior in prison, and being found guilty of sexual battery on 7/31/12, it is recommended that he be made Heavy

Justification: This is I/M Allen's initial SCC review. I/M Allen is a 30 year old NSI, currently incarcerated on Lewd and Lascivious Conduct by Person 18 YOA/Older No Bond, charge related to action in presence of a correctional employee, and Sexual Battery (No physical force) Bond \$50,000.00. I/M Allen EOS'd from a FSP sentence 08/10/12 while incarcerated here. I/M has an extensive history of sexually related infractions at state prison and he scored high on PREA Sexual Predator Risk form. I/M Allen was approved for 30 day observation period in SPA. He was released from SPA 05/03/12 and reclassified 06/04/12. On 07/30/12, I/M Allen was found guilty of Sexual Battery on another inmate. His handling was increased 08/01/12 and he was referred back to SCC. I/M Allen was released from discipline 08/29/12 and seen on Unit 3 08/30/12. He was alert and cooperative, but he continued to claim innocence on Sexual Battery. It was explained to I/M Allen that based on Policy and Procedure 305.03, he would be referred to SPA. The appeal process was explained. Based on criminal history, disciplinary history at state, high PREA score, current charges and disciplinary charge violating 305.03 of Policy and Procedure, I recommend that I/M Allen be placed in SPA.
