The only noticeable injury Jama had was a small scrape on her right outer forearm that appeared fresh. Jama denied medical attention. Her injury was photographed. Cameron appeared excited but was extremely cooperative and made no mention of any injuries.

Jama provided the following sworn written and verbal statements: On February 22, 2019, I told my husband of five years, Jason Johnson, I was done and wanted a divorce. On February 23, 2019, we were invited out to dinner with friends. I decided we should go, we've been through worse, but we can at least manage to be civil till we're divorced. While out at dinner Jason was being verbally abusive. I was uncomfortable and did not want to be treated that way so I left. When I got home Jason called me several times. I ignored all but the last call. In the last call Jason told me "If you don't come get me you'll die tonight." My son, Cameron, overheard the phone call. Cameron locked all the doors and set the alarm. Cameron had every intention of protecting me.

When Jason arrived home he was intoxicated. Not having his keys he had to come in through the garage. Jason kicked the door to the wash/mud room several times (picture of the door to the mud room shows black marks and what looks like dry blood on the center of the door) before Cameron finally unlocked it so he wouldn't bust it down. Once in the residence Jason saw Cameron standing in the hallway holding his AR-15 rifle prepared to defend us. I stood in between Jason and Cameron so Jason wouldn't get to Cameron. That is how I received the scrape on my arm and Jason received the scratches on his neck. After the struggle Jason made it to Cameron's bedroom door by that time Cameron was already in his room. Jason kicked and punched the door several times trying to get into the room. (Pictures of Cameron's bedroom door show black marks from Jason's shoes, a crack in the door and Jason's glasses on the floor) When Jason finally walked away from the door Cameron and I left the residence.

Cameron provided the following sworn written statement: While my mom and stepdad were out at dinner with friends my mom decided to leave and come home because my stepdad was acting rude. After mom came home Jason, my stepdad, called her several times. Finally my mom answered the phone. I could hear Jason cursing and yelling. At one point Jason told my mother "If you don't come and pick me up, you won't live through the night." At that point, fearing for not only my mother's life but mine as well, knowing the training Jason has and how violent he can be, I grabbed my AR-15 rifle, loaded a mag into it and racked a round into the chamber. I was preparing to defend my mom and myself. When Jason finally arrived at the house he attempted to kick in the laundry/mudroom door. I finally went and unlocked it so he wouldn't bust it down. After unlocking it I immediately returned to my room. While in my room I heard Jason and my mom fighting. I opened my door and tried to see what was going on that's when Jason seen me and said "Fucking quit looking at me". Jason then

started to come in my direction in an aggressive manner. That's when my mom stepped in and tried stopping him. Once in my room I closed and locked my door and put all my weight against the door so Jason couldn't enter my room. Jason kicked my door several times. (Pictures of Cameron's bedroom door with black marks attached)

When asked if he wanted to provide a statement Jason refused. Jason denied all accusations that a physical disturbance occurred. Jason and Jama have been together in a domestic relationship and married for five years. They do not have any children in common. Jason had two noticeable injuries, one on the right side of his neck just below his right ear and one on the back left side of his neck. Jason stated the marks were self-inflicted. Jason also denied any medical attention.

At the conclusion of my investigation, based on physical evidence, coupled with the statements from the victim and the witness I believe Jason A Johnson violated F.S.S. 784.03.1.B Battery Domestic violence. This violation occurred in Flagler County where I am a sworn law enforcement officer.
