





On 4/17/2015 at approximately 0722 hours I received a phone call from Sgt.S.Brown #890 who was working at HMC. Sgt.Brown was one officer covering I/m Campbell, Keyshonda #947807 at HMC room 1305. He advised me the doctor wanted to speak to me. A lady identified herself as Dr.Rebecca Legg (ICU Treating Physician). Dr.Legg advised me I/m Campbell was brain dead and she is dying. She advised me she will be removing her off the ventilator and she will soon demise. Dr.Legg was requesting the family be present when the ventilator was removed. Warden Reinhart was advised and approved visitation with all security considerations. Staff was advised. SRO.D.Mitchell #688 did call me at approximately 0900 hours and advised me I/m Campbell, Keyshonda #947807 was pronounced deceased at 0855 hours. Warden Reinhart was advised. Staff coverage was canceled and they were advised to report to the S/C. SRO.D.Mitchell #688 and Officer E.Rivers #1183. Due to this critical incident both officers received an assessment from Mental Health. Medical personnel, OPS and Booking advised.




