### MOTION FOR STAY AND TOLLING OF SPEEDY TRIAL

COMES NOW, the State of Florida, by and through the undersigned Assistant State Attorney, pursuant to Florida Rule of Appellate Procedure 9.140 and moves for the entry of an Order staying proceedings and tolling the running of the Speedy Trial period and as grounds therefore would show:

- 1. The Defendant is charged in this cause with:
  - i. AGGRAVATED BATTERY ON LAW ENFORCEMENT OFFICER
  - ii. AGGRAVATED BATTERY ON LAW ENFORCEMENT OFFICER
  - iii. AGGRAVATED FLEEING OR ATT ELUDE W/ INJ OR PROP DAMAGE
  - iv. TRAFFICKING IN HEROIN OR HYDROMORPHONE (4 GRAMS TO <14 GRAMS)
  - v. POSSESSION OF SCHEDULE I SUBSTANCE
  - vi. RESISTING AN OFFICER WITHOUT VIOLENCE
  - vii. TAMPERING WITH PHYSICAL EVIDENCE
  - viii. POSSESSION OF PARAPHERNALIA
    - ix. CARRYING A CONCEALED WEAPON.
- 2. Prior to the rescheduling of a trial date, a hearing was held on the Defendant's Motion to Suppress.
- 3. As a result of the hearing held on 10/19/2021, the Court entered an Order signed on October 21, 2021, filed on October 21, 2021, granting the Defendant's Motion to Suppress.
