**NARRATIVE** The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 23 day of October, 2020, at approximately 0517  a.m.  p.m. at 200 BLOCK BEVILLE RD DAYTONA BEACH within Volusia County, violated the law and did then and there:

1 On 10/23/2020 at approximately 1651 hours, units were dispatch to 1500 Virginia Avenue in reference to a Suspicious Vehicle.  
 2  
 3 Upon arrival, I observed the vehicle that was described by central dispatch as the suspicious vehicle a blue Mitsubishi leaving the area of 1500  
 4 Virginia Avenue. The vehicle was driving westbound on Adeline Street passing my marked Daytona Beach vehicle traveling westbound on Adeline  
 5 Street. I turned my marked Daytona Beach Police Vehicle and followed the vehicle which took a right turn onto S Ridgewood Avenue, the vehicle  
 6 then took a right turn into the RaceTrac gas station, located at 1510 South Ridgewood Avenue, in the city of Daytona Beach. Where an unknown  
 7 white male exited the vehicle, walked into the RaceTrac paid for fuel came back out then proceeded to put fuel into the vehicle. Officer J. Mackenzie  
 8 arrived on scene and provided central dispatch with the tag to the vehicle which was an FL temporary tag (#CUN0498) which did come back to a Blue  
 9 Mitsubishi registered to Kary Jarvis.  
 10  
 11 While I was parked on the north end of the RaceTrac parking lot a observed the vehicle while exiting the parking lot fails to come to a complete stop  
 12 running the stop bar, from the private driveway of the aforementioned RaceTrac, onto South Ridgewood Avenue. I followed the vehicle which  
 13 crossed over two lanes to enter the southbound turning lane at South Ridgewood Avenue and Beville Road. While behind the vehicle I observed the  
 14 driver making furtive movements around the front area of the vehicle, specifically by the steering wheel and center console. As the light turned green  
 15 the vehicle turned left heading eastbound on Beville Road from South Ridgewood Avenue. I followed the vehicle and activated my emergency lights



16 and conducted the traffic stop. I exited my vehicle approached from the driver's side, while Ofc. J. Mackenzie approached the passenger side. I made  
17 contact with the driver of the vehicle who provided me with his Florida Driver's License and was identified as Kary Jarvis the defendant.  
18  
19 I walked back to my vehicle while Ofc. Mackenzie kept sight of the driver. I contacted central dispatch teletype who performed FCIC/NCIC check on  
20 the defendant driver's license which came as valid. I printed out a warning for the traffic infraction and walked up to the driver. Myself and Ofc.  
21 Mackenzie asked the defendant if we could search the vehicle and the defendant became aggressive and started stating that he had not done  
22 anything wrong. Ofc. Mackenzie advised the defendant per case law due to his furtive movements that were observed we could search the area,  
23 because we did not know if he had a weapon or drugs. The defendant became more aggressive and starting saying he wanted to speak to someone  
24 else. After numerous times of ordering the defendant to exit his vehicle, he complied and step outside. Myself and Ofc. Mackenzie advised the  
25 defendant to stand by my mark patrol vehicle while his vehicle is searched. The defendant refused and entered back into the vehicle, Ofc Mackenzie  
26 and I immediately grabbed the defendant's left arm in an attempt to remove him from his vehicle. The defendant then stated, "Fuck y'all", and  
27 immediately put the vehicle in drive and rapidly accelerated while Ofc. Mackenzie and I were holding on to the vehicle and his arm traveling  
28 eastbound on Beville Rd as not fall under the vehicle.  
29  
30 Ofc Mackenzie was dragged by the defendant's vehicle for approximately 30 feet and he was able to release from the defendant's vehicle and roll  
31 away from the speeding vehicle. I could not safely release from the defendant or the vehicle while I was being dragged.  
32 After being dragged for over 30 yards, the defendant eventually lost control of the vehicle. The vehicle swerved onto the left side bank of east Beville  
33 Street giving me an opportunity to release my grip on the defendant's arm and steering wheel. As I released myself from the vehicle I was thrown  
34 where I rolled into a tree striking the middle of my back. The defendant and the vehicle continued traveling eastbound crashing and coming to final  
35 rest into the retention ditch on Beville Street and South Palmetto Avenue. I immediately got up and pursued the defendant who was still in the vehicle  
36 after crashing it. I pulled my department-issued firearm from its holster and held the defendant at gunpoint as he exited the crashed disabled vehicle  
37 until Ofc. Mackenzie arrived. The defendant laid on the bank of the retention ditch as Ofc Mackenzie arrived I was able jumped over to the bank of  
38 the retention ditch where I was able to handcuff the defendant double locked the cuffs and checked it for tightness.  
39  
40 The defendant was complaining of injuries from the crash so he was transported to Halifax Medical Center for treatment, subsequently released, and  
41 transported to VCBJ.  
42  
43 Injuries were sustained by both myself and Ofc. Mackenzie due to the defendant's complete disregard for our safety. Myself and Ofc. Mackenzie  
44 were also taken to Halifax Medical Center for injuries sustained from this incident.  
45  
46 An inventory of the defendant's vehicle, subsequent to arrest, yielded the following:  
47  
48 Two white rock like substance was located in far left air vent and the right air vent of the vehicle on each side of the steering wheel. The white  
49 substance was tested by Ofc Mackenzie using a sirchie test kit which yield presumptive positive for the chemical presence of Heroin/Fentanyl  
50 weighing a total of 5.6 grams.  
51  
52 A white scraper with white powdery substance in a wooden box was located under the driver side front seat.  
53  
54 Two scales with a white powdery substance was located in the center console.  
55  
56 A "Gucci" brand bag was hanging from the head rest of the front passenger side seat containing numerous clear baggies.  
57  
58 A black suitcase style bag was located in rear passenger right seat containing a black plastic sealer.  
59  
60 A blue vape pen was discovered in the vehicle which was tested using a test multi drug test kit. Which came presumptive positive for THC Oil.  
61 Numerous knives were located in the center console of the vehicle readily available to the defendant.  
62  
63 The defendant was charged with two counts of Aggravated Battery with a Deadly Weapon against Law Enforcement, Aggravated Fleeing/Eluding  
64 Law Enforcement, Trafficking in a controlled Substance (Heroin/Fentanyl), Possession of THC Oil, Resisting Arrest with Violence, Possession of  
65 Drug Paraphernalia, and Unlicensed Carrying of a Concealed Weapon (several switch blades/knives/butterfly knives). One knife was a switch blade,  
66 a spring loaded knife, and four pocket knives.
