From our read of Judge Upchurch's ruling (see above web link) – she seems to be stating that if a citizen is being illegally detained by the police – that force can be applied by that citizen in order to escape that illegal detainment.

We noted that the State Attorney's Office initially appealed Judge Upchurch's ruling - but in the end - opted to abandon the appeal (see below web link).

Records further indicate - that the State Attorney's Office filed a "nolle prosequi" with the Clerk of the Court - effectively abandoning the prosecution of Mr. Jarvis (see below web link)

We (VolusiaExposed.Com) are of the OPINION that Judge Upchurch's ruling may have standing in the ON-GOING prosecution of **Iyanna Rollins**.

You should recall - in July 2022 – your Sgt. Chad Weaver arrested Ms. Iyanna Rollins (18 years of age) for battery on a LEO.

This publication expressed similar concerns regarding Ms. Rollins' encounter with Sgt. Weaver – as was experienced and expressed by convicted felon Kary Jarvis.

We are of the OPINION that Sgt. Weaver's encounter with Ms. Rollins was both an illegal traffic stop – and an illegal detainment.

We partially base our assessment on Sgt. Weaver's own recorded statements as he was attempting to secure Ms. Rollins in handcuffs – repeatedly telling her that she was not under arrest.

Given our OPINION that Sgt. Weaver engaged in an illegal traffic stop and detainment of Ms. Rollins – coupling that with Judge Upchurch's recent ruling in the Jarvis matter – then, any force used by Ms. Rollins was obviously applied to overcome the illegal actions of Sgt. Weaver.

Surely, if a thirty-nine (39) year old Caucasian male – a convicted felon – can drag two cops down the street with his car – in his attempt to flee the cops' illegal actions against him – then an eighteen (18) year old African-American female can fend off similar illegal police actions - by simply kicking at them.

Then again – maybe not – after-all - this is still Volusia County, where the police can present an apparent false narrative against two middle schoolers - about whether they ACTUALLY fired a Russian military assault weapon at deputies (see below linked article - Nicole Jackson-Maldonado prosecution).
