Incident Summary


Officers encountered subject during an in progress felony call. K9 Officer J. Martin announced his presence as well as the presence of the K9 through several loud verbal commands, K9 Martin gave subject multiple commands to lie down and warned him 4 times that the subject could be bit. Subject refused these commands and stood in the open armed with a tennis racquet. K9 Ofc. Martin deployed K9 Vezzer. Subject kicked at K9 Vezzer and wrapped his legs around K9 Vezzer's neck, choking K9 Vezzer. K9 Vezzer bit the subject in the lower left leg, below the knee. K9 Martin disarmed subject and utilized the racquet as an improvised impact weapon striking the subject several times in the head and shoulders. Subject released K9 Vezzer's neck. K9 Martin had K9 Vezzer disengage at this time. Subject refused multiple additional commands to stop resisting from several officers. Subject had a single cuff on his wrist which he swung at officers several times. K9 Lee deployed a Taser-7 probe shot, a follow up cycle (unsuccessful) and an additional cartridge. This gained temporary compliance but subject continued resisting. K9 Lee employed several closed fist strikes to the subjects back and sides, Ofc. C. Maher deployed several closed fist strikes to subject's torso. Ofc. Wiley deployed her Taser-7 (Probe shot) and two follow up drive stuns (1-ankle, 1thigh). Officers were able to then detain the subject in handcuffs. Subject sustained several small lacerations to his head as well as a bite to his lower left leg. Subject transported to Halifax for medical treatment. Once cleared medically subject transported to VCBJ. Photographs obtained. Ofc. Wiley informed Sgt. J. Maher she felt a soreness in her right arm. Sqt. Ellington completed proper paperwork to document injury.

Supervisory Review: After review of report, AXON BWC footage, photographs and other supporting documentation- No policy violation observed. (NOTE- All involved VCAT personnel had already docked BWCs and were securing at time of call.)
