
**NARRATIVE** The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 12 day of January, 2021, at approximately 0619  a.m.  p.m. at 600 blk South Ridgewood A DAYTONA BEACH within Volusia County, violated the law and did then and there:

1 commit a traffic infraction (Ran Stop Sign at South Ridgewood Avenue and South Street), and during the course of the investigation, failed to comply  
 2 with the lawful orders of law enforcement, and attempt to impede the investigation, all while unlawfully/improperly possessing cannabis under 20  
 3 grams.  
 4  
 5 On 01/12/2021 at approximately 1819 hours, I conducted a traffic stop on a gray in color Dodge Caravan, bearing FL TAG #JNSC22 (VIN:  
 6 2D4RN4DG6BR685611), after I observed the operator of said vehicle commit a traffic infraction (Ran Stop Sign), located at the intersection of South  
 7 Ridgewood Avenue and South Street. Upon approaching the vehicle, I made contact with a female (later identified by her Florida Driver's License as  
 8 Selina Scott, D1). D1 Scott demanded several times, "can you please tell me your purpose of pulling me". I explained to D1 Scott the reasoning for  
 9 the stop, and asked if there was anything in the car. D1 Scott stated that she had her, "weed license". I then asked if D1 Scott had any "weed" in the  
 10 car. D1 Scott stated that she had weed on her. I asked D1 Scott if she could take the weed out of her pocket. D1 Scott proceeded to say that she had  
 11 not done anything wrong, and proceeded to use her phone. I instructed D1 Scott to not use her phone to call someone for officer safety purposes. D1  
 12 Scott ignored said instructions, after several requests to not use her phone. D1 Scott stated she was calling her lawyer. I then requested for D1 Scott  
 13 to exit the vehicle. D1 Scott proceeded to try and close her front driver side window. I then grabbed a hold of the window, and advised that if D1 Scott  
 14 did not exit the vehicle, that the window would be broken, and she would be taken out of the vehicle. I then reached through the window, and  
 15 unlocked the front driver side door, where D1 Scott was taken into custody for resisting an officer without violence.

17 While escorting D1 Scott to the front of my patrol car, D1 Scott attempted to pull away several times, and dispatch had requested units respond  
18 emergency to me, due to D1 Scott causing a clear disturbance over the radio, during the course of being taken into custody.  
19  
20 After each attempt to transmit over the radio for units to slow down their response, D1 Scott proceeded to yell into my radio, making it difficult for  
21 responding units to understand my radio transmissions. Due to responding officer's safety concerns with responding emergency, D1 Scott was  
22 escorted onto the hood of my car. I then transmitted over the radio that D1 Scott was in custody, and that responding units could downgrade their  
23 responses.  
24  
25 Officer A. Dickens arrived on scene, and conducted a search of D1 Scott's person. In the back left pocket of D1 Scott's person was a plastic baggie,  
26 twisted at the top, housing a green leafy substance. This substance later tested presumptive positive for the chemical presence of Cannabis.  
27  
28 D1 Scott was read her Miranda Warnings, from a department issued card. D1 Scott advised she understood, and would not answer any questions.  
29  
30 Although D1 Scott has a medical marijuana card, the way in which the cannabis was contained in the plastic baggie is consistent with that of  
31 street-level sales, and was not properly housed in a labeled medical marijuana container.  
32  
33 D1 Scott was transported to the Daytona Beach Police Department beach side precinct without incident.  
34  
35 Approximately an hour and a half into processing D1 Scott's paperwork, D1 Scott complained of a head and left wrist injury, allegedly suffered while  
36 being taken into custody.  
37  
38 Sergeant J. Cerce was made aware of the incident and responded.  
39  
40 EVAC was then dispatched to the precinct, so that D1 Scott could be transported to Halifax Hospital in Daytona Beach.  
41  
42 D1 Scott stated that she also wanted a pregnancy test while getting checked by EVAC.  
43  
44 D1 Scott was turned over to EVAC moments later, and later medically cleared at the hospital.  
45  
46 D1 Scott was issued UTC #ADF55XE for the Ran Stop Sign.  
47  
48 AXON active.  
49  
50 Case cleared by arrest.  
51  
52 AXON active throughout this investigation.
