Subject: CJSTC - Our Questions & Concerns

Mr. Cox:

Thank You for your response.

I suspect you are correct - CJSTC staff should address our questions / concerns - however, absent such - we suspect that it will be appropriate to voice these concerns to the CJSTC Commissioners - "in the sunshine" - during public participation, in the up coming CJSTC meeting, while being video recorded.

We strongly hold the belief that CJSTC staff are processing officer misconduct complaints that are non-compliant with FAC11B-27 and F.S. 943.1395.

Our concerns center around the appearance that law enforcement agencies are being allowed to qualify "moral character" violations (FAC11B-27.0011) as mere "agency policy" violations - thus avoiding a CJSTC review.

In the converse - Officers are having CJSTC cases processed on them absent either a criminal conviction, or an internal investigation being completed (as per FAC11B-27 and F.S. 943.1395)
