NARRATIVE

The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 29 day of January, 2018, at approximately 0011 a.m. p.m. at 3800 YorkTowns Blvd#3505PORT ORANGE within Volusia County, violated the law and did then and there:

- There is BWC footage of this incident logged into evidence.com by this officer.
-
- On the January 29, 2018 I responded to 4545 Clyde Morris Blvd (Port Orange Police Department) in reference to a domestic battery follow up.
-
- Upon my arrival on scene, I contacted Officer Zitto who advised Alleigh Zailch responded to the police department in reference to a domestic violence incident that occurred on 1/29/18 at approximately 0008 hours. Officer Zitto informed me that Alleigh originally told the responding officer the incident was not physical and the officer observed no injuries on Alleigh; however, Alleigh now has several signs of a physical altercation. See officer Chumita's original report for details.
-
- I then made contact with Alleigh who advised she originally said the argument between her and her boyfriend, Stephen W. Szabo Jr, was only verbal in nature due to her not wanting to get him in trouble at work (Volusia County Fire Services). However, after seeing the extent of her injuries and speaking with family, Alleigh wished to report what happened during the incident. Alleigh advised she has known Stephen for seven years and the two have been in an intimate dating relationship for two years. Alleigh stated she had seen Stephen earlier in the day when he was drinking with friends and had gotten into a minor verbal altercation with Stephen over his friends not liking her. Alleigh had since left the scene and went home.
- Alleigh advised she was lying in bed around 2200 when Stephen called her cell phone telling her to open her apartment door. Upon opening the door,

16 Alleigh stated Stephen walked in and demanded her cell phone, accusing her of cheating on him. Alleigh stated she gave Stephen her cell phone and
 17 returned to her bed and got under the covers. Alleigh advised Stephen followed her to the bedroom but stayed just outside of the bedroom door.
 18 Alleigh stated Stephen became irate when he finished going through her phone and charged into her room and grabbed her by her hair in the back of
 19 her head then pulled her out of bed by her hair. Alleigh advised Stephen then pushed her into a mirror in her bedroom causing her to fall onto the
 20 floor and the mirror to hit the ground and shatter. Alleigh stated while she was on the floor Stephen got on top of her stomach, straddling her torso
 21 and placed both of his hands on her neck. Alleigh advised while Stephen's hands were around her neck he applied some pressure; however, she
 22 could still breathe. Alleigh advised at this point she began to throw her arms and legs around in an attempt to get Stephen off of her. Alleigh stated
 23 while Stephen was on top of her he said something along the lines of "This is the last time you disrespect me". Alleigh further stated after
 24 approximately one minute she was able to get Stephen off of her. Once free from Stephen, Alleigh went to the living room and attempted to get her
 25 cell phone back from Stephen. Alleigh advised Stephen refused to give Alleigh her cell phone back. Alleigh advised she wanted her phone so she
 26 could call her mom for help. Alleigh advised during this, Stephen pushed her with both of his hands, causing her to fall over the corner of a piece of
 27 furniture. Alleigh stated, while she was on the ground, Stephen once again got on top of her and placed both of his hands around her neck. Alleigh
 28 advised this time Stephen applied enough pressure to where she could not breathe. Alleigh stated her vision became blurry to where she believed
 29 she was going to lose consciousness. Alleigh advised this is when Stephen let go of her and stomped on her glasses that were on the floor after they
 30 had fallen off of her. At this point Alleigh stated she was continuously telling Stephen to leave; however Stephen would not leave due to being unable
 31 to locate his phone. Alleigh asked for her phone back so she could call Stephen's phone. Stephen still would not allow Alleigh to have her phone and
 32 became irate again. Alleigh advised Stephen then placed his hand around her chin and jaw line and slammed the back of her head into the living
 33 room wall three times. Stephen then released Alleigh and flipped over the ottoman in the living room. Alleigh was then able to obtain her phone and
 34 call Stephen's phone; where she eventually located the phone outside in the grass of her neighbor's yard. Alleigh advised she gave Steven his phone
 35 and once again told him to leave; to which he refused. Alleigh advised she then closed the door to her apartment and locked Stephen out. Alleigh
 36 stated this is when Stephen proceeded to try to kick the door in. Alleigh feared Stephen would damage the door to where it would no longer lock so
 37 she opened the door. Alleigh advised once she opened the door Stephen entered the apartment and went upstairs where he once again refused to
 38 leave multiple times. Alleigh stated this is when police arrived on scene. Alleigh advised when police arrived on scene, Stephen made the statement "
 39 I'm gonna go to prison over you".

 41 While speaking with Alleigh I observed numerous signs of a physical altercation. I observed fresh bruising in the following areas on Alleigh's body:
 42 left eye lid, both sides of her neck, right collarbone, the right side of her right breast, left bicep/tricep, right elbow, left tibia, and both knees. In
 43 addition, Alleigh also had several small lacerations/scratches on her right wrist and left elbow that appeared to be new injuries.

45 17 Digital photos were taken using Axon Capture and downloaded into evidence.com. It should be noted Alleigh also supplied numerous photos of
 46 her injuries that were taken at approximately 0200 hours on 1/29/18. These photos show bright bruising in a hand print around Alleigh's neck and
 47 arms. These photographs will be logged into evidence at POPD.

49 Alleigh completed a sworn verbal and written statement. Alleigh and Stephen were both issued a Domestic Violence Pamphlet on scene when the
 50 incident first occurred.

52 At 1742 hours Steven was taken into custody by VCSO Deputy McIntosh at his place of business and transported to VCBJ with no bond. See event
 53 number P180291767 for details.
