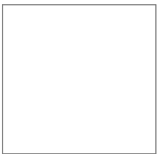

On March 27, 2017 - prior to the start of the trial - Judge Lemonidis threatened two members of our (VolusiaExposed.Com) staff with direct contempt of court (see below video).

The judge's rationale for our representatives' alleged contempt of court - centered around them taking written notes during the jury selection process - in the particular - writing down the names of the prospective jurors within their case / press notes.

Their case / press notes were impounded - and NOT returned to them until the next day.

We note that in the official Court file - available on-line - that the Clerk's official case notes for that date (see attached PDF file) included the names of ALL 30 prospective jurors.

As you may imagine - we (VolusiaExposed.Com) would have concerns - if these prospective jurors' names were recorded by the Clerk on March 27,

2017 - as a public record - and we (VolusiaExposed.Com) were being threatened with direct contempt of court for merely documenting those very same names within our press notes.

Our question to you sir - is as follows - when were these March 27, 2017 Clerk notes incorporated with the Clerk's on-line records - and when were they available for review by the public - in particular, by those members of the public that have access to these on-line court records?
