NARRATIVE

The undersigned certifies and swears that there is probable cause to believe the above-named defendant, on the 05 day of June, 2016, at approximately 1200 a.m. p.m. at 1354 INDIAN LAKE RD EDGEWATER within Volusia County, violated the law and did then and there:

1 Any employee of a county or municipal detention facility or of a private detention facility under contract with a county commission who engages in
 2 sexual misconduct, as defined in s. 944.35(3)(b)1., with an inmate or an offender supervised by the facility without committing the crime of sexual
 3 battery commits a felony of the third degree, to wit:
 4
 5 On 12/14/2016, Volusia County Corrections Division, Captain Dave Vanis, notified the Volusia County Sheriff's Office in reference to a sexual battery
 6 that occurred between the defendant, Correctional Officer Joseph Coleman and the victim, Inmate [REDACTED].
 7
 8 Captain Dave Vanis stated Coleman was a suspect in an alleged sexual incident (unrelated to VP16-30158) that occurred inside the Volusia County
 9 Correctional Facility. Through an internal investigation, Coleman was not reprimanded or terminated due to insufficient evidence and the lack of
 10 victim and witness testimony. Correctional Officer Raulerson was tasked with the responsibility to investigate the use of outgoing phone calls to
 11 Coleman's cell phone number [REDACTED]. Using the [REDACTED] phone system installed by the Volusia County Correctional Facility (to monitor all
 12 phone conversations) Correctional Officer Raulerson discovered 371 outgoing phone calls were made to Coleman's cell phone. Correctional Officer
 13 Raulerson noticed all 371 outgoing phone were made from [REDACTED].
 14
 15 Correctional Officer Raulerson reviewed all 371 outgoing phone calls between [REDACTED] and Coleman from 3/31/2016 through 7/21/2016. Correctional

16 Officer Raulerson concluded Coleman and ██████ were in an existing sexual relationship prior to arrest on 3/3/2016. Through an extensive investigation, Correctional Officer Raulerson discovered a phone conversation between Coleman and ██████ stating they were involved in sexual intercourse on 6/5/2016. The following is the conversation between Coleman and ██████ recorded on 6/5/2016 at approximately 1832 hours:

19 ██████: I just got out of the shower because I got sweaty and dirty.
 20 Coleman: It sounds
 21 like you got a penis put in you something
 22 ██████: I may actually
 23 Coleman: It's crazy
 24 ██████: It was pretty fucking amazing, like scary! So you're an adrenaline junky now are ya?
 25 Coleman: What?
 26 ██████: What? Babe, are you fucking kidding me like oh my god. That's horrible. You can't do things like that. I liked it
 27 Coleman: Yeah?
 28 ██████: Yeah. So my boyfriend has turned into an adrenaline junky.
 29 Coleman: Look. It's only jail. It's not we are on a beach or something you know.
 30 ██████: Right. It's not like it's not a criminal charge either way.
 31 ██████: You probably knocked me up today. Did you come in me? A little bit?
 32 Coleman: Yeah. I had nowhere else to put it.
 33

34 Correctional Officer Raulerson compiled statements from Coleman and ██████ conversations regarding their sexual conquests that occurred inside the Volusia County Correctional Facility. Correctional Officer Raulerson provided Investigator Ruiz with a CD of all 371 recorded conversations between Coleman and ██████, documentation of Coleman's work history, ██████'s movement history, and Correctional Officer Raulerson notes regarding key points in Coleman and ██████'s conversation. All were turned into District III as evidence. Correctional Officer Raulerson completed a sworn written statement.

40 Due to the timeframe between the incident date (6/5/16) and the beginning of the investigation (10/31/16), the surveillance footage was erased and unable to review.

43 Using ██████ database, Investigator Ruiz verified phone number ██████ is issued to Coleman. On 11/17/2016, Coleman resigned from the Volusia County Department of Corrections due to the findings of the internal investigation conducted by the Volusia County Correctional Staff.

46 Investigator Ruiz reviewed the phone calls provided by Correctional Officer Jennifer Raulerson. Investigator Ruiz compiled the following statements involving Coleman and ██████ in regards to sexual activity; to include sexual intercourse, within the Volusia County Correctional Facility:

48 On 6/5/16 at 1832 hours:
 49 Coleman: You can't be fucking me like that and just leave.
 50 ██████: Now you'll be good for a couple of days
 51

52 On 6/5/16 at 1933 hours:
 53 ██████: Is this the sexy guy I had sex with earlier?
 54 Coleman: Ya
 55 ██████: I had the sexiest man ever inside of me today
 56

57 On 6/5/16 at 2145 hours:
 58 Coleman: Conversation with ██████ about not getting caught having sex earlier "There's no way we would have got caught"
 59

60 On 6/6/16 at 1943 hours:
 61 Coleman: You know what?
 62 ██████: What?
 63 Coleman: I had sex with you yesterday
 64 ██████: Yeah
 65 Coleman: I had you up against the wall fucking you from behind
 66 ██████: I know I can't believe you did that, you're crazy



 68 [REDACTED]: You were having your cock in my hairy pussy the other day and didn't even know it because you didn't care how hairy it was
 69 Coleman: I didn't care
 70
 71 On 6/7/16 at 2102 hours:
 72 Coleman: Given the opportunity you're gonna get fucked again & in jail
 73 [REDACTED]: I know&.it's gonna be bad
 74 Coleman: It's gonna happen
 75 [REDACTED]: ok
 76 [REDACTED]: It will be fun; we will have a good time
 77 Coleman: Yes we will
 78
 79 On 6/11/16 at 1833 hours:
 80 [REDACTED]: So if they came up to you asked if you were having sex with an inmate, are you gonna tell them the truth?
 81 Coleman: I'd be like, "Fuck ya, from behind"
 82 [REDACTED]: (laughing) No you can't do that.
 83 Coleman: Why?
 84 [REDACTED]: No cause I'm gonna deny it
 85
 86 On 6/20/16 at 1835 hours:
 87 Coleman and [REDACTED] have on going conversation about her possibly being pregnant from the sexual intercourse they had inside the Volusia County
 88 Correctional Facility.
 89
 90 On 12-28-16, at approximately 1415, Investigator Ruiz traveled to [REDACTED] in reference to an interview
 91 with [REDACTED] (V1). [REDACTED] advised she and Coleman (D1) has been in a romantic relationship and has been dating for approximately three
 92 years. [REDACTED] stated the relationship continued while she was in Volusia County Correctional Facility. [REDACTED] stated she remained in a relationship
 93 but never spoke with him inside of the facility. [REDACTED] stated she maintained a relationship with Joseph through phone conversations and not an
 94 actual physical relationship because of his employment at Volusia County Correctional Facility. [REDACTED] stated they never had any sexual intercourse
 95 inside Volusia County Correctional Facility at any time.
 96
 97 Investigator Ruiz asked [REDACTED] about her recorded phone conversations with Joseph Coleman. [REDACTED] stated all of their conversations were sexual
 98 innuendo. Investigation Ruiz read the following to [REDACTED] from their recorded conversation that occurred on 6/5/2016 at 1832 hours:
 99 [REDACTED]: You probably knocked me up today. Did you cum in me? A little bit?
 100 Coleman: Yeah, I had nowhere else to put it
 101
 102 In the recorded conversation [REDACTED] is stating "I know baby&it was a pregnancy happening right then and there". The statement is referring to the
 103 sexual intercourse between [REDACTED] and Coleman inside of the VCCF.
 104 Coleman: I had you up against the wall fucking you from behind
 105 [REDACTED] repeatedly advised Investigator Ruiz the conversation between her and Coleman was sexual innuendo and role playing but no sexual
 106 intercourse occurred.
 107
 108 Investigator Ruiz asked why [REDACTED] and Coleman refer to the "mop closet" as a fun place and that they look cute there and [REDACTED] replied nothing
 109 happened inside of the "mop closet".
 110
 111 On 12/30/16, at approximately 1525, Investigator Ruiz and Investigator Turner traveled to [REDACTED] in reference to
 112 conducting an interview with Joseph Coleman (D1). Investigator Ruiz made contact with Coleman and asked him if he would like to answer
 113 questions about an incident that occurred at the Volusia County Correctional Facility. Investigator Ruiz notified Coleman that the interview was
 114 consensual and he would talk about the incident.
 115
 116 Coleman stated he and [REDACTED] have been in a romantic relationship for approximately a few years and continued dating while she was an inmate in
 117 the Volusia County Correctional Facility. Coleman stated he viewed [REDACTED] as an inmate while he was working but when he left work and talked to

118 [REDACTED] on the phone then he viewed her as his girlfriend. Coleman stated he seen her several times at the jail, "She never like worked on my shift
 119 she wasn't like a trustee or anything like that". Investigator Ruiz again asked Coleman again if [REDACTED] ever worked as a trustee and he replied, "Not
 120 on my shift". Coleman stated he failed to notify his supervisor that he and [REDACTED] were in an intimate relationship but believes his supervisor's knew
 121 about it due to other people (inmates and correctional officers) talking amongst themselves and his supervisors overhearing the conversation.
 122 Coleman stated he didn't have any physical contact and only saw [REDACTED] as an inmate. Coleman stated he never had sexual intercourse with
 123 [REDACTED]. Investigator Ruiz read the following statements between Coleman and [REDACTED]:
 124 [REDACTED]: I just got out of the shower because I got sweaty and dirty.
 125 Coleman: It sounds like you got a penis put in you something
 126 [REDACTED]: I may actually
 127 Coleman: It's crazy
 128 [REDACTED]: It was pretty fucking amazing, like scary! So you're an adrenaline junky now are ya?
 129 Coleman: What?
 130 [REDACTED]: What? Babe, are you fucking kidding me like oh my god. That's horrible. You can't do things like that. I liked it
 131 Coleman: Yeah?
 132 [REDACTED]: Yeah. So my boyfriend has turned into an adrenaline junky.
 133 Coleman: Look. It's only jail. It's not we are on a beach or something you know.
 134 [REDACTED]: Right. It's not like it's not a criminal charge either way.
 135 [REDACTED]: You probably knocked me up today. Did you come in me? A little bit?
 136 Coleman: Yeah. I had nowhere else to put it.
 137 Coleman stated he understands where the conversation "looks bad" but he advised he would be too scared to have a sexual relationship inside jail.
 138 Coleman stated he would be scared to do anything like that because of the surveillance cameras throughout the Volusia County Correctional Facility.
 139
 140 Through phone conversations, Investigator Ruiz discovered on 05/25/2016, at approximately 1857 hours, Coleman told [REDACTED], "I don't give a shit
 141 about that camera I am going to put my penis in you". On 6/22/16, at approximately 1431 hours, the conversation between [REDACTED] and Coleman she
 142 told him that the surveillance footage is only available for thirty days; after thirty days the surveillance footage is deleted. [REDACTED] advised she
 143 received information from "Sgt" the camera only runs for that limited timeframe. [REDACTED] advised Coleman, "We only have another week to make it
 144 then they can never pull that camera back out. Why does it matter the doctors are gonna know when they tell me how far along I am. They'll be like,
 145 "Weren't you incarcerated? And I'll be like, ya".
 146
 147 Investigator Ruiz asked about the conversation that occurred 6/5/16, at approximately 1933 hours, where the conversation consists of:
 148 Coleman: I guess you weren't expecting that uh
 149 [REDACTED]: No not at all
 150 Coleman: You said you wanted me in you
 151 [REDACTED]: I can't believe you did that. What would you have done if we got caught?
 152 Coleman: I would have said, "This is my girl"
 153 Coleman advised he was aware of the policy violation of speaking with an inmate even though [REDACTED] is his girlfriend. Coleman advised they only
 154 talked about "weird scenarios" but advised he never have sex inside of the jail with [REDACTED].
 155
 156 Investigator Ruiz contacted Correctional Officer Jennifer Raulerson and inquired if [REDACTED] ever worked as a "trustee" while Coleman was on duty.
 157 Coleman admitted to Investigator Ruiz he never worked in the capacity of a correctional officer while [REDACTED] was a "trustee" inmate. Correctional
 158 Officer Jennifer Raulerson provided Investigator Ruiz with documentation showing on May 30, 2016 [REDACTED] worked as a "trustee" and Coleman
 159 worked inside the Volusia County Correctional Facility. On May 31st, at approximately 1328 hours, Coleman and [REDACTED] have a phone conversation
 160 stating how they saw each other while Coleman was working. Per phone conversations, on 5/27/2016, at approximately 1941 hours, Coleman and
 161 [REDACTED] had a conversation that included the following:
 162 Coleman: Guess what
 163 [REDACTED]: What
 164 Coleman: I got to kiss my girlfriend today
 165 [REDACTED]: I know, bad, bad boy
 166 The phone conversations reflect Coleman and [REDACTED] maintained a physical dating relationship while she was an inmate while inside of the Volusia
 167 County Correctional Facility.
