BASIS FOR INVESTIGATION:

On January 12, 2015, Sergeant Sawicki received an incident report completed by Officer Erik Sargent of the Ormond Beach Police Department (OBPD). The report alleged on January 10, 2015, Deputy Bruce Workman ordered (via telephone) a pizza from a Domino's restaurant located at 343 West Granada Boulevard, Ormond Beach, FL. Deputy Workman was off duty and left the restaurant without paying for the aforementioned pizza. When Officer Sargent contacted Deputy Workman at his [Deputy Workman] residence, Deputy Workman admitted to leaving the restaurant without paying. Deputy Workman later made telephonic contact with the Domino's manager [Mr. Corey Taylor] and paid via credit card over the telephone. It was also alleged Deputy Workman had been drinking alcohol while in contact with Officer Sargent.

Chief Deputy Mike Coffin assigned the case for investigation by the Internal Affairs Unit. The Ormond Beach Police Department (OBPD) report completed by Officer Sargent is referenced by case number: OBPD150100190 and is attached and made part of this investigation. (See Tab-C)

OFFENSE(S):

26.2.129 Misdemeanor Injurious to the Department - Department personnel shall adhere to all federal, state and local laws and shall not commit any act or crime defined as a misdemeanor, first or second degree, whether chargeable or not, which brings discredit upon the Department or otherwise impairs the operation and efficiency of the Sheriff's Office and/or which is likely to impair the ability of personnel concerned to perform assigned duties. (Violation subject to dismissal.)

Volusia County Merit System Rules and Regulations 86-453 (13) - Any conduct, on or off duty, that reflects unfavorably on the County as an employer. This violation may be sufficient grounds for disciplinary action ranging from oral reprimand to dismissal, depending on the

seriousness of the offense and other circumstances related to the situation.

INVESTIGATIVE SUMMARY:

On January 12, 2015, Chief Deputy Mike Coffin assigned the above-described incident to the Internal Affairs Unit for investigation. This report details the investigation conducted by Sergeant Justin Sawicki.

On January 13, 2015, Sergeant Justin Sawicki served Deputy Bruce Workman with a Notice of Internal Investigation at the Volusia County Justice Center in Daytona Beach, FL. Deputy Workman was provided with a copy of the law enforcement officer bill of rights. (See Tab – B for Official Correspondence)

Sergeant Sawicki reviewed the incident report completed by Officer Sargent (OBPD150100190) and attached sworn written statements by Mr. Corey Taylor (manager of Domino's) and Mr. Harrison Sinex (employee of Domino's). The following is a summary of Officer Sargent's incident report:

On January 10, 2015, at approximately 1802 hours, Officer Sargent responded to the Domino's restaurant at 343 West Granada Boulevard, Ormond Beach, FL, in regards to the theft of a pizza.

Officer Sargent contacted Mr. Taylor at the restaurant. Mr. Taylor advised a white male in his fifties named "Bruce" had ordered a pizza valued at \$6.38 US Currency via telephone. Approximately thirty minutes after placing the order, "Bruce" entered the restaurant. Mr. Taylor informed Officer Sargent that "Bruce" became agitated with the amount of time it was taking to complete his transaction. "Bruce" demanded the pizza be free of charge and when Mr. Taylor denied the requestm, "Bruce" stated, "Watch this" and exited the restaurant without paying for the pizza.

Mr. Taylor provided Officer Sargent with "Bruce's" telephone number. Officer Sargent was able to determine via VCSO Central Communications (Central), "Bruce's" identity was in fact Deputy Bruce Workman. Officer Sargent was able to ascertain Deputy Workman's residential address and personal information. Officer Sargent attempted to contact Deputy Workman on two (2) separate telephone numbers and was unable to make contact on both occasions.

Officer Sargent traveled to Deputy Workman's residence in Ormond Beach, FL. Upon arrival, Officer Sargent made contact with Deputy Workman. Deputy Workman invited Officer Sargent into his residence and offered him a beverage, to which Officer Sargent declined. Officer Sargent informed Deputy Workman of his presence and that he was there for a criminal investigation in which Deputy Workman was the suspect in the theft of a pizza from Domino's. Deputy Workman advised Officer Sargent, there was a discrepancy in regards to payment of the pizza between Deputy Workman and a cashier [Mr. Sinex]. Deputy Workman informed the officer he was in a hurry because he was engrossed in a football game on the television. Mr. Taylor was summoned to assist Deputy Workman. When Deputy Workman was unsatisfied with Mr. Taylor's response to his [Deputy Workman] request, Deputy Workman stated, "whatever" and walked out of the restaurant without purchasing the pizza. According to Officer Sargent's report,

Deputy Workman apologized for the incident and advised he would return to the Domino's to purchase the pizza.

Deputy Workman was asked to provide Officer Sargent with his Florida driver's license. Deputy Workman provided the officer with his VCSO credentials. Officer Sargent clarified and again asked to be provided with Deputy Workman's Florida driver's license. Deputy Workman apologized for providing the incorrect identification and for the "mix up" at the Domino's and contributed it to being "...wrapped up in the game." Officer Sargent then wrote in his report, "while speaking with him beside his truck I could smell the strong odor alcohol coming from his breath. I told him he probably should not attempt to drive to Domino's due to being able to smell the odor of alcohol." Deputy Workman concurred with the officer and made telephonic contact with Mr. Taylor. Deputy Workman finally purchased the pizza with a credit card via telephone.

Officer Sargent returned to the Domino's and re-contacted Mr. Taylor. Mr. Taylor confirmed the credit card payment had been successful and on behalf of Domino's, he wished to no longer have law enforcement assistance.

Mr. Corey Taylor

On January 28, 2015, Sergeant Sawicki conducted a sworn recorded interview with Mr. Corey Taylor at the Domino's restaurant located at 343 West Granada Boulevard, Ormond Beach, FL. The following is a summary of that interview:

Mr. Taylor advised he has been an employee of Domino's for the past seven (7) years and is currently a manager at the aforementioned location.

Mr. Taylor confirmed he was working on January 10, 2015. Mr. Taylor advised at approximately 1800 hours, a person by the name of "Bruce" placed an order for a pizza via the telephone. Mr. Taylor was provided with a photograph of Deputy Workman, and he positively identified Deputy Workman as "Bruce."

According to Mr. Taylor, he did not observe Deputy Workman enter the restaurant as he was away from the front counter. Mr. Taylor recalled hearing Deputy Workman raise his voice toward an employee [Mr. Harrison Sinex]. Mr. Taylor stated he heard Deputy Workman raising his voice because he was irritated at the amount of time it was taking to pay for the pizza he had ordered.

After hearing the verbal dispute between Deputy Workman and Mr. Sinex, Mr. Taylor walked to the front counter to assist. Mr. Taylor described his encounter with Deputy Workman by saying, "He said he was; he wanted to pay. He was watching the game. He said it was taking too long. He said it should be free. I told him again that it was gonna be; it was \$6.38 for the pizza and he said, he basically said watch this, he took the pizza and turned out."

Upon further questioning, Mr. Taylor confirmed Deputy Workman did in fact attempt to purchase the pizza with a credit card; however, there was a computer error with the terminal. Prior to realizing the computer error, Mr. Sinex returned the credit card to Deputy Workman. When Mr. Sinex observed the error, he attempted to move to another terminal to try and

successfully make the credit card transaction; this is when Deputy Workman became irritated and demanded the pizza be free of charge.

When Deputy Workman was not satisfied and walked out of the restaurant without purchasing the pizza, he entered a pick-up truck in the parking lot and drove out of the parking lot.

Mr. Taylor stated he then contacted the VCSO Communications Center and requested law enforcement respond to the Domino's for the theft. Officer Sargent arrived and was briefed on the incident by Mr. Taylor. Mr. Taylor provided Officer Sargent with the telephone number Deputy Workman utilized to order the pizza. Officer Sargent traveled to Deputy Workman's residence, and shortly after, Deputy Workman made a telephone call to the Domino's and spoke with Mr. Taylor. Mr. Taylor advised Deputy Workman purchased the pizza via credit card by providing the card number over the telephone. Mr. Taylor advised he did not press charges on behalf of Domino's because Deputy Workman called and ultimately purchased the pizza. When asked if Deputy Workman was remorseful, Mr. Taylor said, "Yes. Very."

Mr. Taylor was asked if Deputy Workman ever presented his VCSO credentials during the encounter. Mr. Taylor stated he did not. Mr. Taylor was asked if it appeared Deputy Workman was under the influence of alcohol and he stated, "No." (See Tab - E for Official Transcript)

Mr. Harrison Sinex

On January 28, 2015, Sergeant Sawicki conducted a sworn recorded interview with Mr. Harrison Sinex at the Domino's restaurant located at 343 West Granada Boulevard, Ormond Beach, FL. The following is a summary of that interview:

Mr. Sinex has been employed with Domino's at the aforementioned location for the last five (5) months.

On January 10, 2015, Mr. Sinex recalled a male by the name of "Bruce" entered the restaurant after placing an order either via telephone or the internet. Mr. Sinex stated he contacted "Bruce" at the front counter. Mr. Sinex was shown a photograph of Deputy Workman, and he positively identified him as "Bruce." Mr. Sinex stated Deputy Workman appeared to be in a hurry as he wanted to purchase the pizza and leave expeditiously.

Deputy Workman provided Mr. Sinex with a credit card in an attempt to purchase the pizza. Mr. Sinex returned the credit card to Deputy Workman after swiping it in the terminal. He [Mr. Sinex] then observed there was a computer error, and the transaction did not process. Mr. Sinex asked Deputy Workman to move to another terminal to make another attempt at making the credit card transaction. According to Mr. Sinex, Deputy Workman became angry and stated "...10 minutes or less or it's free..." Mr. Sinex advised Deputy Workman made this comment "...a couple of times."

When Mr. Sinex was unable to rectify the dilemma, he stated he summoned his manager Mr. Taylor to assist. Mr. Sinex advised when Mr. Taylor came to the front counter, he [Mr. Sinex] walked to the back of the restaurant and was unable to hear the conversation between Mr. Taylor

and Deputy Workman. Mr. Sinex did however observe Deputy Workman remove the pizza from the front counter and walk out the front door into the parking lot. Mr. Sinex observed Deputy Workman enter a pick-up truck and later drive out of the parking lot. Mr. Taylor then contacted law enforcement at which point, Officer Sargent arrived at the Domino's and Mr. Sinex completed a sworn written statement regarding the incident.

Mr. Sinex was asked if Deputy Workman presented his VCSO credentials during the encounter. Mr. Sinex stated he did not. Mr. Sinex was asked if Deputy Workman appeared to be intoxicated and he was unsure, however he did advise he was unable to smell the odor of alcohol emitting from his person. (See Tab - F for Official Transcript)

After conducting both interviews with Mr. Taylor and Mr. Sinex, Sergeant Sawicki inquired if there was video surveillance of the incident. Both Mr. Taylor and Mr. Sinex advised the restaurant does have surveillance cameras, however they primarily focus on the kitchen area and not the front counter. Mr. Taylor also advised the surveillance footage is not stored on site, rather at a corporate location. Mr. Taylor advised he has attempted to retrieve video footage for the incident; however, Domino's corporate offices have not produced the video. (See Tab - F for Official Transcript)

Officer Erik Sargent

On January 28, 2015, Sergeant Sawicki conducted a sworn recorded interview with Ormond Beach Police Officer Erik Sargent at the Ormond Beach Police Department in Ormond Beach, FL. The following is a summary of that interview:

Officer Sargent has been employed with the Ormond Beach Police Department for nearly a year as a patrol officer.

Officer Sargent recalled being on duty January 10, 2015. Officer Sargent also recalled responding to the Domino's restaurant at 343 West Granada Boulevard, Ormond Beach, FL, for a theft of a pizza.

According to Officer Sargent, when he arrived to the Domino's he made contact with Mr. Corey Taylor. Mr. Taylor advised Officer Sargent that a male later identified as Deputy Workman entered the restaurant after making a telephonic order. When Deputy Workman felt the amount of time it was taking to purchase the pizza was taking too long, he [Deputy Workman] asked for a discount or the pizza to be free of charge. Mr. Taylor informed Officer Sargent that Mr. Harrison Sinex dealt with Deputy Workman first and later Mr. Taylor involved himself when Deputy Workman was arguing with Mr. Sinex. Mr. Taylor informed Officer Sargent that as Deputy Workman was speaking to him, Deputy Workman stated, "Watch this" and walked out of the restaurant without purchasing the pizza. Officer Sargent provided Mr. Taylor and Mr. Sinex with sworn written statements to document the incident.

Officer Sargent advised he was provided with the telephone number Deputy Workman had

utilized to make the pizza order. Officer Sargent requested the assistance of VCSO Central Communications to try and locate a person's name and/or address linked to the telephone number. Officer Sargent was advised by a dispatcher that the telephone number was linked to Deputy Workman. The dispatcher informed Officer Sargent, Deputy Workman was a government employee, however he was not informed he was a deputy sheriff. Officer Sargent attempted to make telephonic contact with Deputy Workman, however no contact was made at this time. Officer Sargent received Deputy Workman's residential address and responded to Deputy Workman's residence.

Upon arrival at Deputy Workman's residence, Officer Sargent observed a marked VCSO patrol vehicle parked in front of the residence. When Officer Sargent made contact with Deputy Workman, he invited the officer inside and offered him a beverage. Officer Sargent informed Deputy Workman he was not there to "hang out", rather he was there to investigate the theft of a pizza in which Deputy Workman was the suspect. When Officer Sargent informed Deputy Workman of his presence, Deputy Workman stated, "... he basically told me that they did have some discrepancies over the price of the pizza as it stood and that it was, how did he word that? That it was a misunderstanding and he left with the pizza. That was basically what he explained." Sergeant Sawicki then asked Officer Sargent, "Ok. So he did admit to you that he did leave with the pizza? Did he acknowledge the fact that he did not pay for it?" Officer Sargent responded, "Yes." According to Officer Sargent, Deputy Workman never informed him that he did attempt to purchase the pizza. When asked if Deputy Workman provided any other explanation for leaving without purchasing the pizza, Officer Sargent said, "The only other indication that he said was that he was in the middle of watching the football game and he was trying to get back to watch the football game."

Deputy Workman was asked to present his Florida identification at which point, he provided the officer with his VCSO identification card. Officer Sargent returned the VCSO credentials to Deputy Workman and asked once again for his Florida identification, to which Deputy Workman obliged. Officer Sargent advised when he contacted Deputy Workman, he observed Deputy Workman was drinking a beer. Officer Sargent stated he was able to detect the odor of alcohol emitting from Deputy Workman's person. Officer Sargent described the odor as, "apparent."

When asked to describe Deputy Workman's demeanor during the investigation, Officer Sargent stated:

"Initially it was cordial and friendly. When I presented him with the information you know like I said he said he offered for me to basically come inside and have a drink with him. And the game was on. And I told him I was there for business you know and we started speaking of it and he kind of turned abrupt at one point and mentioned that he was sergeant for some agency. I don't recall which agency he mentioned at the time and I told him you know basically I'm here to investigate the theft of a pizza and inquired you know the discrepancy about the pizza worth risking your career over. At which time he took more of a formal approach with it."

When asked if he would describe Deputy Workman's demeanor as rude, Officer Sargent stated,

"I don't know if I'd go so far as rude but just, abrupt would be a good word."

After several moments, Deputy Workman agreed he would purchase the pizza. Deputy Workman retrieved his vehicle keys (personal vehicle). At this point, Officer Sargent suggested Deputy Workman not drive due to his drinking of an alcoholic beverage. Deputy Workman concurred and ultimately purchased the pizza via telephone utilizing a credit card.

Officer Sargent re-contacted Mr. Taylor to confirm if the purchase was successful, to which he was advised it was. Officer Sargent stated Mr. Taylor at this time no longer wished to prosecute Deputy Workman on behalf of Domino's. Officer Sargent stated, had Domino's wished to prosecute, he would have at the least completed a SA-707 charging Deputy Workman with the theft of the pizza. (See Tab - G for Official Transcript)

Deputy Bruce Workman

On February 09, 2015, Sergeant Sawicki and Investigator Glen Bennett conducted a sworn recorded interview with Deputy Bruce Workman at the Sheriff's administrative offices in DeLand, FL. Also present during the interview was Teamster representative, Sergeant Joel Turney. The following is a summary of that interview:

Deputy Workman has been employed with the VCSO for approximately nine (9) years. Deputy Workman has held positions in patrol, civil enforceable, Daytona International Airport and is currently assigned to court security at the Justice Center in Daytona Beach, FL. Deputy Workman has no prior law enforcement experience before his employment with the VCSO.

According to Deputy Workman, he ordered a pizza from the Domino's at 343 West Granada Boulevard, Ormond Beach, FL, via telephone. Deputy Workman advised he drove his personal vehicle to the aforementioned Domino's to purchase the pizza. Upon arrival, Deputy Workman contacted Mr. Harrison Sinex. Deputy Workman described his interaction with Mr. Sinex as follows:

"I, if I, if memory serves me correctly it was very busy. There were people in the lobby and a lot of background noises. People were ordering pizza and I stood in line. I don't know for a short time and told the young man I was there to pick up a pizza, I had called it in. And initially they couldn't find the pizza and meanwhile during this time I had given him credit card to the best of my memory it was a Discover card. And he swiped the card, handed it back and asked me to move down the counter. I did. The pizza, the kid said here's the pizza, sat it down and he had made the comment I think this going to be free. I was standing there and I made the comment come on guys you know the games going to be on, I'm trying to watch this game you know ten minutes or less being in third quarter is coming on and uh this young man, he was very young I'm going to guess him at the best, I won't remember what his birthdate is, I saw it but late teens possibly early 20's and I made a comment, I'm paraphrasing. I said I don't care whether it's free or not, get the manager I want to watch this game. You know I was obviously in a hurry because I had deliberately timed that to pick it up so I

wouldn't miss any of the ball game."

Deputy Workman stated when the manager [Mr. Corey Taylor] came to the counter, he could not recall the brief conversation. Deputy Workman described the remainder of the encounter by saying:

"The manager he just stood there and I don't recall really talking to him because like I said there was a lot of noise back and forth and I have a significate hearing loss. And you know I'm standing right there and I said come on guys whatever. You know ten minutes or less this ball game is going to be back on and uh I thought the pizza was paid for. I picked the pizza up. I turned and walked out and I was parked in plain view in front of the store and I do remember when I got in my POV, privately owned vehicle. I took a second to look at text messages and you know see if I had any new text message or voice mails because typically you know I'll bet friends lunch or something on ball games and it was a very exciting game and I did not try to leave Domino's in a hurry and at no point did an employee from Domino's come out and say Bruce we need to re-swipe. I mean there was every opportunity because quite frankly Sergeant Sawicki, I want to get, well we are on record. There is no way I would embarrass this agency over a \$5.99 carry-out pizza."

Deputy Workman was asked to confirm his statement, "Ten minutes or less or it's free." Deputy Workman advised at no time did he say, "Ten minutes of less or it's free." Rather, he was referring to the football game's second half beginning in ten minutes or less, which is why he was in a hurry to exit the restaurant.

Deputy Workman was asked what indication he had from Domino's employees that the pizza had been paid for. Deputy Workman advised he thought the credit card transaction had been successful when Mr. Sinex returned his credit card to him. Deputy Workman was asked if he signed anything for the transaction or received a receipt. Deputy Workman stated, "No" to both queries. Deputy Workman continued to state "...and a lot of places depending on the amount you put on a credit card, there's nothing to sign anymore." According to Deputy Workman, at no point during the encounter did Mr. Sinex nor Mr. Taylor advise him the credit card transaction was unsuccessful due to computer error. Deputy Workman reiterated he had assumed the transaction was successful when Mr. Sinex returned his card to him.

After leaving the Domino's, Deputy Workman returned to his residence. While at his residence, a short time after returning, Officer Erik Sargent made contact with Deputy Workman. Deputy Workman stated he asked Officer Sargent if he wished to enter his residence and if he wanted water or a soda. Deputy Workman recalled Officer Sargent declined both offers and informed him he was there to investigate the theft of a pizza in which Deputy Workman allegedly was the suspect. Deputy Workman stated he informed Officer Sargent there was a misunderstanding as he assumed he had paid for the pizza.

During the encounter, Officer Sargent asked Deputy Workman for his identification. Deputy Workman confirmed he did provide Officer Sargent with his VCSO identification card. When

asked why he presented his VCSO credentials in lieu of his Florida driver's license, Deputy Workman informed investigators that he does not carry a wallet. He keeps all of his identification and credit cards clipped together with a "gator" style clip. Deputy Workman advised his VCSO identification card is on top of the stack of cards, and he merely produced it as a convenience, because it was the first card in the stack. During the interview, Deputy Workman did produce the aforementioned stack of identification and credit cards. Sergeant Sawicki observed the cards were held together with a "gator" style clip and his VCSO identification card was on top of the stack.

After Officer Sargent completed a wanted person's check via VCSO teletype, he asked Deputy Workman if he was going to "make it right" referring to purchasing the pizza. Deputy Workman advised the officer he would most certainly pay for the pizza at which point, he retrieved his vehicle keys (personal vehicle). As Deputy Workman retrieved his keys, Officer Sargent stated, "You've been drinking." Deputy Workman stated in lieu of driving back to the Domino's, he retrieved his telephone and placed a call to the Domino's. Deputy Workman stated he introduced himself when Mr. Taylor answered the telephone and apologized for the confusion. Deputy Workman then provided his credit card number to Mr. Taylor, and the purchase was successful.

Deputy Workman was asked about a statement written in Officer Sargent's incident report that stated, "Workman added the manager was called over and there was a discrepancy about the amount to be paid for pizza, at which time Workman told me he said whatever and walked out without paying for the pizza." Deputy Workman's response was, "That was when I thought the credit card transaction had went through. I asked for some cheese, some napkins and some pepper. And my thought was the credit card transactions went through. I don't care if they credit the credit card or not for \$6. I said whatever guys I'm going to watch the game and that's when I picked the pizza up and walked out. There was no attempt to flee with that pizza. I mean I casually walked to my vehicle, parked in plain view." Deputy Workman later stated, at no point did he ask Officer Sargent to provide him with a ride to the Domino's to purchase the pizza. Deputy Workman also stated Officer Sargent's report "is not accurate."

Deputy Workman was asked how much alcohol he had consumed on January 10, 2015. Deputy Workman advised he did not begin consuming alcohol until he arrived to his residence after traveling to the Domino's. Deputy Workman stated further, that when he was contacted by Officer Sargent, the beer that the officer observed was the first and only alcoholic beverage Deputy Workman consumed prior to and during the encounter with the officer.

Deputy Workman was questioned if he felt he violated the below listed policies regarding this investigation. The following are his responses to the alleged violations:

26.2.129 Misdemeanor Injurious to the Department - Department personnel shall adhere to all federal, state and local laws and shall not commit any act or crime defined as a misdemeanor, first or second degree, whether chargeable or not, which brings discredit upon the Department or otherwise impairs the operation and efficiency of the Sheriff's Office and/or which is likely to impair the ability of personnel concerned to perform assigned duties. (Violation subject to dismissal.)

Volusia County Merit System Rules and Regulations 86-453 (13) - Any conduct, on or off duty, that reflects unfavorably on the County as an employer. This violation may be sufficient grounds for disciplinary action ranging from oral reprimand to dismissal, depending on the seriousness of the offense and other circumstances related to the situation.
