Applications submitted after the deadline will not be considered. All applicants must have been members of The Florida Bar for at least 10 years, electors of the state of Florida and be residents of the Fifth District Court of Appeal prior to taking office.

The Judicial Application (which can be downloaded from the governor's website) must include:

- An original and 10 printed copies of the application;
- One Digital (electronic) copy of the application (either as a .PDF or in Microsoft Word) to msasso@sasso-law.com;
- One Digital (electronic) copy of the application with personal information redacted in a format suitable for submission in response to public records requests;
- A recent photograph;
- Letters of recommendation applicants wish the commission to consider, however, these letters may also be sent as supplements, after the application is submitted;
- Copies of the applicant's completed federal income tax returns for the preceding three years or current financial statement and financial history. Note: if an applicant is practicing law as a professional association, tax returns for the three-year period should include the tax returns for the professional association;
- Any additional information applicants feel may be helpful to the commission in assessing qualifications.

After the deadline, the commission will determine which applicants to interview. Applicants to be interviewed will be contacted to confirm the date, time, and location.

All proceedings of the Judicial Nominating Commission are open to the public except for deliberations. Accordingly, applicants should not expect their applications to be kept confidential.
