NOTE TO APPLICANTS: All questions in the application must be answered fully and completely. Applications should include current and accurate contact information for judges, cocounsel, opposing counsel, and references because those individuals will likely be contacted.

The deadline for submission of the application is October 18, 2021 at 10:00AM. Incomplete or non-functioning electronic copies of the applications and applications received after the deadline may not be considered.
