22. Describe the general nature of your current practice including any certifications which you possess; additionally, if your practice is substantially different from your prior practice or if you are not now practicing law, give details of prior practice. Describe your typical clients or former clients and the problems for which they sought your services.

I practice both civil and criminal law. I have represented insurance companies and their insureds. A typical case was when an insurance company after a thorough investigation paid money to an insured for his/her property damage and/or personal injuries sustained from an automobile accident caused by the negligence of another. On behalf of the insurance company and insured, I would file suit against the tortfeasor to recover the money the insurance company paid to the insured under the property damage and/or uninsured motorist claim and the deductible the insured paid pursuant to the policy. I have tried many of these types of cases and have been very successful in achieving favorable verdicts for my clients.

I have also represented local hospitals. A typical case was when a hospital incurred expenses for medical treatment rendered to a patient who then failed to pay his/her medical bill. On behalf of the hospital, I would file suit against the patient to recover the amount of the unpaid medical bill. I would also file suit against certain insurance companies who paid money to a third party over my client's hospital lien.

I have represented local financial institutions. A typical case was when a borrower defaulted on a loan. On behalf of the financial institution, I would file suit against the borrower to recover the balance of the loan. I have tried many of these types of cases and have been very successful in achieving favorable verdicts for my clients.

I have represented local contractors. A typical case is when a homeowner breaches a contract with the contractor. On behalf of the contractor, I would file suit against the homeowner to recover the balance due under the contract. In the complaint, I would normally allege claims under the mechanic's lien law and breach of contract.

I also represent individuals who are charged with simple misdemeanors and serious felonies. These individuals are minors and adults of different ethnicities and socioeconomic levels. I conduct thorough investigations into the allegations made against my clients so that I can provide competent legal advice for them to make informed decisions on how to resolve difficult situations.
