**PROBABLE CAUSE**

On Sunday, May 5, 2019, at approximately 5:50 PM I observed a brown Chevrolet truck bearing Florida tag Y84JLQ traveling west on US Hwy 90 in the area of Marion St. On the back window I observed white letters that stated: "I EAT ASS". This sticker violates Florida State Statute 847.011 (2) which is a second-degree misdemeanor. I then proceeded to conduct a traffic stop on this vehicle.

Upon contact with the vehicle, I observed two white male in the cabin of the truck. The driver was identified by Florida I.D. as Dillon Shane Webb who is also the registered owner of the vehicle. The passenger was identified by Florida I.D. as Alan Zeman.

While speaking with the occupants and informing Dillon of the reason for the traffic stop, Dillon became very defensive about the sticker on his truck and stated: "Their just words." I then asked Dillon how a parent of a small child would explain the meaning of the words "I EAT ASS". Dillon then told me that it would be up to the parent.

Due to the derogatory statement of the back of Dillon's window, I am issuing him a notice to appear (NTA) on May 23, 2019, at the Columbia County Courthouse. Report number CCSO19OFF001969 will accompany this NTA.

Photos of Dillon's sticker was taken and will be placed into evidence at the Columbia County Sheriff's office to be attached to this report.

After issuing Dillon his notice to appear, I allowed him to remove one of the letters from the word "ASS" so the statement would no longer be derogatory. Dillon refused and informed me he would not remove the sticker because of his first amendment right. I then detained Dillon and placed him in the back of my patrol car. Due to the statement on the back of Dillon's truck, I requested a tow truck by rotation. Davis Towing arrived on scene and removed Dillon's truck.

Dillon was then transported to the Columbia County Detention facility without incident where he was charged with Obscene writing on vehicles and resisting an Officer without violence.

I have nothing further to report.
