

On that date, your Affiant met with and his mother at their home located in Palm Coast, Flagler County, Florida. confirmed he has a Facebook account in the name which he created approximately two and a half years ago is unaware of anyone else with a Facebook account utilizing the same name as his was 14 years old at the time the above Facebook messages were exchanged.

Your Affiant also found in the Facebook search warrant results that between December 1, 2012 and December 3, 2012, the Facebook profile exchanged messages with the Facebook account During this message exchange, the Facebook profile stated "Can I see ur dik" and "Can u take a pic of it now". The Facebook profile stated "she" might give "some head" if he sent the picture. sent a picture of a black male's post-pubescent erect penis. Based on the foregoing, your Affiant believes there is probable cause to believe that the suspect did knowingly compile, enter into, or transmit by use of a computer, any notice, statement, or advertisement of any minor's name, telephone number, place of residence, physical characteristics, or other descriptive or identifying information for purposes of facilitating, encouraging, offering, or soliciting sexual conduct of or with any minor, or the visual depiction of such conduct, a violation of Florida State Statue 847.0135(2)(a). Your Affiant also believes

there is probable cause to believe that the suspect did willfully and without authorization fraudulently use, or possess with intent to fraudulently use, personal identification information, to wit:
