We (VolusiaExposed) currently have some concerns:

In regards to Ofc. Kelley's 2013 reprimand - for not documenting domestic violent incidents (see attached PDF) – the reprimand states, that such a failure was an “agency policy” violation – but in truth, isn't there also a statutory requirement to document all DV incidents (F.S. 741.29)?

Is it the position of DBPD, that Ofc. Kelley “forgot” both (the agency policy and statutory requirements)?

VolusiaExposed.Com has great interest in situations whereas law enforcement officers have possibly violated state laws or constitutional mandates – and the employing / investigative agency relegates the violations to mere agency policy violations.

Since the Morrison incident started out originally as a DV incident (Oct. 2012 - Ofc. Kelley's initial involvement) – we wish to explore

whether Ofc. Kelley was “unaware” of other legal requirements attached to DV cases, and maybe, also in use of force application cases (ref. To the 2011 tasing incident – failure to properly report / acknowledge his level of responsibility) (see attached PDF)

Chief, frankly we are still haunted by Officer Kulenek's testimony at VCSO Deputy Scott Flesch's personnel board hearing (see below linked youtube videos) . She testifies that she was NOT in pursuit of off duty Deputy Flesch, and that he pulled his vehicle over immediately after she activated her patrol car lights – but Flesch was still criminally charged with felony – fleeing and eluding.
