Velez observed a six pack of Shock Top beer with three full bottles and with three bottles missing from the six pack which was located on the passenger side floor board of passenger seat. Ofc. Velez re-contacted Wilson as he suspected Wilson was impaired. Officer Velez asked Wilson to exit the vehicle. Wilson exited the vehicle slowly and leaned on his vehicle as he staggered while walking and swayed while standing. Velez asked Wilson to submit to a series of Field Sobriety Exercises, Wilson agreed to attempt the exercises. The Field Sobriety Exercises were videotaped by Officer Kortright and the videotape was submitted into POPD evidence. Wilson showed the following signs of impairment (see FSE video and DUI Processing Form for further details): Horizontal Gaze Nystagmus-Officer Velez observed lack of smooth pursuit, distinct and sustained Nystagmus at maximum deviation and onset of Nystagmus prior to 45 degrees in both eyes. Wilson was unable to keep his head still and had to be reminded to follow, the stimulus with eyes only. Walk and Turn- Wilson could not maintain balance during instructions, missed heel-to-toe, stepped off the line, took the incorrect amount of steps, first by taking 21 steps forward, Wilson took 2 steps backward before turning around incorrectly and taking 14 steps back the opposite direction. One Leg Stand- Wilson used arms to balance (raised more than 6 inches), put foot down three times, Wilson lost balance using his right leg and switched to his left leg and did not lift his foot from the ground. The exercise had to be terminated for Wilson's safety. Based on the totality of Ofc. Velez's investigation, Wilson was placed under arrest for Driving Under the Influence and was asked to submit to a breath test wilson erfused to submit to a breath test and was read the Florida implied Consent Warning. Wilson acknowledged that he understood the warning and consented to a breath test the second time. Wilson was read the Miranda Warning and acknowledged that he und									
	had already taken the breath test. (see Ofc. Velez's supplement report for further details) Wilson was issued Florida DUI Citation #AOF2HQE for Driving Under the Influence and Florida UTC #A47H73E for the traffic violation. Wilson has one prior conviction for DUI on 01/24/2003 from Port Orange Police. While completing this Charging Affidavit, Wilson had a medical emergency and was transported to Daytona Halifax via EVAC (see case #15-7939 for details).
