Debbie / Chief Thomas:

Thank You for your responses.

It's very interesting and odd that no other documents or records exist to memorialize what the exact allegations were against Lt.

Sampsell.

F.S. 112.532 requires that all interviews of law enforcement officers facing disciplinary action be recorded. Are you saying that no such records exist? Lt. Sampsell's demotion letter appears to indicate that such an interview transpired. So where is the recording?

I have attached two PDF files that might be of some interest to you.

The PDF file titled "Issue-40" is a May 2010 document from FDLE / CJSTC - on the bottom of page 2 it describes the obligations of law enforcement agencies to investigate suspected violations of FDLE / CJSTC moral character standards (FAC 11B-27.0011).

The other attached PDF file is a blank copy of a CJSTC 78 form - which is mandated to be filed upon the completion of all internal investigations of law enforcement officers. Is there also no CJSTC 78 form on file?

VolusiaExposed files this public record request for a copy of the recorded interview of Lt. Sampsell, and his CJSTC 78 form filed on this particular matter.

Absent those records - we request an explanation of why per our suspicions, Florida Statutes and Florida Administrative Code were not properly adhered to by OCPD officials, and why these suspicions are not justified.

Finally, your assurances that the allegations lodged against Lt. Sampsell did NOT involve allegations of sex on duty and / or sexual harassment (both violations of FAC 11B-27.0011), would go along way of relieving much of our concerns.

Our rationale for inquiring is that both (sex on duty / sexual harassment) would be moral character violations - as defined in FAC 11B-27. In that regard, were the allegations against Sampsell memorialized in any additional documents, to include, but not limited to a CJSTC 78 form, letter of complaint, investigative documents, etc. ? If so, please consider this email as our public record request for those documents.

Officer Sampsell is well known to us - and it is NOT our desire to bring any further embarrassment to him - rather we wish to ensure that the OCPD followed proper FDLE / CJSTC procedures regarding possible police misconduct.
