
MAN ARRESTED FOR MURDER NEAR ORANGE CITY

The Volusia County Sheriff's Office arrested a 29-year-old man early this morning for the Saturday night murder of Lucienne Northern near Orange City, Gregory Duvall of 513 Weston Place, DeBary was arrested at his home without incident at approximately 3 a.m. Duvall was charged with 2nd degree murder and booked into the Volusia County Branch Jail in Daytona Beach, An autopsy for Northern is scheduled for Monday morning.

Sheriff's Office deputies were called out to Dale's Ale at 2400 N. Volusia Ave., Orange City at 8:28 p.m. Saturday when the mortally wounded woman from DeLand was found in the parking lot. Moments later deputies and paramedics arrived but Northern was pronounced dead on scene at 8:46 p.m.

Witnesses reported seeing the 38-year-old victim verbally arque with Duvall inside the bar and then they both left separately. A patron went outside a few moments later. saw Northern injured in the parking lot and had an employee call for help. Investigators were able to track down Duvall based on on-scene evidence and witness statements.


