We (VolusiaExposed.Com) have come into some knowledge - that apparently while juvenile defendant N [REDACTED] was being held in custody at the **Volusia DJJ juvenile facility** (June - August 2021) - DCF conducted an investigation of whether [REDACTED] (and other children) had been sexually molested by a DJJ staff member.

According to the DCF Investigative Summary (2021-224764-01) - DCF notified "law enforcement" of the sexual molestation allegations.

The Volusia's DJJ facility falls within VSO's geographical jurisdiction.

Please accept this as a public record request (PRR) for any documents that would support that the VSO was notified by DCF - AND / OR that VSO conducted an investigation into these sexual molestation allegations.

We (VolusiaExposed.Com) desire to re-visit - and follow-up on - our Decmeber 22, 2022 article covering the alleged sexual molestation of Ms. [REDACTED] while housed at the **Volusia County Jail (adult correctional facility)**.




