
COUNT I: MICHAEL T WEBB on or about October 18, 2023, in the County of VOLUSIA and State of Florida, while in possession of a firearm, did intentionally, unlawfully and knowingly threaten by word or act to do violence to the person of BEAU WESTFALL, knowing BEAU WESTFALL was a law enforcement officer who was engaged in the lawful performance of a duty, coupled with an apparent ability to do so, which created a well-founded fear in BEAU WESTFALL that such violence was imminent, contrary to Florida Statutes 775.0823(10), 784.07(2)(c), 784.021 and 775.087(2). (2 DEG FEL)

COUNT II: IN THAT MICHAEL T WEBB on or about October 18, 2023, in the County of VOLUSIA and State of Florida, while in possession of a firearm, did intentionally, unlawfully and knowingly threaten by word or act to do violence to the person of BRIAN G SANTIAGO, knowing BRIAN G SANTIAGO was a law enforcement officer who was engaged in the lawful performance of a duty, coupled with an apparent ability to do so, which created a well-founded fear in BRIAN G SANTIAGO that such violence was imminent, contrary to Florida Statutes 775.0823(10), 784.07(2)(c), 784.021 and 775.087(2). (2 DEG FEL)

COUNT III: IN THAT MICHAEL T WEBB on or about October 18, 2023, in the County of VOLUSIA and State of Florida, did wantonly or maliciously shoot at, within, or into a public or private building located in VOLUSIA County, Florida, contrary to Florida Statute 790.19. (2 DEG FEL)

COUNT IV: IN THAT MICHAEL T WEBB on or about October 18, 2023, in the County of VOLUSIA and State of Florida, did wantonly or maliciously shoot at, within, or into a public or private building located in VOLUSIA County, Florida, contrary to Florida Statute 790.19. (2 DEG FEL)
