COUNT I

CHARGE: FIRST DEGREE MURDER, in Violation of F.S. 782.04(1)(a)1

<u>SPECIFICATIONS OF CHARGE</u>: In that JAMES DESMOND BOOTH, on or about the 25th day of January, 2011, within Volusia County, Florida, did then and there unlawfully, while acting from a premeditated design to kill Debra Gibson, kill and murder Debra Gibson, a human being, by shooting her with a firearm.

COUNT II

CHARGE: TAMPERING WITH A WITNESS, in Violation of F.S. 914.22(1)(a) and / or (e) & 914.22(2)(c)

SPECIFICATIONS OF CHARGE: In that JAMES DESMOND BOOTH, on or about the 25th day of January, 2011, within Volusia County, Florida, did then and there knowingly use intimidation or physical force, or threaten Debra Gibson, with the intent to cause or induce Debra Gibson to withhold testimony from an official investigation or official proceeding involving the investigation or prosecution of a Second Degree Felony and / or hinder, delay, or prevent the communication of a law enforcement officer or judge of information relating to the commission or possible of commission of an offense or a violation of release pending a judicial proceeding, involving the investigation or prosecution of a Second Degree Felony.

HICKSON, on or about the 25th day of January, 2011, within Volusia County, Florida, did then and there knowingly use intimidation or physical force, or threaten Debra Gibson, with the intent to cause or induce Debra Gibson to withhold testimony from an official investigation or official proceeding involving the investigation or prosecution of a Second Degree Felony and / or hinder, delay, or prevent the communication to a law enforcement officer or judge of information relating to the commission or possible commission of an offense or a violation of release pending a judicial proceeding, involving the investigation or prosecution of a Second Degree Felony, or JESSICA L. HICKSON did aid, abet, counsel, hire, or otherwise procure such offense to be committed.
