

Violation of Special Condition (20) of the Order of Sex Offender Probation, by failing not to view, access, own or possess any obscene, pornographic or sexually stimulating visual or auditory material, including telephone, electronic media, computer program or computer services relevant to the offender's deviant behavior, and as grounds for belief that the offender violated his probation, Officer Kelley states that on 7/1/13 the offender was in possession of pornographic images as evidence by the material found on the offender's cell phone.

Violation of Special Condition (29) of the Order of Sex Offender Probation, by failing not to access the internet or other computer services, and as grounds for belief that the offender violated his probation, Officer Kelley states that since 1/4/13 the offender has been accessing the internet on a consistent basis as evidenced by a search of the offender's cell phone on 7/1/13.

Violation of Special Condition (30) of the Order of Sex Offender Probation, by failing to abide by the rules of electronic monitoring, and as grounds for belief that the offender violated his probation, Officer Kelley states that from 3/30/13 thru 6/29/13 the offender had several electronic monitoring violations, as evidenced by GPS tracking.

On 8/30/10 the offender was sentenced by the Honorable Joseph G. Will in Volusia County Circuit Case# 09-32968CFAES to a term of three (3) years state prison with credit for 138 days time served followed by a period of four (4) years sex offender probation for the offense of Lewd or Lascivious Molestation. On 12/22/12 the offender was released from prison and began the probation portion of his sentence.
