Sorry, but we must modify our dates regarding any CJSTC 61, 61A and 78 forms being on file regarding a former Volusia County Sheriff Deputy - Michael Sawicki.

Please consider the time frame of September 2011 to March 2013.

In September 2011 - we have documents that tend to support that he was being investigated for driving his patrol car under the influence of alcohol.

In July 2012 - we have documents that tend to support an arrest for domestic violence.

In August 2012 - we have documents that tend to support that he was engaging in sex while on duty.

We (VolusiaExposed.Com) are preparing to post an article questioning whether the Volusia County Sheriff Department properly reported these

concerns, as is apparently mandated by FAC 11B-27 and F.S. 943.

All of the above allegations appear to be probable moral character violations, as are defined in FAC 11b-27.0011 - thus mandating the above request forms (CJSTC 61, 61A, 78) to be filed by the employing agency with the CJSTC / FDLE.

We are in possession of what appears to be a CJSTC 61 form attached to the August 2012 incident.

However, this form appears to be filed incorrectly, indicating that Deputy Sawicki resigned while being investigated merely for an agency policy violation - while the above linked August 2012 VCSO report clearly indicates allegations of sex while on duty. (Sex on duty is defined as a moral character violation within FAC11B-27.0011)

Your assistance in fulfilling this PRR, will greatly assist us in properly understanding whether the VCSO maintained proper compliance with Florida Law, attached to their responsibilities to properly investigate and report these allegations to CJSTC / FDLE.
