I am in receipt of several recent e-mails from you, dated February 28, March 1, March 6 and March 8, in which you raise questions related to former deputy Michael Sawicki. This shall serve as my response to all of those e-mails and the questions contained therein:

-An internal investigation into the Sawicki matter was conducted, in compliance with F.S. 943.1395(5). You have been provided with the ROI associated with the investigation, and any suggestion that we did not comply with the applicable statutes is false and incorrect.

-The original CJSTC Form 61 affidavit of separation was sent to FDLE.

-After review, we concur that the box indicating a voluntary separation while being investigated for a moral character violation more accurately reflects the conditions of Sawicki's separation. We thank you for bringing this to our attention, and accordingly, we are in the process of making that change to the Form 61 on file with FDLE.

-I have not located any additional investigative reports.

Heard from FDLE / CJSTC (see below email) - they appear to be saying that the only CJSTC 61, 61A or 78 forms they have on file for Deputy Sawicki is the 78 form attached to former Deputy Deane's 2012 DV arrest.

Was the Sept. 4, 2012 CJSTC 61 form signed by L. Bounds filed with the CJSTC? (You provided us this form some days ago - see below web link to form). I seem to recall that Florida Law requires that these forms (61) be filed with the CJSTC / FDLE within 45 days of the LEO's departure from employment.
