NARRATIVE / CONTINUATION

1 On 08-23-2014, at approximately 1514 hours, Deputy Matusick responded to the 106 mile marker of westbound I-4. Upon arrival, Deputy

2 Matusick met with Deputy Luoma. Deputy Luoma advised that he received a positive narcotics alert from his partner K-9 Jago on a box/moving

3 truck that was stopped by Florida Highway Patrol. Deputy Matusick observed that most of the items in the back of the box truck had already been

4 removed and were on the side of the roadway.

5 Deputy Matusick deployed K-9 Baeron in the back portion of the box truck. K-9 Baeron was allowed to work the back of the box truck on his own,

6 without any direction from the handler. Deputy Matusick observed K-9 Baeron begin to show an obvious change in behavior towards the front right

7 side of the truck. K-9 Baeron's mouth closed and his tail began to wag as he sniffed a narrow space between a stack of boxes and a dresser that

8 was located at the front of the truck. K-9 Baeron sat with his nose to that area and stared. This behavior indicated "an alert" to Deputy Matusick

9 that K-9 Baeron located the presence and/or odor of an illegal narcotic. Deputy Matusick placed K-9 Baeron back into her patrol vehicle and


10 assisted Florida Highway Patrol in searching the remainder of truck.

11 A search of the remaining items were met with negative results.

12 Deputy Matusick assisted Florida Highway Patrol in loading the contents back into the truck; however delays from the movers and inclement

13 weather prevented all of the items from being placed back onto the truck.

14 No further action taken by Deputy Matusick or K-9 Baeron.
