The victim in this case, Bryan Payne, along with his mother, Mary Payne, contacted the Orlando Police Department on the night of 1-28-11 and requested a supervisor to respond to their home in reference to a complaint on an officer. Sgt. Jose Velez supervisor of the Gang Unit responded to the Payne Residence. Bryan Payne completed a "Citizen's Complaint Form" that Sgt. Velez provided. Payne indicated in his complaint that on 1-28-11 he was in from of McCoy Elementary School, at 5255 S. Semoran Bv., when he was confronted by Officer Candelaris who threw him against a wall, threw him to the ground, punched him in the mouth, searched him and then told him to go home. Officer Candelaria accused him of being in a car that ran from him earlier. Sgt. Velez took photos of Payne and his lip area that he said was injured when he was struck. On Feb. 1, 2011, Sgt. Velez obtained a copy of video capturing the incident, from Orange County Public Schools employee Emerson Mann. Sgt. Velez sent the Citizen Complaint form, the photos and the CD to the Chief of Police. On 2-14-11, I viewed the video previously collected by Sgt. Velez, which was given to me by Lt. Ring. The video is dated 1-28-11 and at 2051 hours it shows the victim on the bench on the west side of the corridor of McCoy Elementary School. The victim gets up to walk and an officer, who resembles Officer Candelana wearing what appears to be a Orlando Police Department Gang Unit uniform, comes into view from the north. The officer grabs the victim by his right arm and escorts him to a corner near the front door of the solicol. Two other persons, who were seated on the east bench get up and leave the area? In the corner, the victim appears to be facing the officer. It is hard to see exactly what happens in this comer since it falls along the very edge of the area captured by the video camera. The officer appears to throw the victim to the ground, which causes the victim to land in a seated position facing the officer. The officer takes a position directly over the victim and uses his left hand to push the victim down completely to the ground so that he is lying on his back. The officer extends his right hand toward the victim's face. The victim appears to take a defensive posture by putting both of his hands up seemingly to protect his face. The officer appears to have his finger in the victim's face. The video is not entirely clear, but it appears that the officer's right hand moves in close to the victim's face. I could not see a strike to the mouth, as alleged by the victim, however this could be due to the quality of the video and the distance they are from the camera. The officer picks the victim up and takes him to another wall and faces him up against the wall. He appears to handouff the victim and search him. He removes items from the victims pocket and throws them to the ground. The officer appears to be talking on his police radio via his shoulder mike. The officer then un-handcuff's the victim and stens back from him. The victim picks up his property from the ground while the officer watches. The victim begins to head east and the officer extends his arm to direct him to go west, the victim goes to the west. I placed this original video into OPD evidence #EZQ468A, after requesting the Video Unit, CST Gariepy #4725, make two copies. I contacted victim Payne by phone on 2-14-11 and interviewed him at the Orlando Police, Department on 2-15-11 at 1000 hours. Payne advised in the interview the following: Payne was sitting down at McCoy Elementary. Payne wasn't feeling well, and was waiting for this girlfriend and her friend to come back from the store (Racetrae). Payne saw person come up to him grab him by his jacket, and lift him up. The person "forcibly" moved him to a wall and placed him up against the wall so his back was against it. Payne was in fear because he didn't immediately recognize the person; however, he eventually realized that it was Officer Candelaria, whom he knew from previous incidents. Payne said when he realized who it was, he became more scared. Candelaria asked him if he thought it was cool to run from police officers. He told Candelaria he had no idea what happened. Candelaria later told him that he was in a car with "Juan" and he said he was going to, "fuck Juan's life up". Candelaria threw him to the ground, so that he landed on his back. Candelaria became more upset and started yelling at him. Payne saw Candelaria's first rise up (described it as his arm cocked back and knew a hit was coming) and he was punched in the lip. Payne said, "What's wrong with you, you can't hit me." Candelaria said, 'It's airight, it was a bitch hit'. Payne took this statement to mean it was just a tap, not a big deal. Candelaria kept yelling at Payne as he picked Payne up off the ground. Candelaria threw Payne into another wall. Candelaria placed Payne in handouffs. which prompted Payne to ask why he was putting him in handcuffs. Candelaria told him he was going to see what he had and began searching him. Candelaria removed his belongings from his pockets and threw the items to the ground. Sometime during this search, Candelaria said something on his police radio to the effect of "show me out with one. .. " After Candelana was done, he un-handcuffed Payne and told him to go home. Payne attempted to head towards his girlfriend's house; however, Candelana pointed him to the direction of his home and told him if he saw him on the streets that night it would be worse. Payne walked to Burger King where he borrowed an employee's phone to call his mom to get a ride home. He said his lip was chapped and had bled a little bit from the strike to the mouth he received. He used paper towels in the Burger King bathroom to wipe his lip. Payne was scored during the encounter and offered no resistance in any way to Candelaria. Payne would like to prosecute. He completed and signed a sworm written statement. I read Payne the Photographic Lineup-up Admonition and showed him a photo lineup (tabeled #1) which included Candelaria's photograph (taken from the DHSMV) in position 6. Payne looked at the lineup, immediately picked out the person in position 6, and identified him as Officer Candelaria, the officer involved in the described incident. He completed and signed a Witness Photo Display Identification Room. Payne identified the two people who were sitting on the bench during the beginning of the incident as Malia Wilkerson (actual last name is Wilkinson) and Luz. Galarzar, He provided the name of his girlfriend as Emilie Rodriguez, 1 attempted to clarify whether he was sitting on a bench when the officer first grabbed him (as he indicated) or standing (as seen on the video). Payne believed he was sitting when first contacted by Candelaria, but said he could have already stood up. l ordered a copy of the photographs, taken by Sgt. Velez, and obtained a proof sheet. I did not see any obvious injury to the victim's lip area. I preferred a copy of the radio transmission where Candelaria checked himself out on this injectent. He states, "T104, I'm going to be out with a 13P, Commander and Turnbull." The radio transmission time was 8:36pm on 1-28-11. T104 was Candelaria's OPD unit # on 1-28-11. A "13P" is a police code for suspicious person, 1 researched incidents involving Candelaria and the victim and found Officer Candelaria stopped victim Payne on 12-11-10 and completed an OPD Field Interview Report (FIR) on him and his associates, FIR #10-557157. Officer Candelaria arrested the victim on 12-17-10 for a battery to a female victim, documented under OPD case # 10-555674.

He states in his narratives that at approximately 2016 hours on this date, he was on duty and driving his OPD unmarked pickup truck in the area of S. Semoran Blvd, and Turnbull Dr. He observed a vehicle traveling east on Turnbull Dr. from S. Semoran Blvd, He recognized the driver as Juan Rodriguez, whom he knew had a suspended driver license. He could see the front seat passenger was Alexander Valentin and back seat passenger was Walter Drake. He states these people are documented gang members. He states there were two other people that he could not identify. He attempted to do a traffic stop; however, the driver fled and could not be located. Candelaria's report does not indicate Bryan Payne was in the car. A short time after this incident is when Candelaria encountered the victim at McCoy Elementary. It should be noted that McCoy Elementary sits near the intersection of S. Semoran Blvd. and Turnbull Dr., which is where the vehicle eluded Candelaria. Candelaria previously conducted the battery investigation of OPD case # 11-44505. As a result of his investigation, he arrested Bryan Payne, Juan Rodriguez, Emilie Rodriguez and other associates. In his investigative supplement, Candelaria documented these people to be members of the F.F.L. or Families for Life Gang. On the same date, 1-28-11 at 2054 hours, 38 minutes after the fleeing and eluding incident, Candelaria checks out with a suspicious person at Commander Dr. and Turnbull Dr., under OPD incident # 11-44468. This time is consistent with the time on the video from McCoy Elementary where it appears he talks on his police radio (video time was 2053 hours). McCoy Elementary sits at the intersection of Commander Dr. and Tumbull Dr. He cleared this call as a service call only, no report, no arrest or Field Interview Report or any other documentation were submitted. I interviewed Emilie Rodriguez on 2-16-11 at 1430 hours at her home. She advised that she was hanging out with Bryan Payne, Lucy (Luz Galarza), Malia (Malia Wilkinson) and Nadia (NOI). She left Bryan, Luz and Malia at McCoy Elementary while she and Nadia went to the Racetrac gas station at the corner so she could use the restroom. After she used the restroom inside the business and exited the store, Candelaria had his gun out pointing it at her and told her to sit "the fuck" down. She said, "What did I do?" Candelaria told her "this isn't for you", that he had a message for her brother (who is Juan Rodriguez, the person who eluded him earlier). Candelaria said, "Tell him I'm going to mess his life up and that he thinks it's funny to flee from a cop well it's not and I'm here to tell him it's not and if he thinks he did time the first time then wait until I catch him, he will be doing way more." He then sent her home. As she headed towards home and in the direction of the school, Officer Candelaria followed her on foot on the sidewalk. When she got to the front of the school, she observed Officer Candelaria run across the street, pick Bryan up by his shirt and take him to the entrance of the building and slam him against the wall. He picked him up again and slammed him on the ground and got on him, then picked him up again and threw him on the bench to sit down. She was scared, didn't know what to do and thought he had hurt Bryan bad. After it was over, Candelaria saw her again and told her to go home. She did not see Candelaria punch Bryan, but also stated she could not tell if he had hit him. There were pillars which may have blocked her view as she stood across the street. This may explain why she thought Candelaria sat Bryan on a bench rather than put him up against the wall/pillar prior to searching him as seen in the video. The bench is next to the pillar. I questioned her if she felt threatened when he pointed his gun at her, and she stated she did not think he would shoot her, she just did what he told her to do because he was a police officer and he had arrested her before and she did not want to get in more trouble. Emilie provided the name of her friend Nadia that she went to Racetrac with and her phone number (Emilie). Nadia told her the officer followed her (Emilie) into the Racetrac, waited for her to leave the restroom and then followed her out of the Racetrac. Emilie said she never saw the officer in the store. She said Nadia saw the encounter where he told her to sit down. I read Émilie the Photographic Line-up Admonition and showed her photographic lineup #2, where Candelaria was in position #5. She identified the person in position #5 as the officer involved in the described incident. She completed and signed a Witness Photo Display Identification Form along with a sworn written statement. On 2-16-11 at 1525 hours, I interviewed Luz Galarza at her home. She stated she was sitting down with her friend on a bench at the school when Bryan was "getting pushed around by a cop." The officer was saying, "'You're the one that try to run away from me with your friends." He said to her and her friend, "You two got something to do withthis?" They said "no" and left the area. Galarza could not identify the officer from a photo lineup. On 2-16-11 at 1550 hours, I interviewed Malia Wilkinson at her home. She advised she was sitting down with her friend Lucy at the school. Her head was hurting so she had closed her eyes. She heard footsteps, opened her eyes and saw a male police officer that ran toward Bryan Payne and picked him up and threw him against the wall and then the floor and back and forth. When he finished, he came toward them and said if you are not involved with him, go ahead and walk away, so they left.
