

 - a. I was board certified in Criminal Trial Law for the period of August 1, 2019, through July 31, 2024, and currently practice as the Chief Legal Counsel for Sheriff Wayne Ivey and the Brevard County Sheriff's Office. As Chief Legal Counsel, my role is that of a general counselor and I manage the day-to-day legal operations and issues that confront the Brevard County Sheriff's Office and its approximately 1,700 employees tasked with providing law enforcement services to Brevard County. The Legal Services Unit, which I supervise, litigates matters such as Civil Asset Forfeitures, Risk Protection Orders, Small Claims matters, Public Records Disputes, Constitutional challenges, Discovery matters, and acts as a liaison with retained outside counsel regarding areas such as Professional Liability, Auto Liability, Workers Compensation, Employment Law, and Civil Process. I negotiate, review, draft, and approve contracts, memoranda of understanding, interlocal agreements, and agency policies and procedures. When requested, I review agency internal affairs cases to render opinions as to whether agency employees have committed policy, statutory law, or constitutional violations. I review search and arrest warrants and affidavits for sufficiency of evidence and draft documents required by agency staff. I conduct a variety of training and prepare legal bulletins to ensure adherence to legislative changes and constitutional policing practices by deputies and agency employees. As the Chief Legal Counsel for the Brevard County Sheriff's Office, there is no "typical" client or problem, as we function in criminal justice; we operate the Brevard County Jail Complex; we run Animal Services for the County; act as the Court's Judicial Process unit; and are a large employer of Brevard County citizens.
 - b. My current position is significantly different and more diverse in practice areas that touch on every topic from sufficiency of evidence for criminal arrests to employment law to model jail standards to professional liability, than the twelve (12) years I spent as an **Assistant State Attorney**. During those twelve years, I was assigned to nearly every division within the Office of the State Attorney and prosecuted misdemeanor crimes, repeat domestic violence offenders, felony crimes, elder & economic crimes, and became a supervisor of a four-attorney and four-support staff division as a **Felony Trial Division Chief** from 2016-2019. As a Felony Division Chief, I was tasked with prosecution of homicides, complex economic and drug trafficking cases, training of new felony attorneys, and day-to-day oversight of the division. With that variety of exposure, including in leadership within the Office of the State Attorney, I still was primarily focused on the prosecution of criminal cases whereas my current role at the Sheriff's Office is much more intertwined with the administration of the Sheriff's Office in addition to all legal matters.

From 2007-2019, I exclusively practiced Criminal Trial law as an Assistant State Attorney appointed as a Felony Trial Division Chief, Elder & Economic Crimes Division Chief, Domestic Violence "Strikeback" Attorney, and Misdemeanor Attorney. In July 2019, upon becoming the Chief Legal Counsel for the Brevard County Sheriff's Office, my practice shifted to nearly exclusively the practice of Civil law - handling Civil Asset Forfeitures, Risk Protection Orders, Public Records, Small Claims, and Professional Liability matters amongst other varied issues as the Sheriff's Office general counsel. However, between 2019 and present, I have maintained a presence in the criminal trial courts, as State Attorney Phil Archer has designated me as an Assistant State Attorney on a complex case I previously tried to verdict and on a complex RICO/Drug Trafficking prosecution involving multiple defendants and hundreds of counts as noted in 1.c. above. I also appear in criminal matters periodically as a non-party and on behalf of Sheriff Ivey and the Sheriff's Office to address Motions to Compel Discovery, Motions to Quash, and other criminal case-adjacent matters.

That is significantly different than during my employment as an Assistant State Attorney from August 2007-July 2019. I represented the *State of Florida* in this prosecution of a defendant accused of murdering a nineteen-year-old in Melbourne, Florida on or about August 26, 2003. At the time of our prosecution, the defendant had been convicted of murdering two elderly individuals in Tennessee on August 22, 2003, and is the only viable, but unindicted, suspect in a 2002 murder in Ft. Lauderdale. The defendant was linked to the Melbourne murder after using the Tennessee victim's credit card in Brevard County, and the prosecution of this case required significant coordination to secure evidence from multiple jurisdictions including Tennessee and Ft. Lauderdale.

The affirmation of the verdict and death sentence in this case was significant because while it was tried in 2013, before the revisions to death penalty procedure in Florida, the Florida Supreme Court issued the opinion in the instant case in 2017, after the *Hurst v. Florida* remand from the United States Supreme Court and its decision in *Hurst v. State*, 202 So. 3d 40 (Fla. 2016) requiring that a jury unanimously and expressly find all the aggravating factors be proven beyond a reasonable doubt. In this case, the Supreme Court found the *Hurst* error harmless

having been "convinced beyond a reasonable doubt that no rational jury would have failed to unanimously find that all three aggravating circumstances were proven beyond a reasonable doubt." *Jones*, 212 So. 3d. at 344. Equally significant and important for practitioners is the Supreme Court's thorough discussion of the admissibility of collateral crime evidence to prove identity. The analysis provided, comparisons noted between the murders, and faithful adherence to the rules of evidence and precedent on this topic produced an excellent primer on the appropriate introduction of such evidence. My co-counsel and I diligently focused on the limited and precise introduction of just the amount of information necessary to prove identity in strict adherence to precedent in this area of law and knew that in seeking a death sentence, our evidence would receive the strictest scrutiny, and the Supreme Court's recognition of the precision for that very limited purpose was very rewarding.

Lastly, this case was significant because Brevard County State Attorney Norm Wolfinger could have elected not to extradite the Defendant for prosecution as he was already convicted and on death row in Tennessee. But he believed the family deserved justice and knew convictions are subject to reversal, so he pursued the prosecution in Brevard County as well.

I represented the State of Florida in this heavily contested matter involving the defeated Clerk of Court and his conspiracy to commit bribery and bid tampering with a Michigan-based company that had agreed to funnel "kick-back" payments from several awarded contracts for the Defendant to fund his campaign against the prevailing Clerk of Court in the 2012 election.

This case was significant in my career for several reasons: 1) The investigating entity was the Florida Department of Law Enforcement's Office of Executive Investigations. Mark Mitchell and Dan Augustiniak were the case agents and I have had the pleasure of watching both agents advance in their careers with FDLE during the eleven years this case has remained active, with Mark Mitchell now the Chief of Investigations for the very unit that investigated this case. 2) At the time this case went to trial, it presented the most complicated legal issues I had yet experienced regarding elected officials, county officers' contracting powers, bid tampering, bribery, campaign financing, lobbyists, and the evidence was voluminous and pre-trial litigation, extensive.

To avoid the appearance of impropriety, all Brevard County judges recused themselves and the trial occurred in Seminole County requiring extensive coordination of all out-of-county and out-of-state witnesses. 3) The case was incredibly educational to me as it necessarily required me to learn the political landscape of Brevard County and many of the administrative and technological policies, rules, and practices of our Clerk of Court. The relationships I built throughout that case, including with the current Clerk of Court, Rachel Sadoff, have been the foundation of many discussions, ideas, and projects I have worked on since then.

I represented the State of Florida in this matter which is a co-defendant case tried separately from Mitch Needelman as described above. This defendant and her out-of-state company were the beneficiaries of millions of taxpayer and corporately-loaned dollars for a project for which she and her company were not qualified but had agreed to return Clerk funds through an intermediary to the Needelman campaign. This case was educational regarding economic development and proper vetting of qualified businesses that serve to enhance the quality of life and services for Floridians rather than those looking to exploit financial arrangements.

This case was significant for all the reasons stated above, but additionally because the opposing counsel for this case was a well-known adversary with excellent demonstrative aids, staffing, and resources that the State of Florida did not have. Ultimately, the State prevailed as to the Principal to Commit Bid Tampering and Conspiracy to Commit Bribery counts and succeeded in our efforts to have \$1,241,902.00 in restitution awarded to the Brevard Clerk of Courts Office for all of the taxpayer losses.

I represented the State of Florida in this matter. This case was significant as it was the first murder trial I participated in as co-counsel and resulted in the conviction and life sentence for a defendant accused of beating and kicking to death his partner just two months after committing a Battery Domestic Violence in which the same victim had dropped charges. Having previously served as a Victim Advocate and the Domestic Violence "Strikeback" Attorney, this was a case in which the Court saw fit to sentence the defendant to the maximum penalty allowed by law. This case was significant as I learned several excellent techniques for direct and cross examination in a case in which the defendant claimed he acted in self-defense. Understanding "Stand Your Ground" laws and the prosecution of cases in which self-defense is raised is crucial for prosecutors as it is commonly presented when defendants are charged with violent crimes.

I did so, was offered the job by Statewide Prosecutor Nick Cox, and to prevent my departure from the Office of the State Attorney, the late State Attorney Norm Wolfinger gave me the opportunity to start the Elder & Economic Crimes Unit.

The establishment of the Elder & Economic Crimes Unit is truly the platform that allowed me to learn from and to form connections with people such as Senator Passidomo, elder law and elder service practitioners throughout the state, Rotarians, guardians, and so many others serving Florida's aging population. Perhaps most significantly, it was through my work with the Economic Crimes Task Force that I established a professional relationship with Sheriff Wayne Ivey leading to his recruitment of me as his Chief Legal Counsel when he established a Legal Services Unit within the Brevard County Sheriff's Office.

SUPPLEMENTAL INFORMATION

As the daughter of a retired Air Force Colonel, I grew up on military bases with my role models being those who dedicated themselves as public servants to and warriors for the United States of America. That loyalty and dedication transmitted to me a desire to follow in my father's footsteps and serve the people. My desire to serve the public has manifested itself in the form of being a Child Protective Investigator investigating allegations of child abuse, neglect, and abandonment. It then led to working with juvenile offenders to help them gain employability skills and jobs to pay back restitution to crime victims; then to working as a victim advocate; assistant state attorney and now as the Chief Legal Counsel for Sheriff Wayne Ivey and the Brevard County Sheriff's Office. During my time at the Office of the State Attorney I had the opportunity to volunteer as a Teen Court Judge "presiding" over actual juvenile criminal cases in which offenders had admitted guilt but participate in sentencing proceedings before a jury of their peers. These proceedings gave me a first glance at ruling on objections, procedural issues, and doing the work that is required of our judges. I also started the Elder & Economic Crimes Unit and the Sheriff's Office Legal Services Unit as initially units of one with no predecessor or trainer and have a distinct ability to function independently and solitarily, which is important for the judiciary.

The Comments to *The Rules Regulating the Florida Bar*, Rule 4-3.8 provide: "A prosecutor has the responsibility of a minister of justice and not simply that of an advocate." For the first twelve years of my practice of law, I dedicated myself to seeking justice and not simply convictions in criminal cases. While at times this meant zealously advocating for the people and victims of Florida, it also meant dropping or dismissing cases in which insufficient evidence existed to prove a crime was committed or that the accused was the person who committed the crime. That constant evaluation of cases including credibility of witnesses, sufficiency of evidence, management of heavy caseloads, mastery of the rules of evidence and procedure, and constant research of appellate opinions are crucial for those who take judicial office. While I functioned as a prosecutor aiming always to protect the integrity of the criminal justice system and rights of both victims and the accused, that behavior closely resembles the requirement of judges to preserve the image, confidence and respect for the role of the courts in society.

Lastly, as Chief Legal Counsel for the Brevard County Sheriff's Office, I have rendered opinions and guidance on constitutional and administrative matters covering a broad range of topics, both civil

and criminal, for the last five years. To effectively act as a police legal advisor, I research and interpret the law as a textualist when advising the Sheriff and his deputies about the constitutionality, permissibility, or prohibition on actions to be taken in fulfilling the role and duties of Sheriff. I have provided input and suggested draft language for 18th Judicial Circuit Court Administrative Orders. Representing a member of the Executive Branch has instilled in me a belief in judicial restraint while respect for the rule of law. The diversity of topics the Sheriff's Office faces daily has broadened my knowledge and has solidified a deep respect for the balance and separation of power between all branches of our government and has given me a well-founded respect for the limited, but essential, role our courts play in settling the unsettled without overstepping their constitutional powers and duties.

72. Explain the particular contribution you believe your selection would bring to this position and provide any additional information you feel would be helpful to the Commission and Governor in evaluating your application.

Senator Jon Kyl noted during Justice Samuel Alito's confirmation hearing what the nation at the time had come to expect of a Supreme Court Justice. Those attributes were: "First rate intellect, demonstrated academic excellence, life of engagement with serious constitutional analysis, and reputation for fair mindedness and modesty." If nominated by the Commission and appointed by Governor DeSantis, I would be diligent in my efforts to demonstrate those qualities each day. I firmly believe that our American and Floridian court system must be grounded in a confidence that the person empowered and entrusted to rule on disputes between adversaries will do so intelligently, learnedly, free from bias or prejudice, and humbly. My goal in obtaining this appointment is to lend credibility, prestige, and the highest view of integrity to the office of the judiciary rather than to seek esteem from the office of judge.

I decided to attend law school and to become a prosecutor while working as a victim advocate and sitting each day in the courtroom gallery watching questioning and arguments made by the lawyers on each side. From that view, it was the *work* of a lawyer that drove me; not the title of "being a lawyer." During the seventeen years I have been privileged to do this work, learning nearly every area of law and appearing before numerous judges, fourteen years of which has been spent in Circuit Court, I have felt the same draw to do the *work* of judging the merits of cases, arguments, and matters – rather than seeking to "be a judge" or obtaining a title.

Pursuant to Fla. Stat. § 26.012, Circuit Courts have exclusive original jurisdiction of proceedings including, but not limited to: probate, guardianship, involuntary hospitalizations, determining incompetency, juveniles, felonies, ejectments, injunctions, emergency hospitalizations pursuant to Ch. 394, and in all actions at law not cognizable by the county courts. During my seventeen years of legal practice, I have worked or had exposure to matters involving each of these case types. To complement twelve years of criminal trial experience that followed nearly five years of victim advocacy and juvenile diversion case management, I intentionally spent the last five years learning civil procedure, civil causes of action and defenses, summary judgment and motion

practice, and diversifying my legal knowledge and practice areas in preparation to apply for an appointment to or election to the bench. As in-house counsel to an Executive Branch member, I have had the opportunity to act as the agency representative rather than the attorney of record in complex Federal proceedings and significant state law actions. Participating in cases with the view of a party sitting as a defendant one day, and the plaintiff the next, I appreciate the expectation that the Judiciary will hear all litigants and promptly address their grievances.

Importantly, if nominated by this Commission and appointed by Governor DeSantis, my faithful adherence to the Constitution and law will not bend to serve the interests of what may be deemed popular in a fleeting moment. My experience and knowledge have prepared me to be assigned *any case*, in *any division*, while instilling confidence in our litigants and community that while there may only be one prevailing party in a matter, their arguments will be heard and considered with sincere humility, deliberation, fairness, and impartiality.

- Jointly held assets: If you hold real or personal property jointly with another person, your interest equals your legal percentage of ownership in the property. <u>However</u>, assets that are held as tenants by the entirety or jointly with right of survivorship must be reported at 100% of their value.
- Partnerships: You are deemed to own an interest in a partnership which corresponds to your interest in the equity of that partnership.
- Trusts: You are deemed to own an interest in a trust which corresponds to your percentage interest in the trust corpus.
- Real property may be valued at its market value for tax purposes, unless a more accurate appraisal of its fair market value is available.
- Marketable securities which are widely traded and whose prices are generally available should be valued based upon the closing price on the valuation date.
- Accounts, notes, and loans receivable: Value at fair market value, which generally is the amount you reasonably expect to collect.
- Closely-held businesses: Use any method of valuation which in your judgment most closely approximates fair market value, such as book value, reproduction value, liquidation value, capitalized earnings value, capitalized cash flow value, or value established by "buy-out" agreements. It is suggested that the method of valuation chosen be indicated in a footnote on the form.
- Life insurance: Use cash surrender value less loans against the policy, plus accumulated dividends.

PART C—LIABILITIES

LIABILITIES IN EXCESS OF \$1,000:

List the name and address of each creditor to whom you were indebted on the reporting date chosen for your net worth (Part A) in an amount that exceeded \$1,000 and list the amount of the liability. Liabilities include: accounts payable; notes payable; interest payable; debts or obligations to governmental entities other than taxes (except when the taxes have been reduced to a judgment); and judgments against you. You are not required to disclose liabilities owned *solely* by your spouse.

You do not have to list on the form any of the following: credit card and retail installment accounts, taxes owed unless the taxes have been reduced to a judgment), indebtedness on a life insurance policy owned to the company of issuance, or contingent liabilities. A "contingent liability" is one that will become an actual liability only when one or more future events occur or fail to occur, such as where you are liable only as a partner (without personal liability) for partnership debts, or where you are liable only as a guarantor, surety, or endorser on a promissory note. If you are a "co-maker" on a note and have signed as being jointly liable or jointly and severally liable, then this is not a contingent liability.

How to Determine the Amount of a Liability:

- Generally, the amount of the liability is the face amount of the debt.
- If you are the only person obligated to satisfy a liability, 100% of the liability should be listed.
- If you are jointly and severally liable with another person or entity, which often is the case where more than one person is liable on a promissory note, you should report here only the portion of the liability that corresponds to your percentage of liability. *However*, if you are jointly and severally liable for a debt relating to property you own with one or more others as tenants by the entirely or jointly, with right of survivorship,

report 100% of the total amount owed.

— If you are only jointly (not jointly and severally) liable with another person or entity, your share of the liability should be determined in the same way as you determined your share of jointly held assets.

Examples:

- You owe \$10,000 to a bank for student loans, \$5,000 for credit card debts, and \$60,000 with your spouse to a saving and loan for the mortgage on the home you own with your spouse. You must report the name and address of the bank (\$10,000 being the amount of that liability) and the name and address of the savings and loan (\$60,000 being the amount of this liability). The credit cards debts need not be reported.
- You and your 50% business partner have a \$100,000 business loan from a bank and you both are jointly and severally liable. Report the name and address of the bank and \$50,000 as the amount of the liability. If your liability for the loan is only as a partner, without personal liability, then the loan would be a contingent liability.

JOINT AND SEVERAL LIABILITIES NOT REPORTED ABOVE:

List in this part of the form the amount of each debt, for which you were jointly and severally liable, that is not reported in the "Liabilities in Excess of \$1,000" part of the form. Example: You and your 50% business partner have a \$100,000 business loan from a bank and you both are jointly and severally liable. Report the name and address of the bank and \$50,000 as the amount of the liability, as you reported the other 50% of the debt earlier.

PART D - INCOME

As noted on the form, you have the option of either filing a copy of your latest federal income tax return, including all schedules, W2's and attachments, with Form 6, or completing Part D of the form. If you do not attach your tax return, you must complete Part D.

PRIMARY SOURCES OF INCOME:

List the name of each source of income that provided you with more than \$1,000 of income during the year, the address of that source, and the amount of income received from that source. The income of your spouse need not be disclosed; however, if there is a joint income to you and your spouse from property you own jointly (such as interest or dividends from a bank account or stocks), you should include all of that income.

"Income" means the same as "gross income" for federal income tax purposes, even if the income is not actually taxable, such as interest on tax-free bonds. Examples of income include: compensation for services, gross income from business, gains from property dealings, interest, rents, dividends, pensions, IRA distributions, distributive share of partnership gross income, and alimony, but not child support. Where income is derived from a business activity you should report that income to <u>you</u>, as calculated for income tax purposes, rather than the income to the business.

Examples:

- If you owned stock in and were employed by a corporation and received more than \$1,000 of income (salary, commissions, dividends, etc.) from the company, you should list the name of the company, its address, and the total amount of income received from it.
- If you were a partner in a law firm and your distributive share of partnership gross income exceeded \$1,000, you should list the name of the firm, its address, and the amount of your distributive share.
- If you received dividend or interest income from investments in stocks and bonds, list only each individual company from which you received more than \$1,000. Do not aggregate income from all of these investments.
- If more than \$1,000 of income was gained from the sale of property, then you should list as a source of income the name of the purchaser, the purchaser's address, and the amount of gain from the sale. If the purchaser's

identity is unknown, such as where securities listed on an exchange are sold through a brokerage firm, the source of income should be listed simply as "sale of (name of company) stock," for example.

— If more than \$1,000 of your income was in the form of interest from one particular financial institution (aggregating interest from all CD's, accounts, etc., at that institution), list the name of the institution, its address, and the amount of income from that institution.

SECONDARY SOURCE OF INCOME:

This part is intended to require the disclosure of major customers, clients, and other sources of income to businesses in which you own an interest. It is not for reporting income from second jobs. That kind of income should be reported as a "Primary Source of Income." You will **not** have anything to report **unless**:

- (1) You owned (either directly or indirectly in the form of an equitable or beneficial interest) during the disclosure period, more than 5% of the total assets or capital stock of a business entity (a corporation, partnership, limited partnership, LLC, proprietorship, joint venture, trust, firm, etc., doing business in Florida); and
- (2) You received more than \$1,000 in gross income from that business entity during the period.

If your ownership and gross income exceeded the two thresholds listed above, then for that business entity you must list every source of income to the business entity which exceeded 10% of the business entity's gross income (computed on the basis of the business entity's more recently completed fiscal year), the source's address, the source's principal business activity, and the name of the business entity in which you owned an interest. You do not have to list the amount of income the business derived from that major source of income.

Examples:

- You are the sole proprietor of a dry cleaning business, from which you received more than \$1,000 in gross income last year. If only one customer, a uniform rental company, provided more than 10% of your dry cleaning business, you must list the name of your business, the name of the uniform rental company, its address, and its principal business activity (uniform rentals).
- You are a 20% partner in a partnership that owns a shopping mall and your gross partnership income exceeded \$1,000. You should list the name of the partnership, the name of each tenant of the mall that provided more than 10% of the partnership's gross income, the tenant's address and principal business activity.

PART E – INTERESTS IN SPECIFIED BUSINESS

The types of businesses covered in this section include: state and federally chartered banks; state and federal savings and loan associations; cemetery companies; insurance companies; mortgage companies, credit unions; small loan companies; alcoholic beverage licensees; pari-mutuel wagering companies; utility companies; and entities controlled by the Public Service Commission; and entities granted a franchise to operate by either a city or a county government.

You are required to make this disclosure if you own or owned (either directly or indirectly in the form of an equitable or beneficial interest) at any time during the disclosure period, more than 5% of the total assets or capital stock of one of the types of business entities listed above. You also must complete this part of the form for each of these types of business for which you are, or were at any time during the year an officer, director, partner, proprietor, or agent (other than a resident agent solely for service of process).

If you have or held such a position or ownership interest in one of these types of businesses, list: the name of the business, its address and principal business activity, and the position held with the business (if any). Also, if you own(ed) more than a 5% interest in the business, as described above, you must indicate that fact and describe the nature of your interest.

JUDICIAL APPLICATION DATA RECORD

The judicial application shall include a separate page asking applicants to identify their race, ethnicity and gender. Completion of this page shall be optional, and the page shall include an explanation that the information is requested for data collection purposes in order to assess and promote diversity in the judiciary. The chair of the Commission shall forward all such completed pages, along with the names of the nominees to the JNC Coordinator in the Governor's Office (pursuant to JNC Uniform Rule of Procedure).
